Dear Mr. Lawley,

Thank you for your email and your offer to meet us.

Unfortunately I am leaving for Sct Petersburg tomorrow morning and wont be back before Monday.

I would however like to clarify the Danish position. The remarks I have made have solely addressed the fact that ICANN board has not followed the procedures that it - according to the bylaws - must follow when taking decisions. The rules that were negotiated at the Shanghai meeting, serves two purposes. They reiterate that issues with public policy implications are formally presented to the GAC, and they ensure that the GAC is involved at the relevant time in the decisionmaking processes.

In other words my remarks could have concerned any other TLD with possible public policy implications, and DK has not taken any position on triple x as such.

We understand that you have been one of the more vocal critics of ICANN's decision to enter into contractual negotiations with us for the introduction of the .xxx sTLD.

As the .xxx Registry Operator, Stuart Duncan our Chief Operating Officer and I are currently in Europe and would like to extend an offer to meet with you in Copenhagen this coming Wednesday 26th Thursday 27th or Friday 28th to discuss our application and the process it went through and answer any questions you may have.
