

 - Request 11-1 (Request for Transfer of zetamusic.com)



Number of Requests Acted Upon

REQUEST 10-2

•On 9 December 2010, the BGC recommended that the Board deny the request to reconsider the approval of amendments to the .JOBS registry agreement. The BGC also recommended close monitoring of compliance with the .JOBS charter. The Board approved the BGC recommendation on 10 December 2010

Number of Requests Acted Upon

REQUEST 10-3

 On 4 December 2010, the BGC recommended that the Board deny the request to reconsider the inclusion of resolution text relating to the HSTLD program. The Board approved the BGC recommendation on <u>10 December 2010</u>



Number of Requests Acted Upon REQUEST 11-1

•On 15 August 2011, the BGC recommended that the Board deny the request to reconsider staff's failure to transfer the requested domain name, as the Reconsideration process is not the proper forum for domain name disputes. The Board approved the BGC recommendation on 25 August 2011.

Number of Requests Pending

- As of 13 October 2011, no Reconsideration Requests are pending.
- No Reconsideration Requests were pending at the end of the 2010 calendar year.

 The BGC reviewed and acted on all Reconsideration Requests submitted in 2011



Other Accountability Mechanisms Available to Denied Requesters

- ICANN makes available the Ombudsman and the Independent Review Process as additional mechanisms to enhance ICANN accountability to persons materially affected by its decisions
- During 2012, the BGC will be leading a review of ICANN's accountability mechanisms

Use of Other Available ICANN Accountability Mechanisms

Independent Review - In accordance with Article IV, section 3 of ICANN's Bylaws, ICANN has designated the International Centre for Dispute Resolution as the body to process requests for independent review of Board actions alleged by an affected party to be inconsistent with **ICANN's Articles of Incorporation** or Bylaws.

Other Available ICANN Accountability Mechanisms

Independent Review, continued



- On 19 February 2010, ICANN
 received the Panel Declaration in
 the only Request for Independent
 Review, submitted by ICM Registry,
 Inc. in 2008.
- After a <u>25 June 2010</u> determination to accept and act in accordance with certain findings of the Panel, on <u>18 March</u> <u>2011</u> the Board approved entering a .XXX Registry Agreement with ICM.
