Re: IGO Request to Register Its Reserved Domain

Dear Chris, Akram and Cyrus:

Attached please find a request from the Deputy Director of International Operations at Euclid University, a United Nations-chartered international intergovernmental organization (IGO), which provides distance education and consulting services to officials in participating states¹, as well as to the general public. As you can see, Euclid University is seeking to register the domain name Euclid.university; however, ICANN prohibits us from registering Euclid.university to any party, including Euclid University, the very IGO the prohibition intends to protect.

This isn't an isolated case. As you know, we and others have pointed out in other fora that this prohibition irrationally harms Euclid University and every other IGO. By way of further example, under current registry agreements, the International Olympic Committee would be prohibited from registering Olympics.hockey and the Red Cross from registering Redcross.care.

To address these types of absurd situations, we filed a Registry Service Evaluation Process (RSEP) in 2015. Our non-controversial ask in that RSEP was for a specific IGO to be permitted to consent to the registration of its own reserved name. We didn't seek the release of *all* IGO full names and acronyms or address what protections an IGO would have when any such names are released to third parties—issues the community has been grappling with for years. Unfortunately, while our RSEP was approved, it has languished in perpetuity waiting for a contract amendment, which we were told would not be forthcoming.

We are aware of both the anticipated 2018 implementation of agreed-to policy with respect to IGO reserved names and the community's ongoing deliberations of various IGO-related issues and understand that sometime in 2018 IGOs should be able to register their own names. We note that this "right" comes over four years since we signed our first registry agreements.

In the meantime, however, this 2018 implementation process should not preclude the reasonable accommodation of this particular IGO's request. Therefore, we request that ICANN, as party to our .UNIVERSITY Registry Agreement, agree to waive the reservation of Euclid university to address the more immediate harm to Euclid University. California law provides that parties to a contract may agree to waive enforcement of a certain

provision and, moreover, waivers are specifically contemplated in Section 7.6(i) of the .UNIVERSITY Registry Agreement ("No waiver of any provision of this Agreement shall be binding unless evidenced by a writing signed by the party waiving compliance with such provision."). A simple waiver from ICANN in this case would at least solve the harm the prohibition is causing the IGO and be a reasonable approach considering our pending RSEP, the implementation of the policy permitting such registration, and common sense.

We would very much appreciate a waiver in this case. Please contact me at your earliest convenience to effectuate such a waiver.
