#### 3. Description of specific action you are seeking to have reconsidered.

Requesters seek the reconsideration of ICANN's Community Priority Evaluation Panel's determination whereby Application ID 1-1083-39123 for the .RADIO gTLD (hereinafter: the "Application") submitted by the European Broadcasting Union (hereinafter: the "EBU") prevailed in Community Priority Evaluation. This determination was posted on ICANN's website under URL <u>https://www.icann.org/sites/default/files/tlds/radio/radio-cpe-1-1083-39123-en.pdf</u> (hereinafter: the "Determination"). As a result of this Determination, ICANN has:

- resolved the contention set for the .RADIO gTLD;
- changing the status of the Application to "In Contracting". Reference is made to the Application's status page, available at <u>https://gtldresult.icann.org/application-</u> result/applicationstatus/applicationdetails/1468;
- changing the status of Requesters' respective applications for the .RADIO gTLD to "Will Not Proceed", as referred to their respective status pages available at <a href="https://gtldresult.icann.org/application-result/applicationstatus/applicationdetails/1848">https://gtldresult.icann.org/application-result/applicationstatus/applicationdetails/1848</a>; <a href="https://gtldresult.icann.org/application-result/applicationstatus/applicationdetails/1508">https://gtldresult.icann.org/application-result/applicationstatus/application-result/applicationstatus/application-result/applicationstatus/application-result/applicationstatus/application-result/application-re

# 6. Describe how you believe you are materially affected by the action or inaction:

Considering the fact that the Determination states that the EBU's Application prevailed in the context of Community Priority Evaluation, the Requesters' respective applications for the .RADIO gTLD will be no longer considered by ICANN, which will likely result in ICANN not awarding the .RADIO gTLD to any of the Requesters.

# 7. Describe how others may be adversely affected by the action or inaction, if you believe that this is a concern.

Requesters are of the opinion that, considering the fact that the community described in and targeted by the Application is too narrow and vague, third parties who have an affinity with the radio industry in general, including manufacturers of radio transmitters and receivers, telephony, video, radars, navigation and heating equipment, and many others directly or indirectly affiliated

with radio will be ineligible to register domain names in the .RADIO gTLD.

### 8. Detail of Board or Staff Action – Required Information

#### Provide the Required Detailed Explanation here:

In the context of ICANN's New gTLD Program, ICANN has received the following applications for the .RADIO gTLD:

- the EBU's application for a community-based gTLD (Application ID 1-1083-39123);
- Afilias Ltd.'s "standard" application (Application ID 1-868-75631);
- BRS Media, Inc.'s "standard" application (Application ID 1-994-75477);
- Tin Dale's "standard" application (Application ID 1-1593-8224).

On September 10, 2014, ICANN's Community Priority Evaluation panel published its Determination stating that the EBU's Application for the .RADIO gTLD obtained a passing score of 14 out of 16 points, and hence prevailed in Community Priority Evaluation.

Since Requesters are of the opinion that the publication of these Community Priority Evaluation results are considered to be an action by ICANN staff, they are entitled to invoke and utilize ICANN's Reconsideration Request process in relation to this Determination / action by ICANN staff.

The immediate effect of this Determination seems to be that each of the Requesters' applications for the .RADIO gTLD will no longer be considered by ICANN, given the fact that the status of each of their applications has been changed to "Will Not Proceed", as is reflected on their respective Application Status pages published by ICANN. Reference is made to:

- Tin Dale LLC's application for the .RADIO gTLD: <u>https://gtldresult.icann.org/application-</u> result/applicationstatus/applicationdetails/624.

Requesters furthermore refer to their request submitted under ICANN's Documentary Information Disclosure Policy, attached hereto as Annex 1 and incorporated herein by reference.

According to the Determination:

- the Application met the Delineation requirement set out in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook;
- the Application met the Nexus and Uniqueness requirements set out in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook;
- the Application met the Registration Policies requirement set out in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook;
- the Application met the Opposition requirement set out in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook.

For the reasons set out below and any additional arguments to be developed by Requesters as a follow-up to this Reconsideration Request, Requesters are of the opinion that the Community Priority Evaluation Panel incorrectly applied the standards set out in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, and should not have awarded passing scores in the context of the Determination.

Requesters therefore request ICANN in accordance with its Reconsideration Request process to:

- reconsider the Determination, and in particular not award a passing score in view of the Community Priority Evaluation criteria set out in the Applicant Guidebook for the reasons expressed in this Reconsideration Request and any reasons, arguments and information to be supplemented to this Request or forming part of a new Reconsideration Request in the future;
- reconsider the respective decisions by ICANN that each of the Requesters' applications for the .RADIO gTLD "Will Not Proceed" to contracting;
- restore the "Application Status" of the Requesters' applications and the Application submitted by the EBU to "Evaluation Complete", their respective "Contention Resolution Statuses" to "Active", and their "Contention Resolution Result" to "In Contention".

### 9. What are you asking ICANN to do now?

Based upon the information contained in the Application, Requests are convinced that the Application does not meet the criteria to qualify as a community-based gTLD set out in ICANN's Applicant Guidebook.

In view of obtaining further insights into the arguments of the Community Priority Evaluation panel and the information on which such panel has relied, Requesters have submitted together with this Reconsideration Request and request to obtain further information under ICANN's Documentary Information Disclosure Policy.

Based upon the information and arguments included in this Reconsideration Request, for which the Requesters reserve the right to submit additional arguments and information following the outcome of their request submitted to ICANN in accordance with the Documentary Information Disclosure Policy, Requesters request ICANN to:

- acknowledge receipt of this Reconsideration Request;
- suspend the process for considering this Reconsideration Request in view of possible supplementary arguments and information to be provided by Requesters following receipt of ICANN's responses to Requesters' Request under ICANN's Documentary Information Disclosure Policy, attached hereto as Annex 1;
- in the meantime, suspend the process for awarding the .RADIO gTLD to the EBU;
- reverse the "Application Status" of the Requesters' applications and the Application submitted by the EBU to "Evaluation Complete", their respective "Contention Resolution Statuses" to "Active", and their "Contention Resolution Result" to "In Contention";
- ultimately, unless each of Requesters withdraw this Reconsideration Request or do not provide ICANN with additional information or arguments within a timeframe of 15 days following receipt of ICANN's responses to Requesters' request under ICANN's Documentary Information Disclosure Policy, reconsider the Determination and determine that the Application does not meet the required thresholds for eligibility under the Community Priority Evaluation criteria set out in the Applicant Guidebook on the basis of the information and arguments provided herein.

# 10. Please state specifically the grounds under which you have the standing and the right to assert this Request for Reconsideration, and the grounds or justifications that support your request.

Each and every Requester is an applicant for the .RADIO gTLD.

Reference is made to ICANN's status page for each of the following applications:

Given the fact that due to the Determination, none of the Requesters' applications for the .RADIO gTLD will proceed to the contracting phase with ICANN, which will likely result in ICANN not awarding the .RADIO gTLD to any of the Requesters, it is clear that the Determination materially affects each of the Requesters' respective applications.

As a consequence, they have standing to file this Reconsideration Request in relation to the Determination by the Community Priority Evaluation, as well as ICANN's subsequent decision to change the status of each of the Requesters' applications from "In Contention" to "Will Not Proceed".

The grounds that support this request are the following:

- Based on the information available to Requesters, the community definition contained in the Application does not meet the criteria for community-based gTLDs that have been set out in ICANN's Applicant Guidebook;
- Based on the information available to Requesters, the Application does not meet the requirement of "Delineation" as set out in Section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook for the reasons stated herein, and should therefore not have been awarded a passing score by the Community Priority Evaluation panel in this respect.

Reference is made to the arguments set out in Annex 1. Requesters reserve the right to provide ICANN with additional arguments following receipt of their responses to Requesters' request under ICANN's Documentary Information Disclosure Policy.

3. Based on the information available to Requesters, the Application does not meet the requirements of "Nexus" and "Uniqueness" as set out in Section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook for the reasons stated herein, and should therefore not have been awarded a passing score by the Community Priority Evaluation panel in this respect.

In view of the Requesters, the concept "radio" is much broader than the so-called community definition provided by the EBU, as contained in the determination.

Requesters refer to the fact that the Application does not cover the "radio" concept which is much broader than what has been set out in the Application. By way of example, Requesters refer to the description of all uses of the word "radio" listed by Wikipedia (see: <a href="http://en.wikipedia.org/wiki/Radio">http://en.wikipedia.org/wiki/Radio</a>; and <a href="http://en.wikipedia.org/wiki/Radio">http://en.wikipedia.org/wiki/Radio</a>; (disambiguation)).

4. Based on the information available to Requesters, the Application does

not meet the requirements of "Registration Policies" as set out in Section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook for the reasons stated herein, and should therefore not have been awarded a passing score by the Community Priority Evaluation panel in this respect.

According to the Requesters, the registration policies outlined in the Application, and in particular the eligibility and enforcement criteria set out in the Application do not meet the standards set out in the New gTLD Applicant Guidebook.

In particular, considering the fact that the eligibility criteria contained in the Application for registering domain names under the .RADIO gTLD as well as the community definition contained therein are contradictory, vague, and ill defined, this may result in:

- third parties who are affiliated with the "radio" concept, such as those who are active in the telephony, navigation, radar, video, heating, or other industries referred to – by way of example – Wikipedia will be unable to register domain names in the .RADIO gTLD because they do not meet the eligibility requirements set out in the Application, which seems to be mainly directed to the "radio industry";
- others, such as but not limited to those who merely have the technical skills to set up and maintain a "plug and play" Internet radio software or service on his or her computer but who are not related to the "radio industry" or have no further affiliation with the "radio" concept at all, will be, according to the Application, eligible to register domain names in the .RADIO gTLD. Hence, these parties will have the ability to block or deprive those who are truly and genuinely affiliated to the broad concept of "radio" to register domain names in this gTLD ...

Furthermore, Requesters are of the opinion that, given the fact that this definition and eligibility criteria are vague and contradictory, the effective enforcement of these criteria upon registrants and candidate registrants cannot be guaranteed by the EBU.

5. Based on the information available to Requesters, the Application does not meet the requirements of "Opposition" as set out in Section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook for the reasons stated herein, and should therefore not have been awarded a passing score by the Community Priority Evaluation panel in this respect.

The fact that, in the Determination, the Community Priority Evaluation panel was of the opinion that the Requesters' respective oppositions against the Application being recognized as a community-based gTLD and/or being considered to meet the thresholds set out in the Applicant

Guidebook for prevailing in the context of Community Priority Evaluation has been considered "of no relevance", considering the fact that Requesters operate a substantial part of the "radio"-related domain names in, for instance, .INFO, .ORG, .MOBI, .ASIA, .FM, .AM, and many others.<sup>1</sup>

Furthermore, bearing in mind the above, Requesters do not agree with the Community Priority Evaluation panel's Determination in which the Requesters collectively have been considered "a group of negligible size", and this for the reasons set out above.

Requesters refer to their request under the Documentary Information Disclosure Policy, attached hereto as Annex 1.

# 11a. If yes, is the causal connection between the circumstances of the Reconsideration Request and the harm the same for all of the complaining parties? Explain.

Yes. All of the Requesters are applicants for the .RADIO gTLD who are directly affected by the Determination, which – ultimately – would cause irreparable harm to Requesters if such Determination would be final.

However, Requesters acknowledge that, most likely and ultimately, only one of the Requesters or the EBU will become the Registry Operator for the .RADIO gTLD.

consolidated by the Board Governance Committee.

#### Terms and Conditions for Submission of Reconsideration Requests

The Board Governance Committee has the ability to consolidate the consideration of Reconsideration Requests if the issues stated within are sufficiently similar.

The Board Governance Committee may dismiss Reconsideration Requests that are querulous or vexatious.

Hearings are not required in the Reconsideration Process, however Requesters may request a hearing. The BGC retains the absolute discretion to determine whether a hearing is appropriate, and to call people before it for a hearing.

The BGC may take a decision on reconsideration of requests relating to staff action/inaction without reference to the full ICANN Board. Whether recommendations will issue to the ICANN Board is within the discretion of the BGC.

The ICANN Board of Director's decision on the BGC's reconsideration recommendation is final and not subject to a reconsideration request.

Thank you for your Request for Information dated 26 September 2014 (the "Request"), which was submitted through the Internet Corporation for Assigned Names and Numbers' ("ICANN's") Documentary Information Disclosure Policy ("DIDP"). For reference, a copy of your Request is attached to the email forwarding this Response.

#### **Items Requested:**

Your Request seeks the following:

- the agreement(s) between ICANN and the organizations and individuals involved in the Community Priority Evaluation, in particular the representations and warranties given and quality standards to be applied by such organizations and individuals;
- (2) policies, guidelines, directives, instructions or guidance given by ICANN relating to the Community Priority Evaluation process;
- (3) internal reports, notes, meeting minutes drawn up by or on behalf of ICANN, the Community Priority Panels, and other individuals or organizations involved in the Community Priority Evaluation in relation to the Application [for .RADIO that prevailed in the CPE];
- (4) detailed information in relation to (i) the information reviewed, (ii) criteria and standards used, (iii) arguments exchanged, (iv) information disregarded or considered irrelevant, and (v) scores given by the Community Evaluation panel in view of the criteria set out in the Applicant Guidebook, and more in particular: [relating to the panel's determination of each individual criterion].

#### Response

Community Priority Evaluations ("CPE") are performed by an independent community panel that is coordinated by the Economist Intelligent Unit ("EIU"), an independent, third-party company that contracts with ICANN to perform that coordination role. The CPE standards set forth in Section 4.2 of the Applicant Guidebook ("Guidebook") are available at <a href="http://newgtlds.icann.org/en/applicants/agb">http://newgtlds.icann.org/en/applicants/agb</a>. The CPE Panel Process Document (at <a href="http://newgtlds.icann.org/en/applicants/cpe">http://newgtlds.icann.org/en/applicants/agb</a>. The CPE Guidelines (at <a href="http://newgtlds.icann.org/en/applicants/cpe">http://newgtlds.icann.org/en/applicants/cpe</a>) provide more information on the CPE process. The Guidebook, CPE Panel Process Document, and the CPE Guidelines set forth the guidelines, procedures, standards and criteria applied to CPEs, and make clear"

that the EIU and its designated panelists are the only persons or entities involved in the provision of CPEs.

For item 1, there is a single contract at issue, the contract between ICANN and the EIU for the coordination of the independent community panels to perform CPEs in the New gTLD Program. ICANN does not contract with individuals to perform CPEs. The contract between ICANN and the EIU is not appropriate for public disclosure through the DIDP. The contract includes a confidentiality clause barring ICANN from disclosing the agreement as requested. The following Defined Conditions for Nondisclosure apply to the requested contract:

- Internal information that, if disclosed, would or would be likely to compromise the integrity of ICANN's deliberative and decision-making process by inhibiting the candid exchange of ideas and communications, including internal documents, memoranda, and other similar communications to or from ICANN Directors, ICANN Directors' Advisors, ICANN staff, ICANN consultants, ICANN contractors, and ICANN agents.
- Information provided to ICANN by a party that, if disclosed, would or would be likely to materially prejudice the commercial interests, financial interests, and/or competitive position of such party or was provided to ICANN pursuant to a nondisclosure agreement or nondisclosure provision within an agreement.
- Confidential business information and/or internal policies and procedures.

For item 2, seeking "policies, guidelines, directives, instructions or guidance given by ICANN relating to the CPE process," to the extent that this is seeking information external to the types of directives that would be incorporated into a contract, much of that information is already incorporated into the publicly available documents identified above. Similarly, for items 2, 3, and 4, ICANN has previously indicated in response to Request No. 20140804-1 that ICANN has communications with persons at EIU that are not involved in the scoring of a CPE (but otherwise assist in the facilitation of a particular CPE), and identified that those communications are not appropriate for public disclosure.

Items 3 and 4 seek extensive, detailed information regarding the analysis conducted by the CPE Panel in making its determination that the .RADIO application prevailed in the CPE. The CPE Report regarding the European Broadcasting Union's (EBU) application for the .RADIO gTLD is available at

https://www.icann.org/sites/default/files/tlds/radio/radio-cpe-1-1083-39123-en.pdf. For instance, the Requesters seek "internal reports," "detailed information in relation to [...] information disregarded or considered irrelevant," and specific information "on the reasons for" the CPE Panel's determination as to each criterion.<sup>1</sup>

To help assure independence of the process and evaluation of CPEs, ICANN (either Board or staff) is not involved with the CPE Panel's evaluation of criteria, scoring decisions, or underlying analyses. The coordination of the CPE Panel, as explained in the CPE Panel Process Document, is entirely within the work of the EIU's team. ICANN does not have, nor does it collect or maintain, the work papers of the individual CPE Panels (including the .RADIO CPE Panel) that would likely contain the information called for within these items. In accordance with the Panel Process Document, there are publicly available documents that are to be included within the CPE review, such as the comments directed to the Community Evaluation Panel on the EBU's .RADIO application by commenters including Donuts (https://gtldcomment.icann.org/commentsfeedback/applicationcomment/commentdetails/12392), Minds + Machines (https://gtldcomment.icann.org/commentsfeedback/applicationcomment/commentdetails/12393) and others identified at the comment collection page https://gtldcomment.icann.org/comments-

feedback/applicationcomment/viewcomments.

As such, to the extent that ICANN has documentation responsive to Items 2, 3 and 4, such documents are either already public or subject to certain of the Defined Conditions for Nondisclosure set forth in the DIDP:

- Internal information that, if disclosed, would or would be likely to compromise the integrity of ICANN's deliberative and decision-making process by inhibiting the candid exchange of ideas and communications, including internal documents, memoranda, and other similar communications to or from ICANN Directors, ICANN Directors' Advisors, ICANN staff, ICANN consultants, ICANN contractors, and ICANN agents.
- Information exchanged, prepared for, or derived from the deliberative and decision-making process between ICANN, its constituents, and/or other entities with which ICANN cooperates that, if disclosed, would or would be likely to compromise the integrity of the deliberative and decision-making process between and among ICANN, its constituents, and/or other entities with which ICANN cooperates by inhibiting the candid exchange of ideas and communications.
- Information provided to ICANN by a party that, if disclosed, would or would be likely to materially prejudice the commercial interests, financial interests, and/or competitive position of such party or was provided to ICANN pursuant to a nondisclosure agreement or nondisclosure provision within an agreement.
- Confidential business information and/or internal policies and procedures.
- Drafts of all correspondence, reports, documents, agreements, contracts, emails, or any other forms of communication.

Although your analysis in the Request concluded that no Conditions for Nondisclosure should apply, ICANN must independently undertake the analysis of each Condition as it

applies to the documentation at issue, and make the final determination as to whether any Nondisclosure Conditions apply. Here, for example, ICANN cannot violate contractual conditions that require ICANN to maintain items as confidential solely because the Request proffers that no such conditions apply. Similarly, ICANN does not release draft documentation – particularly if draft documentation was shared for the purpose of facilitating deliberations or decision making – because drafts are not reliable sources of information regarding what actually occurred or standards that were actually applied.

For each of the items identified above as subject to Defined Conditions of Nondisclosure, ICANN has determined that there are no particular circumstances for which the public interest in disclosing the information outweighs the harm that may be caused to ICANN, its contractual relationships and its contractors' deliberative processes by the requested disclosure.

- changing the status of Requesters' respective applications for the .RADIO gTLD to "Will Not Proceed", as referred to their respective status pages available at <a href="https://gtldresult.icann.org/application-result/applicationstatus/applicationdetails/1848">https://gtldresult.icann.org/application-result/applicationstatus/applicationdetails/1848</a>; <a href="https://gtldresult.icann.org/application-result/applicationstatus/applicationdetails/1508">https://gtldresult.icann.org/application-result/applicationstatus/application-result/applicationstatus/application-result/applicationstatus/application-result/applicationstatus/application-result/application-re

Together with the initial Reconsideration Request that has been filed on behalf of Requesters on (date), Requesters submitted a Request for Information under ICANN's Documentary Information Disclosure Policy on September 26, 2014, a copy whereof has been attached hereto as **Annex 2** (hereinafter: the "Request for Information").

Considering the fact that the Request for Information is aimed at obtaining further information and insights into the information, criteria and arguments used by the Community Priority Evaluation Panel in connection with its evaluation of the Application, Requesters request ICANN to review (i) ICANN's Response to the Request for Information, and (ii) the Determination as one single Reconsideration Request, unless expressly provided for otherwise herein.

### 4. Date of action/inaction:

- 10 September 2014 with respect to the publication of the Determination;
- 24 October 2014 with respect to ICANN's Response to Requesters' Request for Information under ICANN's Documentary Information Disclosure Policy, attached hereto as <u>Annex 3</u>.

### 5. On what date did you became aware of the action or that action would not be taken?

- 11 September 2014 with respect to the publication of the Determination;
- 27 October 2014 with respect to the ICANN's Response to Requesters' Request for Information under ICANN's Documentary Information Disclosure Policy.

## 6. Describe how you believe you are materially affected by the action or inaction:

Considering the fact that the Determination states that the EBU's Application prevailed in the context of Community Priority Evaluation, the Requesters' respective applications for the .RADIO gTLD will be no longer considered by ICANN, which will likely result in ICANN not awarding the .RADIO gTLD to any of the Requesters.

Furthermore, ICANN's decided not to disclose any additional information requested by Requesters in their Request for Information, which was aimed at providing Requesters more insights into the information on which the EIU has based its Determination, and more in particular information relating to:

- the agreement(s) between ICANN and the organizations and individuals involved in the Community Priority Evaluation, in particular the representations and warranties given and quality standards to be applied by such organizations and individuals;
- (2) policies, guidelines, directives, instructions or guidance given by ICANN relating to the Community Priority Evaluation process;
- (3) internal reports, notes, meeting minutes drawn up by or on behalf of ICANN, the Community Priority Panels, and other individuals or organizations involved in the Community Priority Evaluation in relation to the Application [for .RADIO that prevailed in the CPE];
- (4) detailed information in relation to (i) the information reviewed, (ii) criteria and standards used, (iii) arguments exchanged, (iv) information disregarded or considered irrelevant, and (v) scores given by the Community Evaluation panel in view of the criteria set out in the Applicant Guidebook, and more in particular: [relating to the panel's determination of each individual criterion].

The full Request for Information has been enclosed to this Reconsideration Request as **Annex 2** and is incorporated herein by reference.

ICANN's Response to the Request for Information states:

"For each of the items identified above as subject to Defined Conditions of Nondisclosure, ICANN has determined that there are no particular circumstances for which the public interest in disclosing the information outweighs the harm that may be caused to ICANN, its contractual relationships and its contractors' deliberative processes by the requested disclosure".

The mere fact of denying Requesters access to information that has been used in connection with the evaluation of the Application without (i) expressly referring on which information the Community Priority Evaluation Panel has relied, (ii) providing a statement regarding the relevancy of such information in connection with the actual evaluation, nor (iii) arguments on why such information is supporting the outcome of the actual evaluation deprives Requesters of the possibility to review the Determination, and restricts their fundamental rights to challenge such Determination in the context of a Reconsideration Request and, ultimately, use the transparency and accountability mechanisms embedded into ICANN's By-Laws.

### 7. Describe how others may be adversely affected by the action or inaction, if you believe that this is a concern.

In view of the Requesters, the concept "radio" is much broader than the so-called community definition provided by the EBU, as contained in the determination.

Requesters refer to:

- the community definition contained in the Application, which in Requesters' opinion – does not meet the criteria for community-based gTLDs that have been set out in ICANN's Applicant Guidebook;
- the community definition contained in the Application does not cover the "radio" concept which is much broader than what has been set out in the Application, as will be demonstrated below. By way of example, Requesters refer to the description of all uses of the word "radio" listed by Wikipedia (see: <u>http://en.wikipedia.org/wiki/Radio</u>; and <u>http://en.wikipedia.org/wiki/Radio\_(disambiguation)</u>);
- the registration policies, and in particular the eligibility and enforcement criteria set out in the Application do not meet the standards set out in the New gTLD Applicant Guidebook. In particular, considering the fact that the eligibility criteria contained in the Application for registering domain names under the .RADIO gTLD as well as the community definition contained therein are contradictory, vague, and ill defined, this may result in:
  - third parties who are affiliated with the "radio" concept, such as those who are active in the telephony, navigation, radar, video, heating, or other industries referred to – by way of example – Wikipedia will be unable to register domain names in the .RADIO gTLD because they do not meet the eligibility requirements set out in the Application, which seems to be mainly directed to the "radio industry";
  - others, such as but not limited to those who merely have the technical skills to set up and maintain a "plug and play" Internet radio software or service on his or her computer but who are not related to the "radio industry" or have no further affiliation with the "radio" concept at all, will be, according to the Application, eligible

to register domain names in the .RADIO gTLD. Hence, these parties will have the ability to block or deprive those who are truly and genuinely affiliated to the broad concept of "radio" to register domain names in this gTLD ...

- the fact that, in the Determination, the Community Priority Evaluation panel was of the opinion that the Requesters' respective oppositions against the Application being recognized as a community-based gTLD and/or being considered to meet the thresholds set out in the Applicant Guidebook for prevailing in the context of Community Priority Evaluation has been considered "of no relevance", considering the fact that Requesters operate a substantial part of the "radio"-related domain names in, for instance, .INFO, .ORG, .MOBI, .ASIA, .FM, .AM, and many others;<sup>1</sup>
- the fact that, bearing in mind the above, the Community Priority Evaluation panel was of the opinion that the Requesters collectively have been considered "a group of negligible size".

Requesters refer to their Request for Information, attached hereto as Annex 2.

### 8. Detail of Board or Staff Action – Required Information

### Provide the Required Detailed Explanation here:

### 8.1. Background Information

In the context of ICANN's New gTLD Program, ICANN has received the following applications for the .RADIO gTLD:

- the EBU's application for a community-based gTLD (Application ID 1-1083-39123);
- Afilias Ltd.'s "standard" application (Application ID 1-868-75631);
- BRS Media, Inc.'s "standard" application (Application ID 1-994-75477);
- Tin Dale's "standard" application (Application ID 1-1593-8224).

On September 10, 2014, ICANN's Community Priority Evaluation panel published its Determination stating that the EBU's Application for the .RADIO gTLD obtained a passing score of 14 out of 16 points, and hence prevailed in Community Priority Evaluation.

Since Requesters are of the opinion that the publication of these Community Priority Evaluation results are considered to be an action by ICANN staff, they are entitled to invoke and utilize ICANN's Reconsideration Request process in relation to this Determination / action by ICANN staff.

The immediate effect of this Determination seems to be that each of the Requesters' applications for the .RADIO gTLD will no longer be considered by ICANN, given the fact that the status of each of their applications has been changed to "Will Not Proceed", as is reflected on their respective Application Status pages published by ICANN. Reference is made to:

# 8.2. Requesters' Request for Information under ICANN's Documentary Information Disclosure Policy (DIDP)

Following receipt of the Determination, Requesters have submitted a detailed Request for Information to ICANN under the latter's Documentary Information Disclosure Policy (DIDP).

In Requester's opinion, the EIU, who has been appointed by ICANN as the community priority evaluation independent panel firm, is subject to the same policies – especially those relating to transparency and accountability – as ICANN. Since the EIU is considered an "ICANN Affiliated Party" under ICANN's Top-Level Domain Application Terms and Conditions (see <a href="http://newgtlds.icann.org/en/applicants/agb/terms">http://newgtlds.icann.org/en/applicants/agb/terms</a>) it is subject to the same rules and procedures as ICANN, and more precisely those roles and procedures reflected in ICANN's By-Laws.

Indeed, the fact that ICANN has apparently deferred the actual community priority evaluation to a third party does not release ICANN or such third party from the transparency and accountability obligations contained in ICANN's By-Laws.

### 8.3. ICANN's Response to Requesters' Request for Information

However, ICANN denied Requesters' Request for Information, whereby

Requesters refer to the following quotes from the Response to the Request for Information:

- 1) *"The contract between ICANN and the EIU is not appropriate for public disclosure through the DIDP".* More in particular, ICANN refers to certain alleged Defined Conditions for Nondisclosure that would apply to the requested contract:
  - Internal information that, if disclosed, would or would be likely to compromise the integrity of ICANN's deliberative and decision-making process by inhibiting the candid exchange of ideas and communications, including internal documents, memoranda, and other similar communications to or from ICANN Directors, ICANN Directors' Advisors, ICANN staff, ICANN consultants, ICANN contractors, and ICANN agents.
  - Information provided to ICANN by a party that, if disclosed, would or would be likely to materially prejudice the commercial interests, financial interests, and/or competitive position of such party or was provided to ICANN pursuant to a nondisclosure agreement or nondisclosure provision within an agreement.
  - Confidential business information and/or internal policies and procedures.
- "ICANN has previously indicated in response to Request No. 20140804-1 that ICANN has communications with persons at EIU that are not involved in the scoring of a CPE (but otherwise assist in the facilitation of a particular CPE), and identified that those communications are not appropriate for public disclosure";
- 3) "To help assure independence of the process and evaluation of CPEs, ICANN (either Board or staff) is not involved with the CPE Panel's evaluation of criteria, scoring decisions, or underlying analyses. The coordination of the CPE Panel, as explained in the CPE Panel Process Document, is entirely within the work of the EIU's team. ICANN does not have, nor does it collect or maintain, the work papers of the individual CPE Panels (including the .RADIO CPE Panel) that would likely contain the information called for within these items."

None of the above arguments are convincing in light of ICANN's By-Laws obligations relating to transparency and accountability:

Indeed, it is not because of the fact that the EIU is independent from ICANN, the EBU or Requesters, that it would not be required to be subject to the same obligations of transparency and accountability as ICANN itself. Indeed, if a decision or determination by such third party materially affects and/or has a material effect in a process that is managed by ICANN – as it has been described in the Applicant Guidebook, the CPE Guidelines, etc. – then such party

should be subject to the same transparency and accountability mechanisms as ICANN.

Therefore, ICANN cannot simply deny its own By-Laws obligations when entering into undisclosed agreements with third parties, in particular when such party or parties assume(s) a role which is actually ICANN's to fulfill.

### 9. What are you asking ICANN to do now?

Based upon the information contained in the Application, Requests are convinced that the Application does not meet the criteria to qualify as a community-based gTLD set out in ICANN's Applicant Guidebook.

In view of obtaining further insights into the arguments of the Community Priority Evaluation panel and the information on which such panel has relied, Requesters have submitted together with this Reconsideration Request and request to obtain further information under ICANN's Documentary Information Disclosure Policy.

Based upon the information and arguments included in this Reconsideration Request, for which the Requesters reserve the right to submit additional arguments and information following the outcome of their request submitted to ICANN in accordance with the Documentary Information Disclosure Policy, Requesters request ICANN to:

- (a) acknowledge receipt of this Reconsideration Request;
- (b) suspend the process for awarding the .RADIO gTLD to the EBU;
- (c) restore the "Application Status" of the Requesters' applications and the Application submitted by the EBU to "Evaluation Complete", their respective "Contention Resolution Statuses" to "Active", and their "Contention Resolution Result" to "In Contention";
- (d) reconsider ICANN's Response to Requesters' Request for Information under ICANN's Documentary Information Disclosure Policy, attached hereto as Annex 3, by providing Requesters' with the information requested in Requesters' Request for Information, attached hereto as Annex 2;
- (e) provide Requesters' with an additional timeframe of 15 days following receipt of the information disclosed following disclosure of the information requested in the Request for Information, this in order for them to complete Section (to be completed) of this Reconsideration Request, and submit the final version to ICANN;
- (f) organize a hearing whereby both the EBU and the Requesters can submit, present and discuss their arguments before ICANN, in view of enabling the latter to take an informed decision on the issue;

- (g) regardless of whether ICANN allows Requesters' requests stated in (d), (e) and/or (f) above, reconsider:
  - the Determination, and in particular not award a passing score in view of the Community Priority Evaluation criteria set out in the Applicant Guidebook for the reasons expressed in this Reconsideration Request;
  - II. ICANN's respective decisions that each of the Requesters' applications for the .RADIO gTLD "Will Not Proceed" to contracting.

# 10. Please state specifically the grounds under which you have the standing and the right to assert this Request for Reconsideration, and the grounds or justifications that support your request.

### 10.1. Background

Each and every Requester is an applicant for the .RADIO gTLD.

Reference is made to ICANN's status page for each of the following applications:

Given the fact that due to the Determination, none of the Requesters' applications for the .RADIO gTLD will proceed to the contracting phase with ICANN, which will likely result in ICANN not awarding the .RADIO gTLD to any of the Requesters, it is clear that the Determination materially affects each of the Requesters' respective applications.

As a consequence, they have standing to file this Reconsideration Request in relation to the Determination by the Community Priority Evaluation, as well as ICANN's subsequent decision to change the status of each of the Requesters' applications from "In Contention" to "Will Not Proceed".

Upon submission of their respective applications for the .RADIO gTLD, Requesters have accepted the

# **10.2.** In relation to ICANN's Response to Requesters' Request for Information

As stated above, ICANN has basically denied each and every request for information made by Requesters in their Request for Information.

ICANN states in its Response to the Request for Information that the Economic Intelligence Unit (EIU) is an independent panel firm, that has been engaged by ICANN in order to perform CPEs.

Requesters do not challenge the independency of the Economist Intelligence Unit (EIU), or at least do not have knowledge about any facts or circumstances to the contrary.

However, it is not because of the fact that the EIU is independent from ICANN, the EBU or Requesters, that it would not be required to be subject to the same obligations of transparency and accountability as ICANN itself. Indeed, if a decision or determination by such third party materially affects and/or has a material effect in a process that is managed by ICANN – as it has been described in the Applicant Guidebook, the CPE Guidelines, etc. – then such party should be subject to the same transparency and accountability mechanisms as ICANN.

Requesters have entered into an agreement with ICANN when submitting their respective applications for the .RADIO gTLD to ICANN. It goes without saying that ICANN and any ICANN Affiliated Party is and must be able to be held accountable under ICANN's transparency and accountability mechanisms

Moreover, if it would be so that ICANN has entered into arrangements with third parties that would deprive ICANN of its obligations and responsibilities laid down in its By-Laws, and more in particular its obligations of Transparency, Accountability and Review, then entering such an arrangement by itself must be considered an action that would be contrary to ICANN's By-Laws.

### Conclusion

Considering the fact that ICANN has denied each and every request made by Requesters in the context of the Request for Information, the Response provided contradicts established ICANN policies, as provided for in Article IV, Section 2, (2), (a) of ICANN's By-Laws.

Requesters therefore request ICANN to disclose to Requesters any and all information requested in its Request for Information as set out in Annex 2 hereto, and allow Requesters for an additional delay of 15 days following receipt of such information in order to amend – if needed – this Reconsideration Request.

### 10.3. In relation to the Determination itself

#### 10.3.1. As regards the criterion "Delineation":

According to the Determination, the community defined in the Application is as follows:

The Radio industry is composed of a huge number of very diverse radio broadcasters: public and private; international and local; commercial or community-oriented; general purpose, or sector-specific; talk or music; big and small. All licensed radio broadcasters are part of the .radio community, and so are the associations, federations and unions they have created (such as the EBU, applicant for the .radio TLD with the support of its sister Unions; see below for more details on Radio industry representativeness). Also included are the radio professionals, those making radio the fundamental communications tool that it is.

However, the Radio industry keeps evolving and today, many stations are not only broadcasting in the traditional sense, but also webcasting and streaming their audio content via the Internet. Some are not broadcasters in the traditional sense: Internet radios are also part of the Radio community, and as such will be acknowledged by .radio TLD, as will podcasters. In all cases certain minimum standards on streaming or updating schedules will apply.

The .radio community also comprises the often overlooked amateur radio, which uses radio frequencies for communications to small circles of the public. Licensed radio amateurs and their clubs will also be part of the .radio community.

Finally, the community includes a variety of companies providing specific services or products to the Radio industry.

The community definition contained in the Application refers to the definition of the "radio industry" as included in the North American Industrial Classification System (NAICS). This definition reads as follows:

"Establishments primarily engaged in broadcasting aural programs by radio to the public. Included in this industry are commercial, religious, educational, and other radio stations. Also included here are establishments primarily engaged in radio broadcasting and which produce radio program materials."<sup>2</sup>

Key elements in this definition include:

- Criterion 1: members of the radio industry are *"establishments"* and *"radio stations"*;
- Criterion 2: they are "primarily engaged in radio broadcasting"; and
- Criterion 3: they "produce radio program materials".

On the basis of the Community Definition provided by the EBU, it is clear that certain "members" of the "radio community" listed by the EBU, such as "radio professionals", "licensed radio amateurs" and "podcasters" do not meet Criterion 1 set out above.

Also, the EBU and the EIU seem to acknowledge that certain "individuals that are in the radio industry" to which the Determination refers, even expressly referencing the NAICS definition in the footnote immediately thereafter, meet Criterion 1 set out above. Requesters do not understand how an individual can be considered an "establishment" or a "radio station".

Other "members" of the "radio community" listed by the EBU, such as "podcasters" also fail to meet Criterion 2 set out above: although they are producing radio program materials, they are obviously *not primarily engaged in radio broadcasting*.

As is generally known, streaming media differs from podcasting in that the file is not downloaded to the person's computer. Instead, the file is "streamed" from a media server directly to the person's computer.<sup>3</sup>

Requesters in this respect refer to the fact that the EBU does not have any members with full voting privileges that are offering their services as "Internet only" webcast or streaming as such. Also, there appear to be no EBU members and members of the unions (as the "voting members" are restricted to terrestrial broadcasters that are "podcast only" audio providers).

More in general, it is not clear to Requesters how the concept of *"a variety of companies"* referred to in the EBU's community definition rhymes with the concept of the Guidebook requirement for community-based applicants to serve a *"clear and straightforward membership that is well-defined"*.

Furthermore, Requesters do not understand why the EIU has acknowledged that *"a variety of companies providing specific services or products to the Radio industry"* meet Criteria 1, 2 or 3 set out above. Indeed, the wording *"variety of companies"* and *"specific services or products"* are obviously much broader than the criteria set forth in the NAICS definition. This is more in particular the case when these companies are rendering "specific" services or products, without expressly mentioning which services are referred to, or what the criteria are for

these services or products to be "specific". These overly broad terms are obviously not in line with the Guidebook's requirement to serve members of a community that "shows a clear and straightforward membership, and is therefore well-defined".

Also, Requesters are unaware of any specific membership criteria that would apply to "radio professionals", "licensed radio amateurs", "podcasters", and "a wide variety of companies providing specific services or products to the Radio industry", apart from the fact that these individuals or organisations have some affinity with the medium "radio".

For instance, under the Community Evaluation Panel's assessment, every employee of a radio company or station can register a .radio domain name, even if such employee's actual professional activities are unrelated to the radio medium as such.

Insofar and to the extent these products and services are specific to the "radio industry", it is not clear to the Requesters how, on the one hand, the reference made in the Application that the so-called "radio community" includes a "wide variety of members", including "radio-related providers that can be identified through trademarks", and "radio industry partners and providers" whereas, according to the NAICS definition, the membership to the radio industry is much more narrow considering the three criteria set out above.

It is commonly known that various companies are offering "Internet radio software" to Internet users, enabling them to operate an Internet radio and stream live audio instantly over the Internet. Considering the fact that – according to the Application – Internet radios are also "part of the Radio community", it is obvious that including any person or entity who sets up a "plug and play" Internet radio system in a few minutes cannot be considered meeting the requirements of a clear and straightforward membership that is well defined.

In the Application, the EBU states that in order to qualify, "Internet radios need to meet certain minimum standards" without being specific on (i) what these standards are, (ii) who has established such standards, and (iii) how the EBU is going to verify whether these standards are met.

It is not clear to Requesters how the CPE panel could agree that the EBU serves the best interest of their community if the "standards" referred to in the Application simply do not exist. Indeed, there are no such "minimum standards on streaming." Furthermore, there simply is no authoritative written definition, limit, or rule approved and monitored for compliance by an authoritative agency (or professional or recognized body) as a minimum acceptable benchmark. Additionally, according to Wikipedia, *"Podcasting contrasts with Internet streaming,"* which means that podcasters would not meet any standards relating to streaming.

Requesters believe that the standards that will be utilized and enforced by the EBU should be available for review. Indeed, standards in broadcasting are non-proprietary and by nature of the development of standards, the standards for worldwide radio are collaborative. But no clear reference has been made in the Application to any of these standards, which is likely because they do not exist ...

In so far and to the extent these standards are Internet-based, they likely need to be developed within ISOC or the 3WC, and not the EBU; standards for international radio are developed within the ITU, of which the EBU is a mere member. Therefore, the EBU does not have any standing in the development or propagation of any of the standards that exist or will be established in the future within the radio industry.

In the Determination, the Community Priority Evaluation panel acknowledges – and in the opinion of the Requesters rightfully so – that the community invoked by the EBU in the Application does not meet the requirements of "Organization". According to the Determination:

"Based on the information provided in the application materials and the Panel's research, there is no such entity that organizes the community defined in the application. Therefore, as there is no entity that is mainly dedicated to the community as defined in the .RADIO application, as the Panel has determined, there cannot be documented evidence of community activities".<sup>4</sup>

Therefore, this has to be considered a clear contradiction with the Determination provided under the Delineation criterion, where the Community Priority Evaluation panel have found that the *"membership in the (industry) community is sufficiently structured as the requirements listed in the community definition above show"*.

Based on this, Requesters cannot accept the contradiction in the EIU's acknowledgement of the fact that the so-called community defined by the EBU is on the one hand *insufficiently organized*, but on the other hand is found to be *"sufficiently structured"*.

Based on the above arguments, Requesters respectfully request ICANN to reconsider the Determination by the EIU in relation to the "Delineation" criterion set out in the Applicant Guidebook.

### 10.3.2. In relation to the criteria "Nexus" and "Uniqueness":

According to the Determination:

"The Community Priority Evaluation panel determined that the application met the criterion for Uniqueness as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the string has no other significant meaning beyond identifying the community described in the application.

[...]

To fulfill the requirements for Uniqueness, the string must have no other significant meaning beyond identifying the community described in the application. The string as defined in the application demonstrates uniqueness, as the string does not have any other meaning beyond identifying the community described in the application."

A simple search on Wikipedia shows that the word *"radio"* extends far beyond the narrow concept as described in the application, and in particular in the description provided in the NAICS' *"radio industry"* definition, as the term *"radio"* also covers additional uses of the *"radiation of electromagnetic signals through the atmosphere or free space"*, such as:

- Telephony;
- Video;
- Navigation (used in, *e.g.*, sattellite navigation systems, such as GPS);
- Radar;
- Heating (used in, e.g., microwaves and induction furnaces); and
- Radio control.<sup>5</sup>

(see print-out contained in Annex 4).

Considering the fact that the EIU has referred to definitions contained in the Oxford English Dictionaries in various determinations in relation other community-based applications, Requesters refer – in view of consistency to the descriptions contained therein and their respective quotations (see print-out contained in **Annex 5**).

By way of example, Requesters point out to the fact that manufacturers of radio transmitters or receivers – both critical elements and tools in order to be able to send and receive broadcasted radio programs – have to be added to this list, and do not form part of the definition of the NAICS definition since they do not meet Criteria 2 and 3 discussed in Section 10.3.1 above ...

Considering the above, it is obvious that the other uses and meanings of the word "radio" have been disregarded by the Community Priority Evaluation panel, which becomes obvious when the same standards and references are used as the EIU has done in other determinations regarding community-based applications. Indeed, in various cases, when testing this criterion, the EIU has referred to the definition contained in the Oxford English Dictionary. Requesters submit as Annex 5 to this Reconsideration Request the list of definitions and descriptions contained in the on line version of the Oxford English Dictionary, which makes it obvious from the outset that the word "radio" has various other meanings that fall outside of the remit of the EBU's concept.

The Requesters are therefore of the opinion that, if the EIU would use the Oxford English Dictionary as a standard for testing this criterion, it needs to do so consistently in all of the cases under their review. If not, the EIU has been using a double standard, without providing any proper justification for doing so.

Therefore, Requesters respectfully request ICANN to reconsider the scoring given by the EIU in relation to the Guidebook criteria "Nexus" and "Uniqueness", because:

- the meaning of the word "radio" is by all means not "unique" (which can be easily retrieved on a commonly known website such as Wikipedia or the Oxford English Dictionary); and
- the uses and meanings listed above (including references mentioned by Wikipedia and Oxford English Dictionary) are unrelated to any of the activities carried out by the EBU and the organizations supporting the Application.

Requesters are therefore of the opinion that the .RADIO gTLD over-reaches substantially beyond the community described by the EBU, because the string indicates a wider thematic remit than the community has. For this reason, Requesters request ICANN to reconsider the Determination and provide for a score of zero ("0") points on this criterion.

# 10.3.3. Registration Policies – Eligibility; Name Selection; Content and Use; Enforcement

The Community Priority Evaluation panel has determined that "[...] the application demonstrates adherence to this requirement by restricting eligibility to the community categories mentioned in Delineation, and additionally requiring the registered domain name be "accepted as legitimate, and beneficial to the cause and value of the radio industry; and commensurate with the role and importance of the registered domain name; and in good faith at the time of registration and thereafter.""

Considering the fact that Requesters have requested further clarifications and information on the information and criteria used by the Community Priority Evaluation panel in § I. above, it is unclear which standards and criteria are going to be used, implemented and enforced by the EBU in view of ensuring that only members of the "radio community" or "radio industry" can register domain names.

Especially since Requesters have established that, on the basis of the criteria set out in the Application, anyone with some affinity with the concept "radio" are considered by the EBU and the Community Evaluation Panel as members of the "radio community", Requesters would like to obtain the information and arguments used by this panel in determining that the criteria for eligibility are satisfied, even when disregarding parties who are active in other, albeit adjacent industries, such as the video, radar, navigation, and heating industry, as well as manufacturers of radio transmitters and receivers.

Furthermore, since the standard propagated by the EBU in relation to name selection is that "the domain name must be commensurate with the role of the registered domain, and with the role and importance of the domain name based on the meaning an average user would reasonably assume in the context of the domain name", Requesters would like to obtain the information, arguments, and the application thereof in concrete use cases they have developed on the basis of the information contained in the Application in order to determine that the "registration policies for name selection for registrants must be consistent with the articulated, community-based purpose of the applied-for gTLD", especially since Requesters do not understand what the EBU means by:

- a) "the domain name must be commensurate with the role of the registered domain";
- b) "the domain name must be commensurate with [...] the role and importance of the domain name";
- c) the criteria the "meaning" of the domain name, "average user", and such average user's "reasonable assumption",

and the standards and criteria used by ICANN and the Community Priority Evaluation panel in establishing that – on the basis of these requirements – names can be excluded from registration because they have no connection with the so-called "radio community", and how these vague requirements can possibly be enforced against the registrant.

The same question arises in relation to the standards and criteria applied by the EBU and evaluated positively by ICANN and the Community Priority Evaluation panel in terms of the "Contents and Use" criterion.

For these reasons, the Requesters are of the opinion that the scoring in relation to Registration Policies needs to be reconsidered.

### 10.3.4. In relation to the criterion "Community Endorsement":

The Community Priority Evaluation panel determined that the EBU "was not the recognized community institution(s)/member organization(s)", which is a view that is supported by the Requesters: the EBU represents, as dictated by their bylaws, "over the air" terrestrial broadcasting (as defined by the ITU). The EBU does not have any "non-radio", "non-TV station" or "Internet only" webcasters as members, let alone "non-terrestrial podcasters". Nonetheless, the EBU includes them in the community definition. Furthermore, the EBU does not include other radio communities (as defined by the ITU) in its community definition.

However, the Community Priority Evaluation panel has determined that the EBU *"[…] possesses documented support from institutions / organizations representing a majority of the community addressed."* 

This is factually incorrect, which can be easily verified by using the criteria provide by the CPE Panel and by making reference to the World CIA Factbook: although the EBU states that they represent about 50,000 radio stations in the world, the "Member Unions" that have provided their support <u>only account for 589 full members</u> that are involved in the "radio" business:

- ABU Asia Pacific Broadcasting Union: 90 members
- ASBU Arab States Broadcasting Union: 28 members
- AUB African Broadcasting Union: 39 members
- CBU Caribbean Broadcasting Union: 17 members
- AIR/IAB International Association of Broadcasting: 24 members
- NABA North American Broadcasting Association: 391 members<sup>6</sup>
- OTI Organización de Telecomunicaciones Iberoamericanas: 0 members.<sup>7</sup>

Requesters note that the majority of these "members" are state-owned or relate to public broadcasters. Furthermore, the activities of quite a number of these members relates to television broadcasting, and therefore have to be disregarded in the context of the .RADIO CPE.

Furthermore, in looking at the proponents of the EBU's Application and objections, Requesters noted that being a member of a union or a broadcasting association does not necessarily entail that each member supports the endorsement of such organization. Indeed, a status as affiliate member of one of the unions only entitles them to an individual vote at maximum. Therefore, it is

unknown and unclear whether an individual member of one of the quoted unions or organizations effectively supports the EBU's Application ...

In view of the above, Requesters have demonstrated that the letters of support were submitted by institutions / organizations representing a vast *minority* of the community addressed, and that the score provided in the Determination must be reconsidered.

### 10.3.5. In relation to the criterion "Opposition":

Requesters do not understand the reasons why and the criteria against which the public comments, submitted by or on behalf of the Requesters to ICANN in relation to the Application, which all contained strong opposition against ICANN awarding the .RADIO gTLD to the Applicant have been considered "of no relevance" or that each of the Requesters is to be considered as a "group of negligible size".

The outcome of the Community Priority Evaluation is particularly surprising, considering the fact that one of the Requesters, BRS Media Inc., is the registry for the .FM TLD, which is serving many domain name registrants relating to radio.

Requesters' consider this consolidated filing appropriate since the alleged causal connection and the resulting harm is the same for all of the Requesters. In each of the individual Requesters' views, they have demonstrated that it has been materially harmed and adversely impacted by the action or inaction giving rise to the request, as required by Article IV, Section 2, (8) of ICANN's By-Laws.

# 11a. If yes, is the causal connection between the circumstances of the Reconsideration Request and the harm the same for all of the complaining parties? Explain.

Yes. All of the Requesters are applicants for the .RADIO gTLD who are directly affected by the Determination, which – ultimately – would cause irreparable harm to Requesters if such Determination would be final.

However, Requesters acknowledge that, most likely and ultimately, only one of

the Requestors or the EBU will become the Registry Operator for the .RADIO gTLD.

### Do you have any documents you want to provide to ICANN?

Pending Requesters' request under the Documentary Information Disclosure Policy, Requesters are not providing any specific documents to ICANN, but reserve the right to do so as a follow-up to this Reconsideration Request or in the context of one or more new Reconsideration Requests. Requesters recognize and acknowledge that any such additional Reconsideration Requests may be consolidated by the Board Governance Committee.

### Terms and Conditions for Submission of Reconsideration Requests

The Board Governance Committee has the ability to consolidate the consideration of Reconsideration Requests if the issues stated within are sufficiently similar.

The Board Governance Committee may dismiss Reconsideration Requests that are querulous or vexatious.

Hearings are not required in the Reconsideration Process, however Requestors may request a hearing. The BGC retains the absolute discretion to determine whether a hearing is appropriate, and to call people before it for a hearing.

The BGC may take a decision on reconsideration of requests relating to staff action/inaction without reference to the full ICANN Board. Whether recommendations will issue to the ICANN Board is within the discretion of the BGC.

The ICANN Board of Director's decision on the BGC's reconsideration recommendation is final and not subject to a reconsideration request.

Criterion #1: Community Establishment	3/4 Point(s)
1-A Delineation	1/2 Point(s)

The Community Priority Evaluation panel determined that the community as defined in the application partially met the criterion for Delineation as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as it is clearly delineated and pre-existing, but, as defined, is not sufficiently organized. The application received a score of 1 out of 2 points under criterion 1-A: Delineation.

#### Delineation

Two conditions must be met to fulfill the requirements for delineation: there must be a clear, straightforward membership definition and there must be awareness and recognition of a community (as defined by the applicant) among its members.

The community defined in the application ("RADIO") is, as follows:

The Radio industry is composed of a huge number of very diverse radio broadcasters: public and private; international and local; commercial or community-oriented; general purpose, or sector-

specific; talk or music; big and small. All licensed radio broadcasters are part of the .radio community, and so are the associations, federations and unions they have created (such as the EBU, applicant for the .radio TLD with the support of its sister Unions; see below for more details on Radio industry representativeness). Also included are the radio professionals, those making radio the fundamental communications tool that it is.

However, the Radio industry keeps evolving and today, many stations are not only broadcasting in the traditional sense, but also webcasting and streaming their audio content via the Internet. Some are not broadcasters in the traditional sense: Internet radios are also part of the Radio community, and as such will be acknowledged by .radio TLD, as will podcasters. In all cases certain minimum standards on streaming or updating schedules will apply.

The .radio community also comprises the often overlooked amateur radio, which uses radio frequencies for communications to small circles of the public. Licensed radio amateurs and their clubs will also be part of the .radio community.

Finally, the community includes a variety of companies providing specific services or products to the Radio industry.

This community definition shows a clear and straightforward membership and is therefore well defined. Association with, and membership in, the radio community can be verified through licenses held by professional and amateur radio broadcasters; membership in radio-related associations, clubs and unions; internet radios that meet certain minimum standards; radio-related service providers that can be identified through trademarks; and radio industry partners and providers.

In addition, the community as defined in the application has awareness and recognition among its members. This is because the community as defined consists of entities and individuals that are in the radio industry<sup>1</sup>, and as participants in this clearly defined industry, they have an awareness and recognition of their inclusion in the industry community. In addition, membership in the (industry) community is sufficiently structured, as the requirements listed in the community definition above show.

The Community Priority Evaluation panel determined that the community as defined in the application satisfies both of the conditions to fulfill the requirements for Delineation.

#### Organization

Two conditions need to be met to fulfill the requirements for organization: there must be at least one entity mainly dedicated to the community, and there must be documented evidence of community activities.

The community as defined in the application does not have one entity mainly dedicated to the community. There are several entities that represent parts of the radio community, such as the World Broadcasting Unions (WBU), the Association for International Broadcasting, the Association of European Radios, the Association Mondiale des Radiodiffuseurs Communautaires, the European Association of Television and Radio Sales Houses, the Union Radiophonique et Télévisuelle Internationale, and the Internet Media Device Alliance. Based on the Panel's research, these entities only represent certain segments of the community as defined by the applicant. For example, the WBU is the umbrella organization for eight regional broadcasting unions, but does not represent amateur radio. There is no entity that represents all of the radio member categories outlined by the applicant. According to the application:

The Radio community is structured mainly under 8 world broadcasting Unions which represent radio broadcasting interests at the World Radio Frequencies Conferences and coordinate their work through the WBU, as described in response to Question 11H.

The WBU works through a number of permanent working commissions, such as the Technical Committee, which deals with technical standardization; the Sports Committee, dealing with the coverage of world sports events (such as Olympic Games and football world championships); ISOG (International Satellite Operations Group), dealing with satellite contribution circuit issues. Besides the WBU, other specialized broadcasting associations represent specific radio interests, such as the already mentioned AMARC and AER.

According to the AGB, "organized" implies that there is at least one entity mainly dedicated to the community, with documented evidence of community activities." As described above, there is no entity(ies) that represents all of the radio member categories outlined by the applicant. An "organized" community is one that is represented by at least one entity that encompasses the entire community as defined by the applicant. For example, there should be at least one entity that encompasses and organizes: "radio broadcasters, the associations, federations and unions they have created, radio professionals, Internet radios, podcasters, amateur radio (and their clubs), and companies providing specific services or products to the Radio industry." Based on information provided in the application. Therefore, as there is no entity that is mainly dedicated to the community as defined in the .RADIO application, as the Panel has determined, there cannot be documented evidence of community activities.

The Community Priority Evaluation panel determined that the community as defined in the application does not satisfy either of the two conditions to fulfill the requirements for organization.

#### Pre-existence

To fulfill the requirements for pre-existence, the community must have been active prior to September 2007 (when the new gTLD policy recommendations were completed).

The community as defined in the application was active prior to September 2007. Radio broadcast technologies have existed in one form or another for nearly a century. As the industry has evolved<sup>2</sup> through the uptake of new technologies, so too has industry membership. For example, in the early years of the industry, members of the radio industry included radio professionals, broadcasters and companies providing products to the industry, amongst others. With the advent of the internet and other radio technologies, the community has expanded to include Internet radios, podcasters and others. The Panel acknowledges that not all elements of the community defined in the application have been in existence since the dawn of the industry; however, the proposed community segments have been active prior to September 2007.

The Community Priority Evaluation panel determined that the community as defined in the application fulfills the requirements for Pre-existence.

#### 1-B Extension

2/2 Point(s)

The Community Priority Evaluation panel determined that the community as identified in the application met the criterion for Extension specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the application demonstrates considerable size and longevity for the community. The application received a maximum score of 2 points under criterion 1-B: Extension.

#### <u>Size</u>

Two conditions must be met to fulfill the requirements for size: the community must be of considerable size, and it must display an awareness and recognition of a community among its members.

The community as defined in the application is of a considerable size. The community for .RADIO as defined in the application is large in terms of the number of members. According to the application:

Currently, there are about 50,000 radio stations worldwide, according to the figure published by CIA World Facts on their website. In addition, there are at least another 50,000 web radios.

Moreover, the community as defined in the application has awareness and recognition among its members. This is because the community as defined consists of entities and individuals that are in the radio industry<sup>3</sup>, and as participants in this clearly defined industry, they have an awareness and recognition of their inclusion in the industry community.

The Community Priority Evaluation panel determined that the community as defined in the application satisfies both the conditions to fulfill the requirements for Size.

#### Longevity

Two conditions must be met to fulfill the requirements for longevity: the community must demonstrate longevity and it must display an awareness and recognition of a community among its members.

The community as defined in the application demonstrates longevity. The pursuits of the .RADIO community are of a lasting, non-transient nature. Radio services have, as noted, existed for more than a century and are likely to continue, although technological advances may change form and function.

Moreover, as mentioned previously, the community as defined in the application has awareness and recognition among its members. This is because the community as defined consists of entities and individuals that are in the radio industry<sup>4</sup>, and as participants in this clearly defined industry, they have an awareness and recognition of their inclusion in the industry community.

The Community Priority Evaluation panel determined that the community as defined in the application satisfies both the conditions to fulfill the requirements for Longevity.

Criterion #2: Nexus between Proposed String and Community	3/4 Point(s)
2-A Nexus	2/3 Point(s)

The Community Priority Evaluation panel determined that the application partially met the criterion for Nexus as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook. The string "identifies" the name of the community as defined in the application, without over-reaching substantially beyond the community, but it does not "match" the name of the community as defined. The application received a score of 2 out of 3 points under criterion 2-A: Nexus.

To receive the maximum score for Nexus, the applied-for string must "match" the name of the community or be a well-known short-form or abbreviation of the community name. To receive a partial score for Nexus, the applied-for string must "identify" the community. "Identify" means that the applied-for string should closely describe the community or the community members, without over-reaching substantially beyond the community.

The applied-for string (.RADIO) identifies the name of the community. According to the applicant:

Radio means the operators, services and technologies defined here as the Radio community. Radio also means, and is, audio broadcasting. The station broadcasting or streaming that audio content is radio, and the company performing the audio broadcasting is radio. A radio is the receiver used by the listener. Radio is the name everybody uses to refer to the entire industry, and the whole community.

With the advent of streaming via the Internet and the continuous delivery of audio content to broad groups of listeners, we now often refer to the new services as web, net or Internet radio.

The Radio community could not find any other name, even vaguely appropriate, to designate the TLD for its community. .radio is the TLD for the Radio community and could not be anything else. It is perfectly tuned.

The string closely describes the community, without overreaching substantially beyond the community. The string identifies the name of the core community members (i.e. licensed professional and amateur radio broadcasters and their associated unions and clubs, and Internet radio). However, the community, as defined in the application, also includes some entities that are only tangentially related to radio, such as companies providing specific services or products to radio broadcasting organizations and which may not be automatically associated with the gTLD string. For example, network interface equipment and software providers to the industry, based on the Panel's research, would not likely be associated with the word RADIO<sup>5</sup>. However, these entities are considered to comprise only a small part of the community. Since only a small part of the community as defined by the applicant extends beyond the reference of the string, it is not a substantial over-reach. Therefore, the string identifies the community, as the public will generally associate the string with the community as defined by the applicant.

The Community Priority Evaluation panel determined that the applied-for string identifies the name of the community as defined in the application. It therefore partially meets the requirements for Nexus.

#### 2-B Uniqueness

#### 1/1 Point(s)

The Community Priority Evaluation panel determined that the application met the criterion for Uniqueness as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the string has no other significant meaning beyond identifying the community described in the application. The application received a maximum score of 1 point under criterion 2-B: Uniqueness.

To fulfill the requirements for Uniqueness, the string must have no other significant meaning beyond identifying the community described in the application. The string as defined in the application demonstrates uniqueness, as the string does not have any other meaning beyond identifying the community described in the application. The Community Priority Evaluation panel determined that the applied-for string satisfies the condition to fulfill the requirements for Uniqueness.

The Community Priority Evaluation panel determined that the application met the criterion for Eligibility as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as eligibility

is restricted to community members. The application received a maximum score of 1 point under criterion 3-A: Eligibility.

To fulfill the requirements for Eligibility, the registration policies must restrict the eligibility of prospective registrants to community members. The application demonstrates adherence to this requirement by restricting eligibility to the community categories mentioned in Delineation, and additionally requiring that the registered domain name be "accepted as legitimate; and beneficial to the cause and values of the radio industry; and commensurate with the role and importance of the registered domain name; and in good faith at the time of registration and thereafter." (Comprehensive details are provided in Section 20e of the applicant documentation). The Community Priority Evaluation panel determined that the application satisfies the condition to fulfill the requirements for Eligibility.

3-B Name Selection

The Community Priority Evaluation panel determined that the application met the criterion for Name Selection as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as name selection rules are consistent with the articulated community-based purpose of the applied-for TLD. The application received a maximum score of 1 point under criterion 3-B: Name Selection.

To fulfill the requirements for Name Selection, the registration policies for name selection for registrants must be consistent with the articulated, community-based purpose of the applied-for gTLD. The application demonstrates adherence to this requirement by specifying that the registrant's nexus with the radio community and use of the domain must be commensurate with the role of the registered domain, and with the role and importance of the domain name based on the meaning an average user would reasonably assume in the context of the domain name. (Comprehensive details are provided in Section 20e of the applicant documentation). The Community Priority Evaluation panel determined that the application satisfies the condition to fulfill the requirements for Name Selection.

3-C Content and Use

The Community Priority Evaluation panel determined that the application met the criterion for Content and Use as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the rules for content and use are consistent with the articulated community-based purpose of the applied-for TLD. The application received a maximum score of 1 point under criterion 3-C: Content and Use. To fulfill the requirements for Content and Use, the registration policies must include rules for content and use for registrants that are consistent with the articulated community-based purpose of the applied-for gTLD. The application demonstrates adherence to this requirement by specifying that use of the domain name must be beneficial to the cause and values of the radio industry, and commensurate with the role and importance of the registered domain name, etc. (Comprehensive details are provided in Section 20e of the applicant documentation). The Community Priority Evaluation panel determined that the application satisfies the condition to fulfill the requirements for Content and Use.

#### 3-D Enforcement

The Community Priority Evaluation panel determined that the application met the criterion for Enforcement as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the application provided specific enforcement measures as well as appropriate appeal mechanisms. The application received a maximum score of 1 point under criterion 3-D: Enforcement.

Two conditions must be met to fulfill the requirements for Enforcement: the registration policies must include specific enforcement measures constituting a coherent set, and there must be appropriate appeals mechanisms. The applicant outlined policies that include specific enforcement measures constituting a coherent set. The enforcement program is based on random checks, and if the content or use of an existing domain name shows bad faith, it will be suspended. There is also an appeals mechanism, which is managed in

the first instance by the registry, with appeals heard by an independent, alternative dispute resolution provider. (Comprehensive details are provided in Section 20e of the applicant documentation). The Community Priority Evaluation panel determined that the application satisfies both conditions to fulfill the requirements for Enforcement.

#### Criterion #4: Community Endorsement

#### 4-A Support

#### 4/4 Point(s) 2/2 Point(s)

The Community Priority Evaluation panel determined that the application fully met the criterion for Support specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the applicant had documented support from the recognized community institution(s)/member organization(s). The application received a maximum score of 2 points under criterion 4-A: Support.

To receive the maximum score for Support, the applicant is, or has documented support from, the recognized community institution(s)/member organization(s), or has otherwise documented authority to represent the community. "Recognized" means those institution(s)/organization(s) that, through membership or otherwise, are clearly recognized by the community members as representative of the community. To receive a partial score for Support, the applicant must have documented support from at least one group with relevance. "Relevance" refers to the communities explicitly and implicitly addressed.

The Community Priority Evaluation panel determined that the applicant was not the recognized community institution(s)/member organization(s). However, the applicant possesses documented support from institutions/organizations representing a majority of the community addressed, and this documentation contained a description of the process and rationale used in arriving at the expression of support. The applicant received support from a broad range of recognized community institutions/member organizations, which represented different segments of the community as defined by the applicant. These entities represented a majority of the overall community. The Community Priority Evaluation Panel determined that the applicant fully satisfies the requirements for Support.

#### 4-B Opposition

#### 2/2 Point(s)

The Community Priority Evaluation panel determined that the application met the criterion for Opposition specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the application did not receive any relevant opposition. The application received the maximum score of 2 points under criterion 4-B: Opposition.

To receive the maximum score for Opposition, the application must not have received any opposition of relevance. To receive a partial score for Opposition, the application must have received opposition from, at most, one group of non-negligible size.

The application received letters of opposition, which were determined not to be relevant, as they were (1) from individuals or groups of negligible size, or (2) were not from communities either explicitly mentioned in the application nor from those with an implicit association to such communities. The Community Priority Evaluation Panel determined that the applicant satisfies the requirements for Opposition.

#### .RADIO Community Priority Evaluation for Application ID 1-1083-39123 Request under ICANN's Documentary Information Disclosure Policy

This request is submitted under ICANN's Documentary Information Disclosure Policy on behalf of Afilias Limited, BRS Media Inc., and Tin Dale, LLC, applicants for the .RADIO gTLD (hereinafter referred to as "Requesters")<sup>1</sup> in relation to ICANN's Community Priority Evaluation panel's determination that the European Broadcasting Union's application for the .RADIO gTLD (application ID 1-1083-39123; hereinafter referred to as the "Application") has prevailed in Community Priority Evaluation (hereinafter: the "Determination").

#### Context

Reference is made to the Community Evaluation Report that has been released by ICANN and published on the ICANN website under URL <a href="https://www.icann.org/sites/default/files/tlds/radio/radio-cpe-1-1083-39123-en.pdf">https://www.icann.org/sites/default/files/tlds/radio/radio-cpe-1-1083-39123-en.pdf</a>.

According to this Report: *"[t]he Community Priority Evalation panel determined that the application met the requirements specified in the Applicant Guidebook"*, confirming that the application for the .RADIO gTLD that has been submitted by the European Broadcasting Union (hereinafter referred to as "EBU") has *"prevailed in Community Priority Evaluation"*.

Considering the fact that, according to the processes and procedures set out in ICANN's Applicant Guidebook, this Determination would result in ICANN (i) awarding the .RADIO gTLD to the EBU, and – hence – (ii) not allowing the Requesters to proceed with their respective applications, this decision materially impacts the applications submitted by the latter parties.

According to ICANN, "ICANN's Documentary Information Disclosure Policy (DIDP) is intended to ensure that information contained in documents concerning ICANN's operational activities, and within ICANN's possession, custody, or control, is made available to the public unless there is a compelling reason for confidentiality."<sup>2</sup>

#### Request

In view of transparency of ICANN's decision-making process, the Requesters would like to obtain the following information from ICANN under the Documentary Information Disclosure Policy:

- 1) the agreement(s) between ICANN and the organizations and individuals involved in the Community Priority Evaluation, in particular the representations and warranties given and quality standards to be applied by such organizations and individuals;
- 2) policies, guidelines, directives, instructions or guidance given by ICANN relating to the Community Priority Evaluation process;
- 3) internal reports, notes, meeting minutes drawn up by or on behalf of ICANN, the Community Priority Panels, and other individuals or organizations involved in the Community Priority Evaluation in relation to the Application;
- 4) detailed information in relation to (i) the information reviewed, (ii) criteria and standards used, (iii) arguments exchanged, (iv) information disregarded or considered irrelevant, and (v) scores given by the Community Priority Evaluation panel in view of the criteria set out in the Applicant Guidebook, and more in particular:

#### I. In relation to the criterion "Delineation":

a. According to the Determination, the community defined in the Application is as follows:

The Radio industry is composed of a huge number of very diverse radio broadcasters: public and private; international and local; commercial or community-oriented; general purpose, or sector-specific; talk or music; big and small. All licensed radio broadcasters are part of the .radio community, and so are the associations, federations and unions they have created (such as the EBU, applicant for the .radio TLD with the support of its sister Unions; see below for more details on Radio industry representativeness). Also included are the radio professionals, those making radio the fundamental communications tool that it is.

However, the Radio industry keeps evolving and today, many stations are not only broadcasting in the traditional sense, but also webcasting and streaming their audio content via the Internet. Some are not broadcasters in the traditional sense: Internet radios are also part of the Radio community, and as such will be acknowledged by .radio TLD, as will podcasters. In all cases certain minimum standards on streaming or updating schedules will apply.

The .radio community also comprises the often overlooked amateur radio, which uses radio frequencies for communications to small circles of the public. Licensed radio amateurs and their clubs will also be part of the .radio community.



Finally, the community includes a variety of companies providing specific services or products to the Radio industry.

b. The community definition contained in the Application refers to the definition of the "radio industry" as included in the North American Industrial Classification System (NAICS). This definition reads as follows:

"Establishments primarily engaged in broadcasting aural programs by radio to the public. Included in this industry are commercial, religious, educational, and other radio stations. Also included here are establishments primarily engaged in radio broadcasting and which produce radio program materials."<sup>3</sup>

Key elements in this definition include:

- Criterion 1: members of the radio industry are *"establishments"* and *"radio stations"*;
- Criterion 2: they are "primarily engaged in radio broadcasting"; and
- Criterion 3: they "produce radio program materials".
- c. Requesters would like to obtain further information on the reasons for acknowledging that certain "members" of the "radio community" listed by the Applicant, such as "radio professionals", "licensed radio amateurs" and "podcasters" meet Criterion 1 set out above;
- d. Requesters would like to obtain further information on the reasons for acknowledging that certain "individuals that are in the radio industry" to which the Determination refers, even expressly referencing the NAICS definition in the footnote immediately thereafter, meet Criterion 1 set out above, as an individual cannot be considered an "establishment" nor a "radio station";
- e. Requesters would like to obtain further information on the reasons for acknowledging that certain "members" of the "radio community" listed by the Applicant, such as "podcasters" meet Criterion 2 set out above;
- f. It is not clear to Requesters how the concept of "a variety of companies" rhymes with the concept of a "clear and straightforward membership that is well-defined". Therefore, Requesters would like to obtain further information on the criteria used by and the determinations made by ICANN and the Community Priority Evaluation panel in this respect.

Furthermore, Requesters would like to obtain further information on the reasons for acknowledging that certain that "a variety of companies providing specific services or products to the Radio industry" meet Criteria 1, 2 or 3 set out above, considering the fact that the wording "variety of companies" and "specific services or products" are obviously much broader than the criteria set forth in the NAICS definition.

This is more in particular the case when these companies are rendering "specific" services or products, without expressly mentioning what these are, or what the criteria are for these services or products to be "specific". Therefore, Requesters would like to obtain further information on the

criteria used by and the determinations made by ICANN and the Community Priority Evaluation panel in view of these criteria;

g. Requesters would like to obtain further information on the criteria used by and the determinations made by ICANN and the Community Priority Evaluation panel for acknowledging that only companies "providing specific services or products to the Radio industry", etc. can be considered members of a community that "shows a clear and straightforward membership, and is therefore well-defined".

Requesters are unaware of any specific membership criteria that would apply to "radio professionals", "licensed radio amateurs", "podcasters", and "a wide variety of companies providing specific services or products to the Radio industry", apart from the fact that these individuals or organisations have some affinity with the medium "radio". For instance, under the Community Evaluation Panel's assessment, every employee of a radio company or station can register a .radio domain name, even if such employee's actual professional activities are unrelated to the radio medium as such.

h. Insofar and to the extent these products and services are specific to the "radio industry", it is not clear to the Requesters how, on the one hand, the reference made in the Application that the so-called "radio community" includes a "wide variety of members", including "radio-related providers that can be identified through trademarks", and "radio industry partners and providers" whereas, according to the NAICS definition, the membership to the radio industry is much more narrow considering the three criteria set out above.

Based on this, Requesters would like to obtain further information on the criteria used by and the determinations made by ICANN and the Community Priority Evaluation panel in view of these criteria.

 It is commonly known that various companies are offering "Internet radio software" to Internet users, enabling them to operate an Internet radio and stream live audio instantly over the Internet. Considering the fact that – according to the Application – Internet radios are also "part of the Radio community", it is obvious that including any person or entity who sets up a "plug and play" Internet radio system in a few minutes cannot be considered meeting the requirements of a clear and straightforward membership that is well defined.

Given this, Requesters would like to obtain further information on the criteria used by and the determinations made by ICANN and the Community Priority Evaluation panel in view of this criterion, as well as in view of Criteria 1 ("establishments and radio stations") and 2 ("broadcasting").

In the Application, the EBU states that in order to qualify, "Internet radios need to meet certain minimum standards" without being specific on what these standards are and how the EBU is going to verify whether these standards are met.

j. In the Determination, ICANN and the Community Priority Evaluation panel acknowledge – and in the opinion of the Requesters rightfully so – that the



community invoked by the EBU in the Application does not meet the requirements of "Organization". According to the Determination:

"Based on the information provided in the application materials and the Panel's research, there is no such entity that organizes the community defined in the application. Therefore, as there is no entity that is mainly dedicated to the community as defined in the .RADIO application, as the Panel has determined, there cannot be documented evidence of community activities".<sup>4</sup>

In light of this Determination, there is a clear contradiction with the Determination provided under the Delineation criterion, where ICANN and the Community Priority Evaluation panel have found that the "membership in the (industry) community is sufficiently structured as the requirements listed in the community definition above show.

Based on this, Requesters would like to obtain further information on the criteria and arguments used and provided for accepting that the community is on the one hand *insufficiently organized*, but on the other hand is found to be *"sufficiently structured"*.

#### II. In relation to the criteria "Nexus" and "Uniqueness":

According to the Determination:

"The Community Priority Evaluation panel determined that the application met the criterion for Uniqueness as specified in section 4.2.3 (Community Priority Evaluation Criteria) of the Applicant Guidebook, as the string has no other significant meaning beyond identifying the community described in the application.

[...]

To fulfill the requirements for Uniqueness, the string must have no other significant meaning beyond identifying the community described in the application. The string as defined in the application demonstrates uniqueness, as the string does not have any other meaning beyond identifying the community described in the application."

A simple search on Wikipedia shows that the word "radio" extends far beyond the narrow concept as described in the application, and in particular in the description provided in the NAICS' "radio industry" definition, as the term "radio" also covers additional uses of the "radiation of electromagnetic signals through the atmosphere or free space", such as:

- Telephony;
- Video;
- Navigation (used in, *e.g.*, sattellite navigation systems, such as GPS);
- Radar;
- Heating (used in, *e.g.*, microwaves and induction furnaces); and
- Radio control.<sup>5</sup>

Furthermore, Requesters point out to the fact that manufacturers of radio transmitters or receivers – both critical elements and tools in order to be able to send and receive broadcasted radio programs – have to be added to this list, and do not form part of the definition of the NAICS definition since they do not meet Criteria 2 and 3 ...

Considering the above, the Requesters would like to obtain further insights in the information reviewed and arguments developed by the Community Priority Evaluation panel in its determination that:

- a) the applied-for string *identifies* the name of the community as defined in the application, or *closely describes* such community, considering the above elements;
- b) why the other uses and meanings of the word "radio" have been disregarded by the Community Priority Evaluation panel, especially since the uses and meanings listed above are unrelated to any of the activities carried out by the EBU and the organizations supporting the Application;
- c) why the other uses and meanings of the word "radio" have been disregarded, by determining that the meaning of the word "radio" is unique (which, on the basis of the information that can be easily retrieved on a commonly known website such as Wikipedia, is obviously not the case).

#### III. Registration Policies – Eligibility; Name Selection; Content and Use; Enforcement

The Community Priority Evaluation panel has determined that "[...] the application demonstrates adherence to this requirement by restricting eligibility to the community categories mentioned in Delineation, and additionally requiring the the registered domain name be "accepted as legitimate, and beneficial to the cause and value of the radio industry; and commensurate with the role and importance of the registered domain name; and in good faith at the time of registration and thereafter.""

Considering the fact that Requesters have requested further clarifications and information on the information and criteria used by the Community Priority Evaluation panel in § I. above, it is unclear which standards and criteria are going to be used, implemented and enforced by the EBU in view of ensuring that only members of the "radio community" or "radio industry" can register domain names.

Especially since Requesters have established that, on the basis of the criteria set out in the Application, anyone with some affinity with the concept "radio" are considered by the EBU and the Community Evaluation Panel as members of the "radio community", Requesters would like to obtain the information and arguments used by this panel in determining that the criteria for eligibility are satisfied, even when disregarding parties who are active in other, albeit adjacent industries, such as the video, radar, navigation, and heating industry, as well as manufacturers of radio transmitters and receivers.

Furthermore, since the standard propagated by the EBU in relation to name selection is that *"the domain name must be commensurate with the role of the registered domain, and with the role and importance of the domain name based on the meaning an average user would reasonably assume in the context of the domain name"*, Requesters would like to obtain the information, arguments, and the application thereof in concrete use cases they have developed on the basis of the information contained in the Application in order to determine that the *"registration policies for name selection for registrants must be consistent with the* 



*articulated, community-based purpose of the applied-for gTLD",* especially since Requesters do not understand what the EBU means by:

- a) "the domain name must be commensurate with the role of the registered domain";
- b) "the domain name must be commensurate with [...] the role and importance of the domain name":
- c) the criteria the "meaning" of the domain name, "average user", and such average user's "reasonable assumption",

and the standards and criteria used by ICANN and the Community Priority Evaluation panel in establishing that – on the basis of these requirements – names can be excluded from registration because they have no connection with the so-called "radio community", and how these vague requirements can possibly be enforced against the registrant.

The same question arises in relation to the standards and criteria applied by the EBU and evaluated positively by ICANN and the Community Priority Evaluation panel in terms of the "Contents and Use" criterion.

#### IV. In relation to the criterion "Community Endorsement":

The Community Priority Evaluation panel determined that the EBU "*was not the recognized community institution(s)/member organization(s)*", which is a view that is supported by the Requesters.

However, the Community Priority Evaluation panel has determined that the EBU "[...] possesses documented support from institutions / organizations representing a majority of the community addressed."

Requesters therefore would like to obtain further information concerning the information on which such determination was based, especially in determining that the letters of support were submitted by institutions / organizations representing a *majority* of the community addressed. (emphasis added)

Furthermore, Requesters would like to obtain further information about the institutions / organizations who – in the Community Priority Evaluation panel's view also form part of the "radio community", but who have not supported the Application.

#### V. In relation to the criterion "Opposition":

Requesters would like to obtain further information as to the reasons why and the criteria against which the public comments, submitted by or on behalf of the Requesters to ICANN in relation to the Application, which all contained strong opposition against ICANN awarding the .RADIO gTLD to the Applicant have obviously been considered "of no relevance" or that each of the Requesters is to be considered as a "group of negligible size".

The outcome of the Community Priority Evaluation is particularly surprising, considering the fact that one of the Requesters, BRS Media Inc., is the registry for the .FM TLD, which is serving many domain name registrants relating to radio.



#### **Standards for Disclosure**

Requesters are of the opinion that none of the information requested by them meet any of the defined conditions for non-disclosure as set out in ICANN's Documentary Information Disclosure Policy:

- Information provided by or to a government or international organization, or any form of recitation of such information, in the expectation that the information will be kept confidential and/or would or likely would materially prejudice ICANN's relationship with that party.

Considering the nature and contents of Requesters' requests, this standard is not met.

- Internal information that, if disclosed, would or would be likely to compromise the integrity of ICANN's deliberative and decision-making process by inhibiting the candid exchange of ideas and communications, including internal documents, memoranda, and other similar communications to or from ICANN Directors, ICANN Directors' Advisors, ICANN staff, ICANN consultants, ICANN contractors, and ICANN agents.

Considering the nature and contents of Requesters' requests, this standard is not met. Since these requests are made in view of assessing Requesters' respective positions and (legal) actions in relation to ICANN potentially awarding the .RADIO gTLD to the EBU, and considering the impact such award may have upon Requesters, they believe that it is essential for ICANN to provide supplemental information and motivations for its determination to give the Application a passing score in the context of Community Priority Evalation.

- Information exchanged, prepared for, or derived from the deliberative and decision-making process between ICANN, its constituents, and/or other entities with which ICANN cooperates that, if disclosed, would or would be likely to compromise the integrity of the deliberative and decision-making process between and among ICANN, its constituents, and/or other entities with which ICANN cooperates by inhibiting the candid exchange of ideas and communications.

Considering the nature and contents of Requesters' requests, this standard is not met. Since these requests are made in view of assessing Requesters' respective positions and (legal) actions in relation to ICANN potentially awarding the .RADIO gTLD to the EBU, and considering the impact such award may have upon Requesters, they believe that it is essential for ICANN to provide supplemental information and motivations for its determination to give the Application a passing score in the context of Community Priority Evalation.

- Personnel, medical, contractual, remuneration, and similar records relating to an individual's personal information, when the disclosure of such information would or likely would constitute an invasion of personal privacy, as well as proceedings of internal appeal mechanisms and investigations.

Requesters believe that this condition does not apply in relation to this request.



Information provided to ICANN by a party that, if disclosed, would or would be likely to materially prejudice the commercial interests, financial interests, and/or competitive position of such party or was provided to ICANN pursuant to a nondisclosure agreement or nondisclosure provision within an agreement.

Requesters believe that this condition does not apply in relation to this request.

- Confidential business information and/or internal policies and procedures.

Requesters believe that this condition does not apply in relation to this request.

- Information that, if disclosed, would or would be likely to endanger the life, health, or safety of any individual or materially prejudice the administration of justice.

Requesters believe that this condition does not apply in relation to this request.

- Information subject to the attorney– client, attorney work product privilege, or any other applicable privilege, or disclosure of which might prejudice any internal, governmental, or legal investigation.

Requesters believe that this condition does not apply in relation to this request.

- Drafts of all correspondence, reports, documents, agreements, contracts, emails, or any other forms of communication.
  - Requesters believe that this condition does not apply in relation to this request. The Requesters' requests relate to the information, final criteria, standards, arguments and considerations used in view of drafting a determination that lacks clarity and is insufficiently motivated.
- Information that relates in any way to the security and stability of the Internet, including the operation of the L Root or any changes, modifications, or additions to the root zone.

Requesters believe that this condition does not apply in relation to this request.

- Trade secrets and commercial and financial information not publicly disclosed by ICANN.

Requesters believe that this condition does not apply in relation to this request.

- Information requests: (i) which are not reasonable; (ii) which are excessive or overly burdensome; (iii) complying with which is not feasible; or (iv) are made with an abusive or vexatious purpose or by a vexatious or querulous individual.

As stated above, considering the impact of ICANN awarding the .RADIO gTLD may have upon Requesters, they believe that it is essential for ICANN to provide supplemental information and motivations for its determination to give the Application a passing score in the context of Community Priority Evalation.

ICANN's transparency obligations, created by ICANN's Bylaws and Articles of Incorporation require the publication of information related to the process, facts and analysis used by



individual members of the Community Priority Evaluation panel in preparation of the Determination.

Bylaw Article III, Section 1 provides as follows:

"ICANN and its constituent bodies shall operate to the maximum extent feasible in an open and transparent manner and consistent with procedures designed to use fairness."

Furthermore, Requesters refer to ICANN's core mission and values, set out in their by-laws, and in particular, they intend to review the information provided and to be provided by ICANN following this request on the basis of the following values of ICANN:

7. Employing open and transparent policy development mechanisms that (i) promote well-informed decisions based on expert advice, and (ii) ensure that those entities most affected can assist in the policy development process.

8. Making decisions by applying documented policies neutrally and objectively, with integrity and fairness.

And

10. Remaining accountable to the Internet community through mechanisms that enhance ICANN's effectiveness.

Furthermore, Article 4 of ICANN's Articles of Incorporation provides:

"The Corporation shall operate for the benefit of the Internet community as a whole, carrying out its activities in conformity with relevant principles of international law and applicable international conventions and local law and, to the extent appropriate and consistent with these Articles and its Bylaws, through open and transparent processes that enable open competition and open entry in Internet-related markets. To this effect, the Corporation shall cooperate as appropriate with relevant international organizations."

Considering the potentially irreparable harm that will be done if ICANN would not take into account the position taken by the Requesters as legitimate competitors for the .RADIO gTLD, we respectfully request ICANN to disclose the additional information, criteria, and standards set out above, which have formed the basis of the Determination.

Thank you for your Request for Information dated 26 September 2014 (the "Request"), which was submitted through the Internet Corporation for Assigned Names and Numbers' ("ICANN's") Documentary Information Disclosure Policy ("DIDP"). For reference, a copy of your Request is attached to the email forwarding this Response.

#### **Items Requested:**

Your Request seeks the following:

- the agreement(s) between ICANN and the organizations and individuals involved in the Community Priority Evaluation, in particular the representations and warranties given and quality standards to be applied by such organizations and individuals;
- (2) policies, guidelines, directives, instructions or guidance given by ICANN relating to the Community Priority Evaluation process;
- (3) internal reports, notes, meeting minutes drawn up by or on behalf of ICANN, the Community Priority Panels, and other individuals or organizations involved in the Community Priority Evaluation in relation to the Application [for .RADIO that prevailed in the CPE];
- (4) detailed information in relation to (i) the information reviewed, (ii) criteria and standards used, (iii) arguments exchanged, (iv) information disregarded or considered irrelevant, and (v) scores given by the Community Evaluation panel in view of the criteria set out in the Applicant Guidebook, and more in particular: [relating to the panel's determination of each individual criterion].

#### Response

Community Priority Evaluations ("CPE") are performed by an independent community panel that is coordinated by the Economist Intelligent Unit ("EIU"), an independent, third-party company that contracts with ICANN to perform that coordination role. The CPE standards set forth in Section 4.2 of the Applicant Guidebook ("Guidebook") are available at <a href="http://newgtlds.icann.org/en/applicants/agb">http://newgtlds.icann.org/en/applicants/agb</a>. The CPE Panel Process Document (at <a href="http://newgtlds.icann.org/en/applicants/cpe">http://newgtlds.icann.org/en/applicants/agb</a>. The CPE Guidelines (at <a href="http://newgtlds.icann.org/en/applicants/cpe">http://newgtlds.icann.org/en/applicants/agb</a>. The CPE Guidelines (at <a href="http://newgtlds.icann.org/en/applicants/cpe">http://newgtlds.icann.org/en/applicants/agb</a>. The CPE Guidelines (at <a href="http://newgtlds.icann.org/en/applicants/cpe">http://newgtlds.icann.org/en/applicants/cpe</a>) provide more information on the CPE process. The Guidebook, CPE Panel Process Document, and the CPE Guidelines set forth the guidelines, procedures, standards and criteria applied to CPEs, and make clear

that the EIU and its designated panelists are the only persons or entities involved in the provision of CPEs.

For item 1, there is a single contract at issue, the contract between ICANN and the EIU for the coordination of the independent community panels to perform CPEs in the New gTLD Program. ICANN does not contract with individuals to perform CPEs. The contract between ICANN and the EIU is not appropriate for public disclosure through the DIDP. The contract includes a confidentiality clause barring ICANN from disclosing the agreement as requested. The following Defined Conditions for Nondisclosure apply to the requested contract:

- Internal information that, if disclosed, would or would be likely to compromise the integrity of ICANN's deliberative and decision-making process by inhibiting the candid exchange of ideas and communications, including internal documents, memoranda, and other similar communications to or from ICANN Directors, ICANN Directors' Advisors, ICANN staff, ICANN consultants, ICANN contractors, and ICANN agents.
- Information provided to ICANN by a party that, if disclosed, would or would be likely to materially prejudice the commercial interests, financial interests, and/or competitive position of such party or was provided to ICANN pursuant to a nondisclosure agreement or nondisclosure provision within an agreement.
- Confidential business information and/or internal policies and procedures.

For item 2, seeking "policies, guidelines, directives, instructions or guidance given by ICANN relating to the CPE process," to the extent that this is seeking information external to the types of directives that would be incorporated into a contract, much of that information is already incorporated into the publicly available documents identified above. Similarly, for items 2, 3, and 4, ICANN has previously indicated in response to Request No. 20140804-1 that ICANN has communications with persons at EIU that are not involved in the scoring of a CPE (but otherwise assist in the facilitation of a particular CPE), and identified that those communications are not appropriate for public disclosure.

Items 3 and 4 seek extensive, detailed information regarding the analysis conducted by the CPE Panel in making its determination that the .RADIO application prevailed in the CPE. The CPE Report regarding the European Broadcasting Union's (EBU) application for the .RADIO gTLD is available at

https://www.icann.org/sites/default/files/tlds/radio/radio-cpe-1-1083-39123-en.pdf. For instance, the Requesters seek "internal reports," "detailed information in relation to [...] information disregarded or considered irrelevant," and specific information "on the reasons for" the CPE Panel's determination as to each criterion.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> ICANN is not aware of any "other individuals or organizations" outside of the EIU and the CPE Panel that were "involved in the Community Priority Evaluation" of the EBU's .RADIO application.

To help assure independence of the process and evaluation of CPEs, ICANN (either Board or staff) is not involved with the CPE Panel's evaluation of criteria, scoring decisions, or underlying analyses. The coordination of the CPE Panel, as explained in the CPE Panel Process Document, is entirely within the work of the EIU's team. ICANN does not have, nor does it collect or maintain, the work papers of the individual CPE Panels (including the .RADIO CPE Panel) that would likely contain the information called for within these items. In accordance with the Panel Process Document, there are publicly available documents that are to be included within the CPE review, such as the comments directed to the Community Evaluation Panel on the EBU's .RADIO application by commenters including Donuts (https://gtldcomment.icann.org/commentsfeedback/applicationcomment/commentdetails/12392), Minds + Machines (https://gtldcomment.icann.org/commentsfeedback/applicationcomment/commentdetails/12393) and others identified at the comment collection page https://gtldcomment.icann.org/comments-

feedback/applicationcomment/viewcomments.

As such, to the extent that ICANN has documentation responsive to Items 2, 3 and 4, such documents are either already public or subject to certain of the Defined Conditions for Nondisclosure set forth in the DIDP:

- Internal information that, if disclosed, would or would be likely to compromise the integrity of ICANN's deliberative and decision-making process by inhibiting the candid exchange of ideas and communications, including internal documents, memoranda, and other similar communications to or from ICANN Directors, ICANN Directors' Advisors, ICANN staff, ICANN consultants, ICANN contractors, and ICANN agents.
- Information exchanged, prepared for, or derived from the deliberative and decision-making process between ICANN, its constituents, and/or other entities with which ICANN cooperates that, if disclosed, would or would be likely to compromise the integrity of the deliberative and decision-making process between and among ICANN, its constituents, and/or other entities with which ICANN cooperates by inhibiting the candid exchange of ideas and communications.
- Information provided to ICANN by a party that, if disclosed, would or would be likely to materially prejudice the commercial interests, financial interests, and/or competitive position of such party or was provided to ICANN pursuant to a nondisclosure agreement or nondisclosure provision within an agreement.
- Confidential business information and/or internal policies and procedures.
- Drafts of all correspondence, reports, documents, agreements, contracts, emails, or any other forms of communication.

Although your analysis in the Request concluded that no Conditions for Nondisclosure should apply, ICANN must independently undertake the analysis of each Condition as it

applies to the documentation at issue, and make the final determination as to whether any Nondisclosure Conditions apply. Here, for example, ICANN cannot violate contractual conditions that require ICANN to maintain items as confidential solely because the Request proffers that no such conditions apply. Similarly, ICANN does not release draft documentation – particularly if draft documentation was shared for the purpose of facilitating deliberations or decision making – because drafts are not reliable sources of information regarding what actually occurred or standards that were actually applied.

For each of the items identified above as subject to Defined Conditions of Nondisclosure, ICANN has determined that there are no particular circumstances for which the public interest in disclosing the information outweighs the harm that may be caused to ICANN, its contractual relationships and its contractors' deliberative processes by the requested disclosure.

#### **About DIDP**

ICANN's DIDP is limited to requests for information already in existence within ICANN that is not publicly available. In addition, the DIDP sets forth Defined Conditions of Nondisclosure. # Radio

**Radio** is the radiation (wireless transmission) of electromagnetic signals through the atmosphere or free

space.<sup>[n 1]</sup> Information, such as sound, is carried by systematically changing (modulating) some property of the radiated waves, such as their amplitude, frequency, phase, or pulse width. When radio waves strike an electrical conductor, the oscillating fields induce an alternating current in the conductor. The information in the waves can be extracted and transformed back into its original form.

Radio systems need a transmitter to modulate (change) some property of the energy produced to impress a signal on it. Some types of modulation include amplitude modulation and frequency modulation. Radio

systems also need an antenna to convert electric currents into radio waves, and vice versa. An antenna can be used for both transmitting and receiving. The electrical resonance of tuned circuits in radios allow individual stations to be selected. The electromagnetic wave is intercepted by a tuned receiving antenna. A radio receiver receives its input from an antenna and converts it into a form usable for the consumer, such as

sound, pictures, digital data, measurement values, navigational positions, etc.<sup>[2]</sup> Radio frequencies occupy the range from a 3 kHz to 300 GHz, although commercially important uses of radio use only a small part of this spectrum.<sup>[3]</sup>

A radio communication system sends signals by radio.<sup>[4]</sup> The radio equipment involved in communication systems includes a transmitter and a receiver, each having an antenna and appropriate terminal equipment such as a microphone at the transmitter and a loudspeaker at the receiver in the case of a voice-communication system.<sup>[5]</sup>

## Etymology

The etymology of "radio" or "radiotelegraphy" reveals that it was called "wireless telegraphy", which was shortened to "wireless" in Britain. The prefix *radio-* in the sense of wireless transmission, was first recorded in the word *radioconductor*, a description provided by the French physicist Édouard Branly in 1897. It is based on the verb *to radiate* (in Latin "radius" means "spoke of a wheel, beam of light, ray").

The word "radio" also appears in a 1907 article by Lee De Forest. It was adopted by the United States Navy in 1912, to distinguish radio from several other wireless communication technologies, such as the photophone. The term became common by the time of the first commercial broadcasts in the United States in

the 1920s, and was soon adopted in Europe and Asia. ("Broadcasting" is based upon an agricultural term meaning roughly "scattering seeds widely".) British Commonwealth countries continued to commonly use the term "wireless" until the mid-20th century, though the magazine of the BBC in the UK has been called Radio Times ever since it was first published in the early 1920s.

In recent years the more general term "wireless" has gained renewed popularity through the rapid growth of short-range computer networking, e.g., Wireless Local Area Network (WLAN), Wi-Fi, and Bluetooth, as well as mobile telephony, e.g., GSM and UMTS. Today, the term "radio" specifies the actual type of transceiver device or chip, whereas "wireless" refers to the lack of physical connections; one talks about *radio* transceivers, but another talks about *wireless* devices and *wireless* sensor networks.

## Processes

Radio systems used for communication have the following elements. With more than 100 years of development, each process is implemented by a wide range of methods, specialized for different communications purposes.


## Transmitter and modulation

Each system contains a transmitter. This consists of a source of electrical energy, producing alternating current of a desired frequency of oscillation. The transmitter contains a system to modulate (change) some property of the energy produced to impress a signal on it. This modulation might be as simple as turning the energy on and off, or altering more subtle


properties such as amplitude, frequency, phase, or combinations of these properties. The transmitter sends the modulated electrical energy to a tuned resonant antenna; this structure converts the rapidly changing alternating current into an electromagnetic wave that can move through free space (sometimes with a particular polarization).

Amplitude modulation of a carrier wave works by varying the strength of the transmitted signal in proportion to the information being sent. For example, changes in the signal strength can be used to reflect the sounds to be reproduced by a speaker, or to specify the light intensity of television pixels. It was the method used for the first audio radio transmissions, and remains in use today. "AM" is often used to refer to the medium wave broadcast band (see AM radio).

Frequency modulation varies the frequency of the carrier. The instantaneous frequency of the carrier is directly proportional to the instantaneous value of the input signal. Digital data can be sent by shifting the carrier's frequency among a set of discrete values, a technique known as frequency-shift keying.



Transducing information such as sound into an electromagnetic pulse signal, which is then sent as an electromagnetic radio wave from a transmitter. A receiver intercepts the radio wave and extracts the information-bearing electronic signal, which is converted back using another transducer such as a speaker.



FM is commonly used at VHF radio frequencies for high-fidelity broadcasts of music and speech (see FM broadcasting). Normal (analog) TV sound is also broadcast using FM.

Angle modulation alters the instantaneous phase of the carrier wave to transmit a signal. It is another term for phase modulation.

### Antenna

An *antenna* (or *aerial*) is an electrical device which converts electric currents into radio waves, and vice versa. It is usually used with a radio transmitter or radio receiver. In transmission, a radio transmitter supplies an electric current oscillating at radio frequency (i.e. high frequency AC) to the antenna's terminals, and the antenna radiates the energy from the current as electromagnetic waves (radio waves). In reception, an antenna intercepts some of the power of an electromagnetic wave in order to produce a tiny voltage at its terminals, that is applied to a receiver to be amplified. An antenna can be used for both transmitting and receiving.

## **Propagation**

Once generated, electromagnetic waves travel through space either directly, or have their path altered by reflection, refraction or diffraction. The intensity of the waves diminishes due to geometric dispersion (the inverse-square law); some energy may also be absorbed by the intervening medium in some cases. Noise will generally alter the desired signal; this electromagnetic interference comes from natural sources, as well as from artificial sources

such as other transmitters and accidental radiators. Noise is also produced at every step due to the inherent properties of the devices used. If the magnitude of the noise is large enough, the desired signal will no longer be discernible; this is the fundamental limit to the range of radio communications.

### Resonance

Electrical resonance of tuned circuits in radios allow individual stations to be selected. A resonant circuit will respond strongly to a particular frequency, and much less so to differing frequencies. This allows the radio receiver to discriminate between multiple signals differing in frequency.

### **Receiver and demodulation**

The electromagnetic wave is intercepted by a tuned receiving antenna; this structure captures some of the energy of the wave and returns it to the form of oscillating electrical currents. At the receiver, these currents are demodulated, which is conversion to a usable signal form by a detector sub-system. The receiver is "tuned" to respond preferentially to the desired signals, and reject undesired signals.


Early radio systems relied entirely on the energy collected by an antenna to produce signals for the operator. Radio became more useful after the invention of electronic devices such as the vacuum tube and later the transistor, which made it possible to amplify weak signals. Today radio systems are used for applications from walkie-talkie children's toys to the control of space vehicles, as well as for broadcasting, and many other applications. A radio receiver receives its input from an antenna, uses electronic filters to separate a wanted radio signal from all other signals picked up by this antenna, amplifies it to a level suitable for further processing, and finally converts through demodulation and decoding the signal into a form usable for the consumer, such as sound, pictures, digital data, measurement values,

navigational positions, etc.<sup>[6]</sup>

radiation, with frequencies above the RF range, are infrared, visible light, ultraviolet, X-rays and gamma rays. Since the energy of an individual photon of radio frequency is too low to remove an electron from an atom, radio waves are classified as non-ionizing radiation.

## **Communication systems**

A radio communication system sends signals by radio.<sup>[8]</sup> Types of radio communication systems deployed depend on technology, standards, regulations, radio spectrum allocation, user requirements, service positioning, and investment.<sup>[9]</sup>

The radio equipment involved in communication systems includes a transmitter and a receiver, each having an antenna and appropriate terminal equipment such as a microphone at the transmitter and a loudspeaker at the receiver in the case of a voice-communication system.<sup>[10]</sup>

The power consumed in a transmitting station varies depending on the distance of communication and the transmission conditions. The power received at the receiving station is usually only a tiny fraction of the transmitter's output, since communication depends on receiving the information, not the energy, that was transmitted.

Classical radio communications systems use frequency-division multiplexing (FDM) as a strategy to split up and share the available radio-frequency bandwidth for use by different parties communications concurrently. Modern radio communication systems include those that divide up a radio-frequency band by time-division multiplexing (TDM) and code-division multiplexing (CDM) as alternatives to the classical FDM strategy. These systems offer different tradeoffs in supporting multiple users, beyond the FDM strategy that was ideal for broadcast radio but less so for applications such as mobile telephony.

A radio communication system may send information only one way. For example, in broadcasting a single transmitter sends signals to many receivers. Two stations may take turns sending and receiving, using a single radio frequency; this is called "simplex." By using two radio frequencies, two stations may continuously and concurrently send and receive signals - this is called "duplex" operation.

## History

## **19th century**

The meaning and usage of the word "radio" has developed in parallel with developments within the field of communications and can be seen to have three distinct phases: electromagnetic waves and experimentation; wireless communication and technical development; and radio broadcasting and commercialization. James Clerk Maxwell predicted the propagation of electromagnetic waves (radio waves) (1873) and Heinrich Rudolf Hertz made the first demonstration of transmission of radio waves through free space (1887) but many individuals—inventors, engineers, developers and businessmen constructed systems based on their own understanding of these and other phenomenon, some predating Maxwell and Hertz' discoveries. Thus "wireless telegraphy" and radio wave based systems can be attributed to multiple "inventors". Development from a laboratory demonstration to a commercial entity spanned several decades and required the efforts of many practitioners.

In 1878, David E. Hughes noticed that sparks could be heard in a telephone receiver when experimenting with his carbon microphone. He developed this carbon-based detector further and eventually could detect signals over a few hundred yards. He demonstrated his discovery to the Royal Society in 1880, but was told it was merely induction, and therefore abandoned further research.

Experiments were undertaken by Thomas Edison and his employees of Menlo Park. Edison applied in 1885 to the U.S. Patent Office for a patent on an electrostatic coupling system between elevated terminals. The patent was granted as U.S. Patent 465,971 (https://www.google.com/patents/US465971) on December 29, 1891. The Marconi Company would later purchase rights to the Edison patent to protect them legally from lawsuits.<sup>[11]</sup>

In 1884 Temistocle Calzecchi-Onesti at Fermo in Italy experiments with tubes containing powder and nickel silver with traces of mercury metal filings and their reactions when conducting electricity. This would lead to the development of the iron filings filled coherer, a radio detecting device usually credited to Edouard Branly in 1890.

### Hertzian waves


Between 1886 and 1888 Heinrich Rudolf Hertz publishes the results of his experiments where he was able to transmit electromagnetic waves (radio waves) through the air proving Maxwell's electromagnetic theory.<sup>[12][13]</sup> Early on after their discovery radio waves were referred to as "Hertzian waves".<sup>[14]</sup> Between 1890 and 1892 physicists such as John Perry, Frederick Thomas Trouton and William Crookes proposed electromagnetic or Hertzian waves as a navigation aid or means of communication with Crookes writing on the possibilities of wireless telegraphy based on Hertzian waves in 1892.<sup>[15]</sup>

After learning of Hertz demonstrations of wireless transmission, inventor Nikola Tesla began developing his own system based on Hertz and Maxwell's ideas, primarily as a

means of wireless lighting and power distribution.<sup>[16][17]</sup> Tesla, concluding that Hertz had not demonstrated airborne electromagnetic waves (radio transmission), went on to develop a system based on

what he thought was the primary conductor, the earth.<sup>[18]</sup> In 1893 demonstrations of his ideas, in St. Louis, Missouri and at the *Franklin Institute* in Philadelphia, Tesla proposed this wireless power technology could also incorporate a system for the telecommunication of information.

In a lecture on the work of Hertz, shortly after his death, Professor Oliver Lodge and Alexander Muirhead demonstrated wireless signaling using Hertzian (radio) waves in the lecture theater of the Oxford University Museum of Natural History on August 14, 1894. During the demonstration a radio signal was sent from the neighboring Clarendon laboratory building, and received by apparatus in the lecture theater.



Tesla in his "Experiments with alternate currents of very high frequency and their application to methods of artificial illumination" lecture of 1891. After continued research, Tesla presented his ideas on wireless communication in 1892 and expanded on them in 1893.

Building on the work of Lodge,<sup>[19]</sup> the Indian Bengali physicist Jagadish Chandra Bose ignited gunpowder and rang a bell at a distance using millimeter range wavelength microwaves in a November 1894 public demonstration at Town Hall of Kolkata,. Bose wrote in a Bengali essay, Adrisya Alok (Invisible Light), "The invisible light can easily pass through brick walls, buildings etc. Therefore, messages can be transmitted by means of it without the mediation of wires." Bose's first scientific paper, "On polarisation of electric rays by double-refracting crystals" was communicated to the Asiatic Society of Bengal in May 1895. His second paper was communicated to the Royal Society of London by Lord Rayleigh in October 1895. In December 1895, the London journal the Electrician (Vol. 36) published Bose's paper, "On a new electropolariscope". At that time, the word 'coherer', coined by Lodge, was used in the English-speaking world for Hertzian wave receivers or detectors. The Electrician readily commented on Bose's coherer. (December 1895). The Englishman (18 January 1896) quoted from the Electrician and commented as follows:"Should Professor Bose succeed in perfecting and patenting his 'Coherer', we may in time see the whole system of coast lighting throughout the navigable world revolutionised by an Indian Bengali scientist working single handed in our Presidency College Laboratory." Bose planned to "perfect his coherer" but never thought of patenting it.

In 1895, conducting experiments along the lines of Hertz's research, Alexander Stepanovich Popov built his first radio receiver, which contained a coherer. Further refined as a lightning detector, it was presented to the Russian Physical and Chemical Society on May 7, 1895. A depiction of Popov's lightning detector was printed in the Journal of the Russian Physical and Chemical Society the same year. Until recently, mistakenly believed that it was the first description (publication of the minutes 15/201 of this session —

December issue of the journal RPCS<sup>[20]</sup>), but in fact the first description of the device was given by Dmitry Aleksandrovich Lachinov in July 1895 in the 2nd edition of his course "Fundamentals of Meteorology and climatology" — the first in Russia.<sup>[21][22]</sup> Popov's receiver was created on the improved basis of Lodge's receiver, and originally intended for reproduction of its experiments.

In 1894 the young Italian inventor Guglielmo Marconi began working on the idea of building a commercial wireless telegraphy system based on the use of Hertzian waves (radio waves), a line of

inquiry that he noted other inventors did not seem to be pursuing.<sup>[23]</sup> Marconi read through the literature and used the ideas of others who were experimenting with radio waves but did a great deal to develop devices such as portable transmitters and receiver systems that could work over long distances,<sup>[24]</sup> turning what was essentially a

laboratory experiment into useful communication system.<sup>[25]</sup> By August 1895 Marconi was field testing his system but even with improvements he was only able to transmit signals up to 1/2 mile, a distance Oliver Lodge had predicted in 1894 as the maximum

transmission distance for radio waves. Marconi raised the height of his antenna and hit upon the idea of grounding his transmitter and receiver. With these improvements the system was capable of transmitting signals up to 2 miles (3.2 km) and over hills<sup>[26]</sup> Marconi's experimental apparatus proved to be the first engineering complete, commercially successful radio transmission system.<sup>[27][28][29]</sup> Marconi's apparatus is also credited for saving the 700 people that survived the tragic Titanic disaster.<sup>[30]</sup>

In 1896, Marconi was awarded British patent 12039, *Improvements in transmitting electrical impulses and signals and in apparatus there-for*, the first patent ever issued for a Hertzian wave (radio wave) base wireless telegraphic system.<sup>[31]</sup> In 1897, he established a radio station on the Isle of Wight, England. Marconi opened his "wireless" factory in the former silk-works at Hall Street, Chelmsford, England in 1898, employing around 60 people. Shortly after the 1900s, Marconi held the patent rights for radio. Marconi would go on to win the Nobel Prize in Physics in 1909<sup>[32]</sup> and be more successful than any other inventor in his ability to *commercialize* radio and its associated equipment into a global business.<sup>[24]</sup> In the US some of his subsequent patented refinements (but not his original radio patent) would be overturned in a 1935 court case (upheld by the US Supreme Court in 1943).<sup>[33]</sup>

## 20th century

In 1900, Brazilian priest Roberto Landell de Moura transmitted the human voice wirelessly. According the newspaper *Jornal do Comercio* (June 10, 1900), he conducted his first public experiment on June 3, 1900, in front of journalists and the General Consul of Great Britain, C.P. Lupton, in São Paulo, Brazil, for a distance of approximately 5.0 miles (8 km). The points of transmission and reception were Alto de Santana and Paulista Avenue.<sup>[34]</sup>

One year after that experiment, he received his first patent from the Brazilian government. It was described as "equipment for the purpose of phonetic transmissions through space, land and water elements at a distance with or without the use of wires." Four months later, knowing that his invention had real value, he left Brazil for the United States with the intent of patenting the machine at the US Patent Office in Washington, DC.

Having few resources, he had to rely on friends to push his project. In spite of great difficulty, three patents were awarded: "The Wave Transmitter" (October 11, 1904) which is the precursor of today's radio transceiver; "The Wireless Telephone" and the "Wireless Telegraph", both dated November 22, 1904.

The next advancement was the vacuum tube detector, invented by Westinghouse engineers. On Christmas Eve 1906, Reginald Fessenden used a synchronous rotary-spark transmitter for the first radio program broadcast, from Ocean Bluff-Brant Rock, Massachusetts. Ships at sea heard a broadcast that included Fessenden playing *O Holy Night* on the violin and reading a passage from the Bible.<sup>[35]</sup>

In June 1912 Marconi opened the world's first purpose-built radio factory at New Street Works in Chelmsford, England.

This was, for all intents and purposes, the first transmission of what is now known as amplitude modulation or AM radio. The first radio news program was broadcast August 31, 1920 by station 8MK in Detroit, Michigan, which survives today as all-news format station WWJ under ownership of the CBS network. The first college radio station began broadcasting on October 14, 1920 from Union College, Schenectady, New York under the personal call letters of Wendell

King, an African-American student at the school.<sup>[35]</sup>

That month 2ADD (renamed WRUC in 1947), aired what is believed to be the first public entertainment broadcast in the United States, a


series of Thursday night concerts initially heard within a 100-mile (160 km) radius and later for a 1,000-mile

(1,600 km) radius. In November 1920, it aired the first broadcast of a sporting event.<sup>[35][36]</sup> At 9 pm on August 27, 1920, Sociedad Radio Argentina aired a live performance of Richard Wagner's opera *Parsifal* from the Coliseo Theater in downtown Buenos Aires. Only about twenty homes in the city had receivers to tune in this radio program. Meanwhile, regular entertainment broadcasts commenced in 1922 from the Marconi Research Centre at Writtle, England.

Sports broadcasting began at this time as well, including the college football on radio broadcast of a 1921 West Virginia vs. Pittsburgh football game.<sup>[37]</sup>

One of the first developments in the early 20th century was that aircraft used commercial AM radio stations for navigation. This continued until the early 1960s when VOR systems became widespread.<sup>[38]</sup> In the early 1930s, single sideband and frequency modulation were invented by amateur radio operators. By the end of the decade, they were established commercial modes. Radio was used to transmit pictures visible as television as early as the 1920s. Commercial television transmissions started in North America and Europe in the 1940s.

In 1947 AT&T commercialized the Mobile Telephone Service. From its start in St. Louis in 1946, AT&T then introduced Mobile Telephone Service to one hundred towns and highway corridors by 1948. Mobile Telephone Service was a rarity with only 5,000 customers placing about 30 000 calls each week. Because only three radio channels were available, only three customers in any given city could make mobile telephone calls at one time.<sup>[39]</sup> Mobile Telephone Service was expensive, costing 15 USD per month, plus 0.30 to 0.40 USD per local call, equivalent to about 176 USD per month and 3.50 to 4.75 per call in 2012 USD.<sup>[40]</sup> The Advanced Mobile Phone System analog mobile cell phone system, developed by Bell Labs,

locales) through the 1980s and into the 2000s.

In 1954, the Regency company introduced a pocket transistor radio, the TR-1, powered by a "standard 22.5 V Battery." In 1955, the newly formed Sony company introduced its first transistorized radio.<sup>[44]</sup> It was small enough to fit in a vest pocket, powered by a small battery. It was durable, because it had no vacuum tubes to burn out. Over the next 20 years, transistors replaced tubes almost completely except for high-power transmitters.

By 1963, color television was being broadcast commercially (though not all broadcasts or programs were in color), and the first (radio) communication satellite, *Telstar*, was launched. In the late 1960s, the U.S. long-distance telephone network began to convert to a digital network, employing digital radios for many of its links. In the 1970s, LORAN became the premier radio navigation system.

Soon, the U.S. Navy experimented with satellite navigation, culminating in the launch of the Global Positioning System (GPS) constellation in 1987. In the early 1990s, amateur radio experimenters began to use personal computers with audio cards to process radio signals. In 1994, the U.S. Army and DARPA launched an aggressive, successful project to construct a software-defined radio that can be programmed to be virtually any radio by changing its software program. Digital transmissions began to be applied to broadcasting in the late 1990s.

# Uses of radio

Early uses were maritime, for sending telegraphic messages using Morse code between ships and land. The earliest users included the Japanese Navy scouting the Russian fleet during the Battle of Tsushima in 1905. One of the most memorable uses of marine telegraphy was during the sinking of the RMS *Titanic* in 1912, including communications between operators on the sinking ship and nearby vessels, and communications to shore stations listing the survivors.

Radio was used to pass on orders and communications between armies and navies on both sides in World War I; Germany used radio communications for diplomatic messages once it discovered that its submarine cables had been tapped by the British. The United States passed on President Woodrow Wilson's Fourteen Points to Germany via radio during the war. Broadcasting began from San Jose,

California in 1909,<sup>[45]</sup> and became feasible in the 1920s, with the widespread introduction of radio receivers, particularly in Europe and the United States. Besides broadcasting, point-to-point broadcasting, including telephone messages and relays of radio programs, became widespread in the 1920s and 1930s. Another use of radio in the pre-war years was the development of detection and locating of aircraft and ships by the use of radar (*RA*dio *D*etection *And Ranging*).

Today, radio takes many forms, including wireless networks and mobile communications of all types, as well as radio broadcasting. Before the advent of television, commercial radio broadcasts included not only news and music, but dramas, comedies, variety shows, and many other forms of entertainment (the era from the late 1920s to the mid-1950s is commonly called radio's "Golden Age"). Radio was unique among methods of dramatic presentation in that it used only sound. For more, see radio programming.

#### Audio

AM radio uses amplitude modulation, in which the amplitude of the transmitted signal is made proportional to the sound amplitude captured (transduced) by the microphone, while the transmitted frequency remains unchanged. Transmissions are affected by static and interference because lightning and other sources of radio emissions on the same frequency add their amplitudes to the original transmitted amplitude.

In the early part of the 20th century, American AM radio stations broadcast with powers as high as 500 kW, and some could be heard worldwide; these stations' transmitters were commandeered for military use by the US Government during World War II. Currently, the maximum broadcast power for a civilian AM radio station in the United States and Canada is 50 kW, and the majority of stations that emit signals this powerful were grandfathered in (see List of 50 kW AM radio stations in the United States). In 1986 KTNN received the last granted 50,000 watt license. These 50 kW stations are generally called "clear channel" stations (not to be confused with Clear Channel Communications), because within North America each of these stations has exclusive use of its broadcast frequency throughout part or all of the broadcast day.

FM broadcast radio sends music and voice with less noise than AM radio. It is often mistakenly thought that FM is higher fidelity than AM, but that is not true. AM is capable of the same audio bandwidth that FM employs. AM receivers typically use narrower filters in the receiver to recover the signal with less noise. AM stereo receivers can reproduce the same audio bandwidth that FM does due to the wider filter used in an AM stereo receiver, but today, AM radios limit the audio bandpass to 3–5 kHz. In frequency modulation, amplitude variation at the microphone causes the transmitter frequency to fluctuate. Because the audio signal modulates the frequency and not the amplitude, an FM signal is not subject to static and interference

in the same way as AM signals. Due to its need for a wider bandwidth, FM is transmitted in the Very High Frequency (VHF, 30 MHz to 300 MHz) radio spectrum.

VHF radio waves act more like light, traveling in straight lines; hence the reception range is generally limited to about 50–200 miles (80–322 km). During unusual upper atmospheric conditions, FM signals are occasionally reflected back towards the Earth by the ionosphere, resulting in long distance FM reception.

FM receivers are subject to the capture effect, which causes the radio to only receive the strongest signal when multiple signals appear on the same frequency. FM receivers are relatively immune to lightning and spark interference.

High power is useful in penetrating buildings, diffracting around hills, and refracting in the dense atmosphere near the horizon for some distance beyond the horizon. Consequently, 100,000 watt FM stations can regularly be heard up to 100 miles (160 km) away, and farther, 150 miles (240 km), if there are no competing signals.

A few old, "grandfathered" stations do not conform to these power rules. WBCT-FM (93.7) in Grand Rapids, Michigan, US, runs 320,000 watts ERP, and can increase to 500,000 watts ERP by the terms of its original license. Such a huge power level does not usually help to increase range as much as one might expect, because VHF frequencies travel in nearly straight lines over the horizon and off into space. Nevertheless, when there were fewer FM stations competing, this station could be heard near Bloomington, Illinois, US, almost 300 miles (480 km) away.

FM subcarrier services are secondary signals transmitted in a "piggyback" fashion along with the main program. Special receivers are required to utilize these services. Analog channels may contain alternative programming, such as reading services for the blind, background music or stereo sound signals. In some extremely crowded metropolitan areas, the sub-channel program might be an alternate foreign-language radio program for various ethnic groups. Sub-carriers can also transmit digital data, such as station

identification, the current song's name, web addresses, or stock quotes. In some countries, FM radios automatically re-tune themselves to the same channel in a different district by using sub-bands.

Aviation voice radios use VHF AM. AM is used so that multiple stations on the same channel can be received. (Use of FM would result in stronger stations blocking out reception of weaker stations due to FM's capture effect). Aircraft fly high enough that their transmitters can be received hundreds of miles away, even though they are using VHF.

Marine voice radios can use single sideband voice (SSB) in the shortwave High Frequency (HF—3 MHz to 30 MHz) radio spectrum for very long ranges or narrowband FM in the VHF spectrum for much shorter ranges. Narrowband FM sacrifices fidelity to make more channels available within the radio spectrum, by using a smaller range of radio frequencies, usually with five kHz of deviation, versus the 75 kHz used by commercial FM broadcasts, and 25 kHz used for TV sound.

Government, police, fire and commercial voice services also use narrowband FM on special frequencies. Early police radios used AM receivers to receive one-way dispatches.

Civil and military HF (high frequency) voice services use shortwave radio to contact ships at sea, aircraft and isolated settlements. Most use single sideband voice (SSB), which uses less bandwidth than AM.<sup>[46]</sup> On an AM radio SSB sounds like ducks quacking, or the adults in a

Charlie Brown cartoon. Viewed as a graph of frequency versus power, an AM signal shows power where the frequencies of the voice add and subtract with the main radio frequency. SSB cuts the bandwidth in half by suppressing the carrier and one of the sidebands. This also makes the transmitter about three times more powerful, because it doesn't need to transmit the unused carrier and sideband.

TETRA, Terrestrial Trunked Radio is a digital cell phone system for military, police and ambulances. Commercial services such as XM, WorldSpace and Sirius offer encrypted digital satellite radio.

### Telephony

Mobile phones transmit to a local cell site (transmitter/receiver) that ultimately connects to the public switched telephone network (PSTN) through an optic fiber or microwave radio and other network elements. When the mobile phone nears the edge of the cell site's radio coverage area, the central computer switches the phone to a new cell. Cell phones originally used FM, but now most use various digital modulation schemes. Recent developments in Sweden (such as DROPme) allow for the instant downloading of digital material from a radio broadcast (such as a song) to a mobile phone.

Satellite phones use satellites rather than cell towers to communicate.

#### Video

Analog television sends the picture as AM and the sound as AM or FM, with the sound carrier a fixed frequency (4.5 MHz in the NTSC system) away from the video carrier. Analog television also uses a vestigial sideband on the video carrier to reduce the bandwidth required.

Digital television uses 8VSB modulation in North America (under the ATSC digital television standard), and COFDM modulation elsewhere in the world (using the DVB-T standard). A Reed–Solomon error correction code adds redundant correction codes and allows reliable reception during moderate data loss. Although many current and future codecs can be sent in the MPEG transport stream container format, as of 2006 most systems use a standard-definition format almost identical to DVD: MPEG-2 video in Anamorphic widescreen and MPEG layer 2 (*MP2*) audio. High-definition television is possible simply by using a higher-resolution picture, but H.264/AVC is being considered as a replacement video codec in some regions for its improved compression. With the compression and improved modulation involved, a single "channel" can contain a high-definition program and several standard-definition programs.

#### Navigation

All satellite navigation systems use satellites with precision clocks. The satellite transmits its position, and the time of the transmission. The receiver listens to four satellites, and can figure its position as being on a line that is tangent to a spherical shell around each satellite, determined by the time-of-flight of the radio signals from the satellite. A computer in the receiver does the math.

Radio direction-finding is the oldest form of radio navigation. Before 1960 navigators used movable loop antennas to locate commercial AM stations near cities. In some cases they used marine radiolocation beacons, which share a range of frequencies just above AM radio with amateur radio operators. LORAN systems also used time-of-flight radio signals, but from radio stations on the ground.

Very High Frequency Omnidirectional Range (VOR), systems (used by aircraft), have an antenna array that transmits two signals simultaneously. A directional signal rotates like a lighthouse at a fixed rate. When the directional signal is facing north, an omnidirectional signal pulses. By measuring the difference in phase of these two signals, an aircraft can determine its bearing or radial from the station, thus establishing a line of position. An aircraft can get readings from two VORs and locate its position at the intersection of the two radials, known as a "fix."

When the VOR station is collocated with DME (Distance Measuring Equipment), the aircraft can determine its bearing and range from the station, thus providing a fix from only one ground station. Such stations are called VOR/DMEs. The military operates a similar system of navaids, called TACANs, which are often built into VOR stations. Such stations are called VORTACs. Because TACANs include distance measuring equipment, VOR/DME and VORTAC stations are identical in navigation potential to civil aircraft.

#### Radar

Radar (Radio Detection And Ranging) detects objects at a distance by bouncing radio waves off them. The delay caused by the echo measures the distance. The direction of the beam determines the direction of the reflection. The polarization and frequency of the return can sense the type of surface. Navigational radars scan a wide area two to four times per minute. They use very short waves that reflect from earth and stone. They are common on commercial ships and long-distance commercial aircraft.

General purpose radars generally use navigational radar frequencies, but modulate and polarize the pulse so the receiver can determine the type of surface of the reflector. The best general-purpose radars distinguish the rain of heavy storms, as well as land and vehicles. Some can superimpose sonar data and map data from GPS position.

Search radars scan a wide area with pulses of short radio waves. They usually scan the area two to four times a minute. Sometimes search radars use the Doppler effect to separate moving vehicles from clutter. Targeting radars use the same principle as search radar but scan a much smaller area far more often, usually several times a second or more. Weather radars resemble search radars, but use radio waves with circular polarization and a wavelength to reflect from water droplets. Some weather radar use the Doppler effect to measure wind speeds.

#### Data (digital radio)

Most new radio systems are digital, including Digital TV, satellite radio, and Digital Audio Broadcasting. The oldest form of digital broadcast was spark gap telegraphy, used by pioneers such as Marconi. By pressing the key, the operator could send messages in Morse code by energizing a rotating commutating spark gap. The rotating commutator produced a tone in the receiver, where a simple spark gap would produce a hiss, indistinguishable from static. Sparkgap transmitters are now illegal, because their transmissions span several hundred megahertz. This is very wasteful of both radio frequencies and power.



The next advance was continuous wave telegraphy, or CW (Continuous Wave), in which a pure radio frequency, produced by a vacuum tube electronic oscillator was switched on and off by a key. A receiver with a local oscillator would "heterodyne" with the pure radio frequency, creating a whistle-like audio tone. CW uses less than 100 Hz of bandwidth. CW is still used, these days primarily by amateur radio operators (hams). Strictly, on-off keying of a carrier should be known as "Interrupted Continuous Wave" or ICW or on-off keying (OOK).

Radioteletype equipment usually operates on short-wave (HF) and is much loved by the military because they create written information without a skilled operator. They send a bit as one of two tones using frequency-shift keying. Groups of five or seven bits become a character printed by a teleprinter. From about 1925 to 1975, radioteletype was how most commercial messages were sent to less developed countries. These are still used by the military and weather services.

Aircraft use a 1200 Baud radioteletype service over VHF to send their ID, altitude and position, and get gate and connecting-flight data. Microwave dishes on satellites, telephone exchanges and TV stations usually use quadrature amplitude modulation (QAM). QAM sends data by changing both the phase and the amplitude of the radio signal. Engineers like QAM because it packs the most bits into a radio signal when given an exclusive (non-shared) fixed narrowband frequency range. Usually the bits are sent in "frames" that repeat. A special bit pattern is used to locate the beginning of a frame.

Communication systems that limit themselves to a fixed narrowband frequency range are vulnerable to jamming. A variety of jammingresistant spread spectrum techniques were initially developed for military use, most famously for Global Positioning System satellite transmissions. Commercial use of spread spectrum began in the 1980s. Bluetooth, most cell phones, and the 802.11b version of Wi-Fi each use various forms of spread spectrum.

Systems that need reliability, or that share their frequency with other services, may use "coded orthogonal frequency-division

multiplexing" or COFDM. COFDM breaks a digital signal into as

many as several hundred slower subchannels. The digital signal is often sent as QAM on the subchannels. Modern COFDM systems use a small computer to make and decode the signal with digital signal processing, which is more flexible and far less expensive than older systems that implemented separate electronic channels.

COFDM resists fading and ghosting because the narrow-channel QAM signals can be sent slowly. An adaptive system, or one that sends error-correction codes can also resist interference, because most interference can affect only a few of the QAM channels. COFDM is used for Wi-Fi, some cell phones, Digital Radio Mondiale, Eureka 147, and many other local area network, digital TV and radio standards.

#### Heating

Radio-frequency energy generated for heating of objects is generally not intended to radiate outside of the generating equipment, to prevent interference with other radio signals. Microwave ovens use intense radio waves to heat food. Diathermy equipment is used in surgery for sealing of blood vessels. Induction furnaces are used for melting metal for casting, and induction hobs for cooking.

#### Amateur radio service

Amateur radio, also known as "ham radio", is a hobby in which enthusiasts are licensed to communicate on a number of bands in the radio frequency spectrum non-commercially and for their own enjoyment. They may also provide emergency and public service assistance. This has been very beneficial in emergencies, saving lives in many instances.<sup>[47]</sup>

Radio amateurs use a variety of modes, including nostalgic ones like Morse code and experimental ones like Low-Frequency Experimental Radio. Several forms of radio were pioneered by radio amateurs and later became commercially important, including FM, single-sideband (SSB), AM, digital packet radio and satellite repeaters. Some amateur frequencies may be disrupted illegally by power-line internet service.

#### **Unlicensed radio services**

Unlicensed, government-authorized personal radio services such as Citizens' band radio in Australia, most of the Americas, and Europe, and Family Radio Service and Multi-Use Radio Service in North America exist to provide simple, usually short range communication for individuals and small groups, without the overhead of licensing. Similar services exist in other parts of the world. These radio services involve the use of handheld units.

Wi-Fi also operates in unlicensed radio bands and is very widely used to network computers.

Free radio stations, sometimes called pirate radio or "clandestine" stations, are unauthorized, unlicensed, illegal broadcasting stations. These are often low power transmitters operated on sporadic schedules by hobbyists, community activists, or political and cultural dissidents. Some pirate stations operating offshore in parts of Europe and the United Kingdom more closely resembled legal stations, maintaining regular schedules, using high power, and selling commercial advertising time.<sup>[48][49]</sup>

## Radio control (RC)

Radio remote controls use radio waves to transmit control data to a remote object as in some early forms of guided missile, some early TV remotes and a range of model boats, cars and airplanes. Large industrial remote-controlled equipment such as cranes and switching locomotives now usually use digital radio techniques to ensure safety and reliability.

In Madison Square Garden, at the Electrical Exhibition of 1898, Nikola Tesla successfully demonstrated a radio-controlled boat.<sup>[50]</sup> He was awarded U.S. patent No. 613,809 for a "Method of and Apparatus for Controlling Mechanism of Moving Vessels or Vehicles."<sup>[51]</sup>

In practice, the frequency of radio signals are significantly below that of visible light (in the radio frequency range) from about 3 kHz to 300 GHz.<sup>[1]</sup>

### DETERMINATION OF THE BOARD GOVERNANCE COMMITTEE (BGC) RECONSIDERATION REQUEST 14-41 20 JANUARY 2015

The Requesters, Afilias Limited, BRS Media, Inc, and Tin Dale, LLC (three of the four applicants for the .RADIO string), seek reconsideration of: (i) the Community Priority Evaluation ("CPE") Panel's Report, and ICANN's acceptance of that report, finding that the European Broadcasting Union's ("EBU's") application for .RADIO prevailed in CPE; and (ii) ICANN staff's response to the Requesters' request pursuant to ICANN's Document Information Disclosure Policy ("DIDP") for documents relating to the CPE Panel's Report.<sup>1</sup>

### I. Brief Summary

The Requesters each submitted a standard (meaning not community-based) application for .RADIO. Those applications were placed in a contention set with the EBU's community-based application for .RADIO (the "Application"). As the EBU's Application was community-based, the EBU participated in CPE for .RADIO, and ultimately prevailed. As a result, the contention set for .RADIO has been resolved and only the EBU's Application will proceed.

The Requesters' initial Reconsideration Request claimed that the CPE Panel failed to comply with established ICANN policies and procedures in determining that the Application met the criteria needed to achieve community priority over the standard applications for .RADIO. The day after submitting their initial Reconsideration Request, the Requesters submitted a DIDP request seeking documents relating to the CPE Panel's

Report (the "DIDP Request"), and asked ICANN to postpone its review of the initial Reconsideration Request pending ICANN's response to the DIDP Request. ICANN agreed. On 24 October 2014, ICANN responded to the DIDP Request (the "DIDP Response"). On 11 November 2014, the Requesters submitted a revised Reconsideration Request, which added a call for reconsideration of the DIDP Response.<sup>2</sup> The Requesters claim that ICANN staff improperly determined that some of the documents sought by the Requesters are not appropriate for publication and/or are not in ICANN's possession.

The Requesters' claims are unsupported. The Requesters do not identify any misapplication of policy or procedure by ICANN staff or the CPE Panel. Rather, the Requesters simply disagree with the CPE Panel's determination and scoring of the Application, and with ICANN staff's application of the DIDP Defined Conditions for Nondisclosure. Substantive disagreements with the CPE Panel's Report and the DIDP Response, however, are not proper bases for reconsideration. Because the Requesters have failed to show that either the CPE Panel or ICANN staff acted in contravention of established policy or procedure, the BGC concludes that Request 14-41 be denied.

### II. Facts.

### A. Background Facts.

The Requesters each submitted a standard application for .RADIO<sup>3</sup> that was placed in a contention set with the EBU's community-based Application.<sup>4</sup>

On 19 February 2014, the EBU's Application was invited to participate in CPE. CPE is a method of resolving string contention that will occur only if a community application is in contention and if that applicant elects to pursue CPE.

The EBU elected to participate in CPE for .RADIO, and its Application was sent to the Economist Intelligence Unit ("EIU"), the CPE provider, for evaluation. On 10 September 2014, the CPE Panel issued its report on the EBU's Application.<sup>5</sup> The CPE Panel's Report explained that the Application met the CPE requirements specified in the Guidebook and, therefore, the Application prevailed in CPE. Because the Application prevailed in CPE, the Requesters' applications for .RADIO will not proceed.<sup>6</sup>

On 25 September 2014, the Requesters submitted Request 14-41, requesting reconsideration of the CPE Panel's Report, and ICANN's acceptance of that report.<sup>7</sup> On 26 September 2014, the Requesters submitted the DIDP Request, seeking: (i) the agreement(s) between ICANN and the CPE provider; (ii) guidance given by ICANN relating to the [CPE] process; (iii) internal ICANN documents relating to the Application's CPE; and (iv) information exchanged with or considered by the CPE provider and Panel relating to the Application's CPE.<sup>8</sup>

The Requesters asked ICANN, and ICANN agreed, for ICANN's review of Reconsideration Request 14-41 to be postponed pending ICANN's response to the DIDP Request.<sup>9</sup> On 24 October 2014, ICANN responded to the DIDP Request.<sup>10</sup> ICANN

provided links to all publicly available documents responsive to the DIDP Request, including comments regarding the Application, which were posted on ICANN's website and considered by the CPE Panel.<sup>11</sup> ICANN noted that documents responsive to the requests were either: (1) already public; (2) not in ICANN's possession; or (3) not appropriate for public disclosure because they were subject to certain DIDP Nondisclosure Conditions.<sup>12</sup>

On 10 November 2014, the Requesters submitted a revised Request 14-41.<sup>13</sup> In addition to requesting reconsideration of the CPE Panel's determination that the Application prevailed in CPE, the revised Request also sought reconsideration of the DIDP Response.

#### В. **Relief Requested.**

The Requesters ask the BGC to: (a) "suspend the process for awarding the .RADIO gTLD to the EBU"; (b) "restore the 'Application Status' of the Requesters' applications and the Application submitted by the EBU to 'Evaluation Complete', their respective 'Contention Resolution Statuses' to 'Active', and their 'Contention Resolution Result' to 'In Contention'"; (c) "reconsider the Determination [by the CPE Panel], and in particular not award a passing score" to the EBU's Application; (d) "reconsider [...] ICANN's respective decisions that each of the Requesters' applications for the .RADIO gTLD 'Will Not Proceed' to contracting"; and (e) "reconsider [ICANN's DIDP Response] by providing Requesters[] with the information requested in [the DIDP Request]."<sup>14</sup>

### II. Issues.

In view of the claims set forth in Request 14-41, the issues are whether:

- The CPE Panel violated established policy or procedure by failing to properly apply the CPE criteria set forth in the Guidebook in evaluating the EBU's Application; and
- ICANN staff violated established policy or procedure by determining that certain documents sought in the DIDP Request were subject to DIDP Nondisclosure Conditions.

### **III.** The Relevant Standards for Evaluating Reconsideration Requests.

ICANN's Bylaws provide for reconsideration of a Board or staff action or inaction in accordance with specified criteria.<sup>15</sup> Dismissal of a request for reconsideration of staff action or inaction is appropriate if the BGC concludes, and the Board or the NGPC<sup>16</sup> agrees to the extent that the BGC deems that further consideration by the Board or NGPC is necessary, that the requesting party does not have standing because the party failed to satisfy the reconsideration criteria set forth in the Bylaws.

### A. Community Priority Evaluation.

The reconsideration process can properly be invoked for challenges to expert determinations rendered by third party evaluators, such as the EIU, where it can be stated that the evaluator(s) failed to follow the established policies or procedures in reaching the

determination, or that staff failed to follow its policies or procedures in accepting that determination.<sup>17</sup>

In the context of the New gTLD Program, the reconsideration process does not call for the BGC to perform a substantive review of CPE reports. Accordingly, the BGC does not evaluate the CPE Panel's substantive conclusion that the Application prevailed in CPE. Rather, the BGC's review is limited to whether the CPE Panel violated any established policy or process, which the Requesters suggest occurred when the CPE Panel purportedly misapplied the CPE criteria set out in the Guidebook.<sup>18</sup>

The standards governing CPE are set forth in Section 4.2 of the Guidebook. In addition, the EIU – the firm selected to perform CPE – has published supplementary guidelines ("CPE Guidelines") that provide more detailed scoring guidance, including scoring rubrics, definitions of key terms, and specific questions to be scored.<sup>19</sup>

CPE will occur only if a community-based applicant selects CPE and the other applications in the contention set have completed all previous stages of the gTLD evaluation process.<sup>20</sup> CPE is performed by an independent community priority panel appointed by the EIU to review such applications.<sup>21</sup> A CPE panel's role is to determine whether the community-based application satisfies the four community priority criteria set forth in Section 4.2.3 of the Guidebook. The four criteria include: (i) community establishment; (ii) nexus between proposed string and community; (iii) registration

policies; and (iv) community endorsement.<sup>22</sup> To prevail in CPE, an application must receive a minimum of 14 points on the scoring of foregoing four criteria, each of which is worth a maximum of four points (for a total of 16 points).<sup>23</sup>

### **B.** Documentary Information Disclosure Policy (DIDP)

ICANN considers the principle of transparency to be a fundamental safeguard in assuring that its bottom-up, multi-stakeholder operating model remains effective and that outcomes of its decision-making are in the public interest and are derived in a manner accountable to all stakeholders. A principal element of ICANN's approach to transparency and information disclosure is the commitment to make publicly available a comprehensive set of materials concerning ICANN's operational activities. In that regard, ICANN has identified many categories of documents that are made public as a matter of due course.<sup>24</sup> In addition to ICANN's practice of making many documents public as a matter of course, the DIDP allows community members to request that ICANN make public documentary information "concerning ICANN's operational activities, and within ICANN's possession, custody, or control," that is not already publicly available.<sup>25</sup>

In responding to a request for documents submitted pursuant to ICANN's DIDP, ICANN adheres to the "Process For Responding To ICANN's Documentary Information Disclosure Policy (DIDP) Requests" ("DIDP Response Process").<sup>26</sup> The DIDP Response Process provides that following the collection of potentially responsive documents, "[a] review is conducted as to whether any of the documents identified as responsive to the

Request are subject to any of the [Nondisclosure Conditions] identified [on ICANN's website]."<sup>27</sup>

Per the DIDP, ICANN reserves the right to withhold documents if they fall within any of the Nondisclosure Conditions, which include, among others: (i) "[i]nformation provided by or to a government or international organization . . . in the expectation that the information will be kept confidential and/or would or likely would materially prejudice ICANN's relationship with that party;" (ii) "[i]nternal information that, if disclosed, would or would be likely to compromise the integrity of ICANN's deliberative and decision-making process [...];" (iii) "[i]nformation exchanged, prepared for, or derived from the deliberative and decision-making process between ICANN, its constituents, and/or other entities with which ICANN cooperates [...];" and (iv) "[i]nformation subject to the attorney-client, attorney work product privilege, or any other applicable privilege."<sup>28</sup> In addition, ICANN may refuse "[i]nformation requests: (i) which are not reasonable; (ii) which are excessive or overly burdensome; (iii) [where compliance] is not feasible; or (iv) [which] are made with an abusive or vexatious purpose or by a vexatious or querulous individual."<sup>29</sup>

The DIDP Response Process also provides that "[t]o the extent that any responsive documents fall within any [Nondisclosure Conditions], a review is conducted as to whether, under the particular circumstances, the public interest in disclosing the documentary information outweighs the harm that may be caused by such disclosure."<sup>30</sup> It is within ICANN's sole discretion to determine whether the public interest in the

disclosure of responsive documents that fall within one of the Nondisclosure Conditions outweighs the harm that may be caused by such disclosure.<sup>31</sup> Finally, the DIDP does not require ICANN staff to "create or compile summaries of any documented information," including logs of documents withheld under one of the Nondisclosure Conditions.<sup>32</sup>

### IV. Analysis and Rationale.

The Requesters do not identify any misapplication of policy or procedure by ICANN staff or the CPE Panel. Rather, the Requesters simply disagree with the CPE Panel's determination and scoring of the Application, and with ICANN staff's substantive application of the DIDP Defined Conditions for Nondisclosure. Substantive disagreements with the CPE Panel's Report and the DIDP Response, however, are not proper bases for reconsideration.

# A. The CPE Panel Adhered To Applicable Policies and Procedures in Rendering the CPE Panel's Report.

The Requesters' arguments regarding the CPE Panel's Report reflect only their disagreement with the CPE Panel's conclusions and scoring. The fact that the Requesters would have liked the CPE Panel to reach a different conclusion is not, however, a proper basis for reconsideration. As discussed below, the CPE Panel adhered to the applicable policies and procedures in rendering The CPE Panel's Report.

### **1.** The CPE Panel Properly Applied the First CPE Criterion.

Pursuant to the first CPE criterion, the CPE Panel evaluates "the community as explicitly identified and defined according to statements in the application" through the scoring of two elements, each worth two points—1-A, "Delineation," and 1-B,

"Extension."<sup>33</sup> The Requesters claim that the CPE Panel improperly awarded the Application one out of two points on the "Delineation" element.<sup>34</sup>

Pursuant to Section 4.2.3 of the Guidebook, to receive a maximum score for the "Delineation" element, an application must identify a "clearly delineated, organized, and pre-existing community.<sup>35</sup> Section 4.2.3 also sets forth further guidelines for determining delineation. In awarding one out of two points for "Delineation," the CPE Panel accurately described and applied the Guidebook scoring guidelines.<sup>36</sup>

The CPE Panel determined that the Application's community definition "show[ed] a clear and straightforward membership and w[as] therefore well defined," noting that "[a]ssociation with, and membership in, the radio community can be verified" through things such as "licenses held by professional and amateur radio broadcasters" and "internet radios that meet certain minimum standards."<sup>37</sup> The CPE Panel also determined that the community as defined in the Application (1) "ha[d] awareness and recognition among its members . . . because the community . . . consists of entities and individuals that are in the radio industry, and as participants in this clearly defined industry, they have an awareness and recognition of their inclusion in the industry community," and (2) was pre-existing because it was active prior to September 2007.<sup>38</sup> The CPE Panel nonetheless awarded the Application only one out of two points on the "Delineation" element because it determined that the community was not organized, *i.e.*, it did not have at least one entity mainly dedicated to the community and it did not have documented

evidence of community activities.<sup>39</sup>

In challenging the CPE Panel's Report, the Requesters do not identify any policy or procedure that the CPE Panel misapplied in scoring the "Delineation" element. Instead, they disagree with the CPE Panel's substantive application of the element. The CPE Report notes that the "radio industry" is included in the North American Industrial Classification System ("NAICS") and that the NAICS definition of the industry "includes the vast majority of [the] entities included in the [] community [as defined in the Application]."<sup>40</sup> The Requesters claim that in their view, the community as defined in the Application is broader than the NAICS definition of "radio industry."<sup>41</sup> Specifically, the Requesters claim that groups such as podcasters and companies offering "Internet radio" are not properly considered part of the radio community contemplated by the NAICS.<sup>42</sup> In addition, the Requesters argue that because the CPE Panel found that the community as defined in the Application was not organized, it could not have found that the community was well-defined.<sup>43</sup> Both of the Requesters' arguments reflect only substantive disagreement with the CPE Panel's findings. Such substantive disagreement is not a proper basis for reconsideration.

#### 2. The CPE Panel Properly Applied the Second CPE Criterion.

The Requesters claim that the CPE Panel improperly awarded the Application three out of four points on the second criterion, pursuant to which the CPE Panel assesses the nexus between the proposed string and the community.<sup>44</sup> This CPE Panel evaluates "the relevance of the string to the specific community that it claims to represent" through

the scoring of two elements—2-A, "Nexus" (worth three points), and 2-B, "Uniqueness" (worth one point).<sup>45</sup>

Pursuant to Section 4.2.3 of the Guidebook, to receive a maximum score for the "Nexus" element, the applied-for string must "match[] the name of the community or [be] a well-known short-form or abbreviation of the community name."<sup>46</sup> In awarding two out of three points for the "Nexus" element, the CPE Panel accurately described and applied the Guidebook scoring guidelines.<sup>47</sup> The CPE Panel determined that while the applied-for string "closely resemble[d] the community, without overreaching substantially beyond the community," it "also include[d] some entities that are only tangentially related to radio, such as companies providing specific services or products to radio broadcasting organizations and which may not be automatically associated with the gTLD string."<sup>48</sup> The CPE Panel therefore determined that the Application "partially" met the requirements of criterion 2-A.<sup>49</sup>

To fulfill the requirements for the "Uniqueness" element, a string must have "no other significant meaning beyond identifying the community described in the application."<sup>50</sup> In awarding the Application one out of one point on element 2-B, the CPE Panel determined that "the string as defined in the application demonstrate[d] uniqueness, as the string h[ad] no other significant meaning beyond identifying the community described in the application."<sup>51</sup>

The Requesters also claim that the CPE Panel should have referred to the Oxford English Dictionary's definition of "radio," a definition which the Requesters contend includes "various other meanings that fall outside of the remit of [the community as defined in the Application]."<sup>53</sup> The Requesters claim that in "various cases," other CPE Panels have referred to Oxford English Dictionary definitions in scoring the second CPE criterion. However, there is no requirement that the CPE Panel must consider Oxford English Dictionary definitions. Instead, it is within the discretion of each CPE panel to determine which outside sources, if any, to refer to in evaluating an application.<sup>54</sup> The fact that the CPE Panel determined not to rely on the Oxford English Dictionary in this case is not a basis for reconsideration.

### **3.** The CPE Panel Properly Applied the Third CPE Criterion.

The Requesters claim that the CPE Panel improperly awarded the Application four out of four points on the third criterion, which assesses an applicant's registration

policies.<sup>55</sup> Pursuant to this criterion, the CPE Panel evaluates the applicant's registration policies through the scoring of four elements, each worth one point—3-A, "Eligibility;" 3-B, "Name Selection;" 3-C, "Content and Use;" and 3-D, "Enforcement."<sup>56</sup>

Pursuant to Section 4.2.3 of the Guidebook, to receive a maximum score for the "Eligibility" element, eligibility to register for a domain name on a gTLD must be "restricted to community members."<sup>57</sup> In awarding one out of one point for that element, the CPE Panel accurately described and applied the Guidebook scoring guidelines.<sup>58</sup> The CPE Panel determined that the Application "demonstrate[d] adherence to [the element's] requirement by restricting eligibility to [] community members . . . and additionally requiring that the registered domain name be 'accepted as legitimate; and beneficial to the cause and values of the radio industry; and commensurate with the role and importance of the registered domain name; and in good faith at the time of registration and thereafter."<sup>59</sup>

To receive a maximum score for the "Name Selection" element, an applicant's policies must "include name selection rules consistent with the articulated community-based purpose of the applied-for gTLD."<sup>60</sup> In awarding one out of one point for that element, the CPE Panel accurately described and applied the Guidebook scoring guidelines.<sup>61</sup> The CPE Panel determined that the Application satisfied the requirements for "Name Selection" because it "specif[ied] that the registrant's nexus with the radio community and use of the domain must be commensurate with the role of the registered

domain, and with the role and importance of the domain name based on the meaning an average user would reasonably assume in the context of a domain name."62

To receive a maximum score for the "Content and Use" element, an applicant's policies must "include rules for content and use consistent with the articulated community-based purpose of the applied-for gTLD."63 In awarding one out of one point for that element, the CPE Panel accurately described and applied the Guidebook scoring guidelines.<sup>64</sup> The CPE Panel determined that the Application satisfied the requirements for "Content and Use" because it "specifi[ed] that use of the domain name must be beneficial to the cause and values of the radio industry, and commensurate with the role and importance of the registered domain name."65

To receive a maximum score for the "Enforcement" element, an applicant's policies must "include specific enforcement measures (e.g., investigation practices, penalties, takedown procedures) constituting a coherent set with appropriate appeal mechanisms."<sup>66</sup> In awarding one out of one point for that element, the CPE Panel accurately described and applied the Guidebook scoring guidelines.<sup>67</sup> The CPE Panel determined that the Application both "include[d] specific enforcement measures constituting a coherent set" and had "an appeals mechanism, which [was] managed in the first instance by the registry, with appeals heard by an independent, alternative dispute resolution provider."68

In challenging the CPE Panel's Report, the Requesters do not identify any policy

or procedure that the CPE Panel misapplied in scoring the third criterion. Rather, they claim that it is "unclear which standards and criteria are going to be used . . . by the EBU in view of ensuring that only members of the 'radio community' or 'radio industry' can register domain names."<sup>69</sup> They also state that they "do not understand" the EBU's name selection, the EBU's content and use policies, and the "standards and criteria" that the CPE Panel used to determine that those policies were sufficient.<sup>70</sup> Finally, in their 25 September 2014 Request, the Requesters claimed that because, in their view, "eligibility criteria contained in the Application for registering domain names under the .RADIO gTLD . . . are contradictory, vague, and ill defined," "the effective enforcement of [those] criteria upon registrants and candidate registrants cannot be guaranteed by the EBU."<sup>71</sup> Once again, the Requesters' arguments reflect only substantive disagreement with the CPE Panel's findings, which is not a proper basis for reconsideration.

### 4. The CPE Panel Properly Applied the Fourth CPE Criterion.

The Requesters claim that the CPE Panel improperly awarded the Application four out of four points on the fourth criterion, pursuant to which the CPE Panel assesses community endorsement of an application.<sup>72</sup> This criterion calls for the evaluation of community support for and/or opposition to an application through the scoring of two elements, each worth two points—4-A, "Support," and 4-B, "Opposition."

### a. The CPE Panel Properly Applied Element 4-A.

Pursuant to Section 4.2.3 of the Guidebook, to receive a maximum score for the "Support" element, the applicant must be, or "ha[ve] documented support from, the

recognized community institution(s)/member organization(s) or ha[ve] otherwise documented authority to support the community."<sup>73</sup> The CPE Panel determined that although the EBU "was not the recognized community institution(s)/member organization(s)," it had "documented support from institutions/organizations representing a majority of the community addressed, and this documentation contained a description of the process and rationale used in arriving at the expression of support."<sup>74</sup> The CPE Panel further noted that the EBU had received support from a "broad range of recognized community institutions/member organizations, which represented different segments of the community as defined by the applicant."<sup>75</sup>

In challenging the CPE Panel's Report, the Requesters do not identify any policy or procedure that the CPE Panel misapplied in scoring the "Support" element. Instead, the Requesters claim that the EBU did not in fact receive support from a majority of the community addressed, because, as asserted by the Requesters, there are over 50,000 radio stations in the world, and "the 'Member Unions' that have provided their support only account for 589 full members that are involved in the 'radio business."<sup>76</sup> They further claim that "the majority of these 'members' are state-owned or related to public broadcasters," and/or are involved in television broadcasting.<sup>77</sup> These arguments reflect only a substantive disagreement with the CPE Panel's finding that the EBU had the support of institutions and organizations representing a majority of the defined community, and do not support reconsideration.

#### The CPE Panel Properly Applied Element 4-B. b.

Pursuant to Section 4.2.3 of the Guidebook, to receive a maximum score for the "Opposition" element, the applied-for string must have "no opposition of relevance" from the community.<sup>78</sup> In awarding two out of two points for the "Opposition" element, the CPE Panel accurately described and applied the Guidebook scoring guidelines.<sup>79</sup> The CPE Panel reviewed each letter of opposition received regarding the Application and "determined [them] not to be relevant, as they were (1) from individuals or groups of negligible size, or (2) were not from communities either explicitly mentioned in the application [or] from those with an implicit association to such communities."<sup>80</sup>

In challenging the CPE Panel's Report, the Requesters do not identify any policy or procedure that the CPE Panel misapplied in scoring the "Opposition" element. Instead, the Requesters state that they "do not agree" with the CPE Panel's determination that the opposition received was from "a group of negligible size."<sup>81</sup> The Requesters also claim that "public comments . . . submitted by or on behalf of the Requesters to ICANN in relation to the Application . . . contained strong opposition" to the Application, and further note that one of the Requesters, BRS Media, Inc., is the registry for the .FM gTLD.<sup>82</sup> Once again, the Requesters have only a substantive disagreement with the CPE Panel's conclusion, which is not a basis for reconsideration.

# **B.** ICANN Staff Adhered to Applicable Policies and Procedures in Responding to the DIDP Request.

The Requesters disagree with ICANN staff's determination that certain requested documents were subject to DIDP Nondisclosure Conditions, as well as ICANN's

determination that, on balance, the potential harm from the release of the documents subject to the Nondisclosure Conditions outweigh the public interest in disclosure.<sup>83</sup> The Requesters, however, do not identify any policy or procedure that ICANN staff violated in responding to the DIDP Request. As such, reconsideration is not appropriate.

### 1. ICANN Staff Adhered to the DIDP and DIDP Response Process in Finding Certain Requested Documents Subject to DIDP Nondisclosure Conditions.

The DIDP identifies a number of "conditions for the nondisclosure of information," such as documents containing "information exchanged, prepared for, or derived from the deliberative and decision-making process between ICANN, its constitutes, and/or other entities" and "drafts of all correspondence, reports, documents . . . or any other forms of communication."<sup>84</sup> It is ICANN's responsibility to determine whether requested documents fall within those Nondisclosure Conditions. Specifically, pursuant to the DIDP Response Process, "a review is conducted as to whether the documents identified as responsive to the Request are subject to any of the [Nondisclosure Conditions] identified [on ICANN's website]."<sup>85</sup>

Here, in finding that certain requested documents were subject to Nondisclosure Conditions, ICANN adhered to the DIDP Response Process. As to the contract between ICANN and the EIU for the coordination of the independent panels to perform CPEs, ICANN analyzed the Requesters' request in view of the DIDP Nondisclosure Conditions. ICANN determined that the contract was subject to several Nondisclosure Conditions,

including those covering "information . . . provided to ICANN pursuant to a nondisclosure agreement or nondisclosure condition within an agreement" and "confidential business information and/or internal policies and procedures."<sup>86</sup> As to the remaining items sought by the Requesters, ICANN staff determined that insofar as those documents existed in ICANN's possession and had not already been made public, those documents were also subject to several Nondisclosure Conditions, including those covering "information exchanged, prepared for, or derived from the deliberative and decision-making process between ICANN, its constitutes, and/or other entities," "confidential business information and/or internal policies and procedures," and "drafts of all correspondence, reports, documents . . . or any other forms of communication."<sup>87</sup>

As ICANN noted in the DIDP Response, notwithstanding the fact that the Requesters' "analysis in [their DIDP] Request concluded that no [Nondisclosure Conditions] should apply, ICANN must independently undertake the analysis of each Condition as it applies to the documentation at issue, and make the final determination as to whether any Nondisclosure Conditions apply."<sup>88</sup> In conformance with the publicly posted DIDP Response Process, ICANN undertook such analysis, as noted above, and articulated its conclusions in the DIDP Response. While the Requesters may not agree with ICANN's determination that certain Nondisclosure Conditions apply here, the Requesters identify no policy or procedure that ICANN staff violated in making its determination, and the Requesters' substantive disagreement with that determination is not a basis for reconsideration.

### 2. ICANN Staff Adhered to the DIDP and DIDP Response Process in Determining that the Potential Harm Caused by Disclosure Outweighed the Public Interest in Disclosure.

The DIDP states that if documents have been identified within the Nondisclosure Conditions, they "may still be made public if ICANN determines, under the particular circumstances, that the public interest in disclosing the information outweighs the harm that may be caused by such disclosure."<sup>89</sup> In responding to the DIDP Request, ICANN staff determined that "[f]or each of the [requested] items identified [] as subject to Defined Conditions of Nondisclosure, . . . there are no particular circumstances in the public interest in disclosing the information."<sup>90</sup>

The Requesters do not dispute this determination, nor do they identify any public interest in the disclosure of the requested documents. Instead, the Requesters argue that they personally have been harmed by being denied access to the requested documents.<sup>91</sup> The Requesters' belief that they personally would benefit from the disclosure of the requested documents is not evidence that ICANN staff improperly determined that the documents were inappropriate for disclosure. Here, in accordance with the DIDP Response Process, ICANN staff conducted a review of all responsive documents that fell within the Nondisclosure Conditions, and determined that the potential harm outweighed the public interest in the disclosure of those documents.<sup>92</sup> Indeed, as noted, many of the items in the DIDP Request seek documents containing "confidential business information," including documents subject to contractual confidentiality provisions.<sup>93</sup> The Requesters identify no policy or procedure that ICANN staff violated in determining

that the harm that may be caused by the disclosure of such documents outweighed the public interest in disclosure.

# **3.** ICANN Staff Adhered to the DIDP in Finding that Certain Requested Documents Were Not in ICANN's Possession.

The Requesters also appear to object to ICANN's representation that certain of the requested documents could not be made publicly available because they were not within ICANN's possession.<sup>94</sup> The Requesters claim that "[i]n [their] opinion, the EIU, who has been appointed by ICANN as the [CPE] independent panel firm, is subject to the same policies – especially those relating to transparency and accountability – as ICANN."<sup>95</sup> However, the DIDP is only available as a means to collect documents "within ICANN's possession, custody, or control."<sup>96</sup> ICANN staff acted in accordance with that established policy in noting that ICANN is not able to make public documents that are not within its possession, custody, or control.

### V. Decision

Based on the foregoing, the BGC concludes that the Requesters have not stated proper grounds for reconsideration, and therefore denies Reconsideration Request 14-41. As there is no indication that: (i) either the CPE Panel or ICANN violated any policy or procedure with respect to the CPE Panel's Report, or ICANN's acceptance of that report; or (ii) ICANN staff violated any policy or procedure in responding to the Requesters' DIDP Request, Request 14-41 should not proceed. If the Requesters believe they have somehow been treated unfairly in the process, the Requesters are free to ask the Ombudsman to review this matter.

The Bylaws provide that the BGC is authorized to make a final determination for all Reconsideration Requests brought regarding staff action or inaction and that no Board (or NGPC) consideration is required.<sup>97</sup> As discussed above, Request 14-41 seeks reconsideration of a staff action or inaction. As such, after consideration of this Request, the BGC concludes that this determination is final and that no further consideration by the Board is warranted.

In terms of the timing of the BGC's Determination, the BGC notes that Section 2.16 of Article IV of the Bylaws provides that the BGC shall make a final determination or recommendation with respect to a Reconsideration Request within thirty days following receipt of the request, unless impractical.<sup>98</sup> In this case, the BGC's Determination was delayed due to the Requesters' request for a postponement of the BGC's review of their initial Reconsideration Request and submission of a revised Reconsideration Request. As such, the first practical opportunity for the BGC to take consider this Request was on 20 January 2015.

#### Mr.Atallah,

The Economist Intelligence Unit, NA, Incorporated ("Panel Firm") will provide the Internet Corporation for Assigned Names and Numbers ("ICANN") with professional services to assist in the new Generic Top-Level Domain (gTLD) program in relation to the Community Priority and Geographic Names Panels. This Statement of Work ("SOW") outlines the activities to be performed and work product to be provided along with anticipated professional fees and expenses. The engagement team is expected to begin work on or about June 2012 with targeted completion of this SOW within 12 to 20 months from that date. If these dates change due to changes or other circumstances impacting the gTLD program, ICANN and Panel Firm will adjust dates and the start time accordingly (and anticipated professional fees and expenses to the extent applicable) via a Change Request. It is acknowledged that any modification of professional fees and expenses may impact the allocation of applications to Panel Firm.

# 1. Background

This SOW is entered into pursuant to the *New gTLD Program Consulting Services* Agreement between Panel Firm and ICANN dated 26 July 2011 ("**Master Agreement**").

Unless expressly defined in this SOW, any capitalized terms will have the meaning given to them in the Master Agreement. In this SOW, "Panelist" has the same meaning as "Panelist" or "Evaluation Panelist" in Section 2.4.3 of the Applicant Guidebook.

# 2. Scope and Objectives

The objectives of this SOW are to outline the scope, approach, activities and deliverables related to providing panel evaluation assistance to ascertain whether each application assigned to Panel Firm (subject to any conflict handling) has successfully met the criteria set forth in the *19 September 2011* New gTLD Applicant Guidebook ("**Applicant Guidebook**"). Panel evaluation services will be conducted by applying scoring or other criteria in the Applicant Guidebook as well as the guidance provided in the mandatory evaluator training and the gTLD Evaluation Principles Guide provided by ICANN and developed for evaluation panels. Panel Firm will provide evaluation panel services to ICANN during the opening round<sup>1</sup>("round one") of the new gTLD application program for the following appointed panel(s):

### Community Priority Evaluation Panel

This panel will be responsible for reviewing each (subject to conflicts as dealt with below) community-based application in Contention Sets, where community priority evaluation has been elected, to determine if the application fulfils the community priority criteria pursuant to the requirements outlined in Applicant Guidebook Section 4.2 Community Priority Evaluation.

The review will occur during the String Contention resolution period following the end of Initial Evaluation and/or Extended Evaluation, if applicable. The objectives and scope of the community priority evaluation panel will be to score the assigned application on the four criteria described in the Applicant Guidebook. The results of this review will be comprised of individual scoring for each criteria, including rationale, and a panel summary for each application reviewed in a format defined by ICANN and agreed on by Panel Firm. The summary includes an overall pass/fail result. The Panel Firm will consider application information forwarded by ICANN, including Community Priority panel application comments.

# 3. Approach, Activities and Deliverables

### Panel Evaluation Approach and Activities

As part of the String Contention phase, Panel Firm will perform the panel evaluation services outlined above for assigned applications. ICANN's new gTLD Program Office ("Program Office") will assign applications for evaluation by Panel Firms generally based on a number of factors such as conflicts of interest with a particular applicant, scalability or capacity to complete timely evaluations. ICANN reserves the right to allocate applications to Panel Firm as it deems appropriate to ensure all application processing considerations and requirements are being met.

Note: "Panellist" has the same meaning as "Panelist" or "Evaluation Panelist" in Section 2.4.3 of the Applicant Guidebook.

The approach for evaluating each application is as follows:

### String Contention Periods:

Note, the String Contention periods will occur in two separate phases. The first phase will run concurrent with Extended Evaluation and will cover applications that have passed Initial Evaluation and do not have any Objection(s)filed against them or associated GAC Advice presented to the Board. The second phase will run after the Extended Evaluation and Dispute Resolution Periods have closed and the Board has addressed any associated GAC Advice.

### Review and Evaluate: Community Priority Evaluation (CPE)

The approach begins with the review and evaluation of the questions, related responses and supporting documentation provided by the applicants for each application. Panellists will perform the evaluation and analysis of the applicant's responses to the Community questions against the established criteria in the Applicant Guidebook and will follow the procedures outlined in the gTLD Evaluation Principles guide.

The detailed activities and analysis for the CPE during the String Contention resolution period are as follows:

 Review each question, response and supporting documentation (where relevant). Note that ICANN will provide to Panel Firm all relevant and necessary information submitted to it as part of the application as well as supplemental material in support of the application as relates to its community status. Where Panel Firm determines

that additional application information or supporting material that ICANN has received is necessary to conduct the Community Priority Evaluation and requests that material, ICANN will provide it subject to any restrictions.

- Establish that there is adequate information and supporting documentation to provide a basis for evaluation. If the information and supporting information is inadequate, Panellists will escalate to management according to the established Program Office processes. Adequate information and supporting documentation is defined as follows:
  - a. Complete the response and supporting documentation provided by the applicant is sufficient for the Panel to perform the review
  - b. Appropriate the response and supporting documentation provided by the applicant is relevant to the specific question and/or set of questions
- 3. Determine whether additional subject-matter support is required to interpret the supporting documentation provided by the applicant. For example, if the supporting documentation provided is in a language other than English, Panel Firm may translate the documentation or provide a subject-matter professional who would be similarly capable of reviewing and analysing the documentation. In addition, if the response and/or supporting documentation require additional technical expertise due to additional complexity, uniqueness, etc., Panel Firm will provide the necessary skill sets to review and analyse the documentation.
- 4. Evaluate the provided response and supporting documentation (where relevant) to each question to ascertain compliance to the Application criteria
- Provide a recommended score according to the scoring schedule linked to each question or set of questions (i.e., 0 – fails requirement, 1/2- meets requirements, 2/3 – exceeds requirements).

### **Document and Summarize**

As part of the overall panel evaluation approach, Panel Firm will document their evaluation activities and results and provide a summary of the analysis performed to reach the recommended result—<sup>Non-Responsive Information Reducted Relates to Other Scope of</sup> or a score, for Community Priority applicants—by question or area in the application. Documentation of the evaluation activities and results will be prepared and a summary of the rationale for each score will be documented in the TLD Application System (TAS) according to guidelines established by the Program Office and agreed on by Panel Firm.

The detailed activities to document and summarize the Community Priority evaluation and analysis are as follows:

- 1. Document the evaluation and analysis for each question to demonstrate how the Panellist determined a score for each question based on the established criteria
- 2. Provide a summary of the rationale and recommended score for each question.

## Complete and Support

As part of the overall panel evaluation approach, Panel Firm will perform an internal management/quality control review of the completed evaluation activities and approve the rationale and recommended result– Non-Responsive Information Redacted Relates to Other Scope of or a score, for Community Priority applicants—prior to submitting to ICANN. In addition, Panellists and/or Panel Firm management will also provide ad-hoc support and documentation as requested by ICANN's Quality Control function as part of the overall gTLD evaluation quality control process (see Quality Control below).

The detailed activities to complete and support the Community Priority Evaluation and analysis are as follows:

- Review the evaluation and analysis performed by the Panellists and the summary of the rationale and recommended scores based on overall reasonableness and adherence to the established criteria in the Applicant Guidebook and the gTLD Evaluation Principles guide.
- 2. Approve the rationale and recommended scores to finalize and complete the evaluation
- 3. Provide an overall summary of the evaluation, rationale, and recommended scores to ICANN for final review and approval

# **Quality Control**

Panel Firm acknowledges that consistency of application processing is a key success factor for the new gTLD program. As such, ICANN is requiring certain critical phases of application processing be subject to a Quality Control (QC) program.

The QC program will consist of procedural/administrative completeness checks. It is planned that the QC program will review a total of 35% of applications for procedural completeness.

Further details of Panel Firm's obligations under the QC program are described in Section 8 below.

## Panel Evaluation Key Deliverables

The key deliverables for panel evaluations are as follows:

- A completed Evaluator Template (from the New gTLD Evaluation Principles guide) for each application reviewed;
- A summary of the rationale and recommended score for each question for CPE applicants; and
- Non-Responsive Information Redacted; Relates to Other Scope of Work Not Related to Community Priority Evaluation

In general, the above will be captured via TAS or as otherwise reasonably requested in the event of the Contingency Plan in Section 7 below.

A matrix outlining the program responsibilities for the above steps and deliverables is contained in Exhibit C of this SOW.

\*\* Note: While the detailed documentation of the evaluation analysis is not a key deliverable to ICANN, Panel Firm will provide copies of application evaluation work paper documentation to ICANN if requested. Refer to Section 9(B). Retention Requirements.

### Project Management Approach

Panel Firm will provide on-going project management support in an effort to facilitate the completion of evaluation activities to be on time and within budget (to the extent within Panel Firm's control). As part of the overall gTLD program, Panel Firm's project management team will work with the Program Office to ensure that the evaluations are completed consistently and completely in adherence to the Applicant Guidebook and in accordance with processes established by the Program Office.

Panel Firm will establish a project management approach to manage, coordinate and monitor the evaluation activities based on Panel Firm's proprietary engagement management standards and ICANN's gTLD Program Governance requirements. Panel Firm will tailor certain project management processes to directly support the Program Office governance processes. These include:

- Status reporting Panel Firm will manage evaluation activities progress for each application and provide reasonable on-going status updates to the Program Office as defined in the governance procedures and agreed on by Panel Firm. Panel Firm will manage resources and overall capacity for its evaluation services and provide status update reports to the Program Office as reasonably requested.
- Conflict check Panel Firm will implement a process to identify and communicate potential conflicts of interest to support Program Office application allocation process
- Other support Panel Firm will provide support, as reasonably requested by the Program Office, as it relates to its appointed evaluation panels including:
  - Issue management the processes to ensure program level issues are identified and resolved in a timely manner to minimize the impact to the execution of the gTLD Program.
  - Vendor management the processes necessary to manage all aspects of the vendor relationship including contract administration and performance.
  - Resource and budgeting the processes to manage scheduling (scalability &capacity) of resources and program budget across all phases of the gTLD program.

- Communication the processes to manage communication between various key stakeholders to ensure accurate and timely flow of information as reasonably required
- Continuous Improvement the processes to identify and implement improvements to the overall gTLD program. Panel firms, during status reporting, will provide feedback on process improvement opportunities as they are identified

### Project Management Reporting

• Provide on-going status reports to Program Office to monitor progress, capacity, budget, and other areas as highlighted above.

An overview matrix summarizing the program responsibilities and deliverables is contained in Exhibit C of this SOW.

# 4. Conflict of Interest and Code of Conduct

Note: "Panellist" has the same meaning as "Panelist" or "Evaluation Panelist" in Section 2.4.3 of the Applicant Guidebook.

Panel Firm will ensure that its Panellists are advised and made aware of their obligation to comply with the Conflict of Interest Guidelines and Code of Conduct Guidelines (as set out in Section 2.4.3 of the Applicant Guidebook).

Each Panellist assigned is expected to have read and perform services in compliance with Conflict of Interest Guidelines and Code of Conduct Guidelines. ICANN may require Panellists to submit a signed acknowledgement in the format set out in Exhibit B of this SOW. ICANN may alternatively permit Panel Firm to collect and manage individual Panellists' signed acknowledgement consistent with Exhibit B of this SOW within its own consolidated and documented central register which ICANN (or its nominated QC service provider) may request to inspect and verify compliance.

In accordance with the Conflict of Interest Guidelines, Panel Firm will confirm its implementation of a satisfactory Conflict of Interest monitoring and disclosure protocol with ICANN.

Panel Firm will require that it and each Panellist working under this Statement of Work during the Compliance Period (as defined in the Applicant Guidebook)must:

- (a) Not engage in any direct or indirect communication with any Applicant regarding the gTLD application process; and
- (b) Obtain ICANN's prior written approval(which will not be unreasonably withheld or delayed)in relation to the content of any proposed press release or other public communication concerning the evaluation services, reference to ICANN as a

customer of the Panel Firm or any other subject matter under this SOW prior to any release or publication.

Panel Firm shall be entitled to decline any assigned application or applications it considers, in good faith, will raise the prospect of a conflict of interest or is inconsistent with its professional obligations or requirements. Panel Firm will promptly notify ICANN where it wishes to excuse itself from an assigned application or applications due to conflict or professional obligations. ICANN will re-assign any such application or applications to be evaluated by another panel firm.

ICANN understands that Panel Firm may discuss confidential information regarding gTLD application process handling, co-ordination and process improvements with other panel firms. Confidential information that specifically identifies an applicant or the commercial terms and conditions of the Master Agreement or this SOW must not be disclosed or shared with other panels firms.

# 5. Personnel and Contractors

Panel Firm will notify ICANN of any Panellists or project management personnel, including sub-contractors, being removed from this engagement within a commercially reasonable time frame after such event (e.g. no less than 30 days where practical, otherwise as soon practical) unless such removal is part of Panel Firm's ordinary resource management and scaling activities. In addition, ICANN reserves the right to:

- a. Direct the prompt removal of any Panellist or sub-contractor from the performance of evaluation services by written notice due to any material or ongoing breach of either the Code of Conduct or Conflict of Interest Guidelines by that individual;
- (b) By written notice for any other reasonable grounds in the interests of the new gTLD Program as determined by ICANN; and
- (c) Interview and reasonably reject/approve replacement candidates.

### Panel Firm must:

- (a) Ensure that Panellists assigned to conduct evaluations have successfully completed the relevant new gTLD panellist training developed by ICANN;
- (b) Agree to be bound by the TLD Application System (TAS) Terms of Use (in the form set out in Exhibit A to this SOW and as may be generally amended by ICANN from time to time) in connection with any use of the TAS to perform the evaluation services under this SOW; and
- (c) Comply with the confidentiality obligations under the Master Agreement with ICANN.

Where Panel Firm engages independent third party sub-contractors to assist with the evaluation services, Panel Firm will ensure that each contractor is contractually bound by an obligation of confidentiality broadly consistent with the confidentiality obligations of the Panel Firm under the Master Agreement.

## 6. Service-Level Agreements

Unless otherwise indicated, to ensure ICANN is able to meet all published timelines in the Applicant Guidebook, Panel firm will comply with the following service level metrics:

- The initial set of Panellists for round one must successfully complete the gTLD Training Program
- Any subsequent Panellist joining at a later date must successfully complete the gTLD training program prior to commencing evaluation analysis
- A Conflict of Interest report (format and detail as determined by ICANN and agreed by Panel Firm) must be completed and submitted to ICANN within four weeks after the close of the Application Window, which is expected to be 12 April 2012
- Community Priority Panel -final evaluation results for an application will be provided to ICANN within 15 business days from being assigned. Note: time extensions as agreed will be allowed to address permitted exceptions such as clarifications by ICANN or from the Applicant.
- Non-Responsive Information Redacted; Relates to Other Scope of Work Not Related to Community Priority Evaluation

# 7. gTLD Program Contingencies

In addition to the termination provisions set forth in the Master Agreement, ICANN reserves the right, without prejudice to Panel Firm's rights in respect of fees and costs, to notify the Panel Firm that evaluation services under this SOW will be suspended or terminated (as the case may be) where ICANN determines that the New gTLD Program is being suspended or terminated due to external contingencies impacting the continuation of the New gTLD Program. This includes, but is not limited to, litigation initiated by a governmental authority or regulatory agency, a determination or directive from a court, governmental authority or regulatory agency with competent jurisdiction, or a threat to the security or stability of the Internet or the Domain Name System (DNS).

As noted in the Applicant Guidebook, if a significant number of applications are received beyond stated processing capacity, ICANN will invoke a batching process. Under these circumstances the processes and timelines outlined in this SOW (along, potentially, with the fees) will be impacted. ICANN will work with Panel Firm to determine the impact and agree upon a mutually acceptable approach.

In the event that the TLD Application System is or becomes unavailable for an unscheduled or extended period (including due to unauthorized security intrusions, hacking or denial of service attacks), ICANN will invoke its processing contingency plan and work with panels to receive evaluation results via an alternate, secure mechanism. Under these circumstances the processes and timelines outlined in this SOW may be impacted.

# 8. gTLD Program Quality Control (QC)

Panel Firm will reasonably co-operate and provide reasonably requested documentation to ICANN and its appointed independent Quality Control service provider for the purposes of helping it to verify that Panel Firm's evaluation services have been and are performed in accordance with QC Guidelines. ICANN agrees that its appointed independent Quality Control service provider will be bound by at least the same confidentiality undertakings as Panel Firm.

Reasonable written notice will be given to Panel Firm prior to any QC request.

The detailed activities to provide support to on-going gTLD evaluation process Quality Control requirements include the following:

- 1. For each completed application review, Panel Firm will complete an ICANN provided Application Evaluation Process Log (AEP Log) to confirm that all activities in the evaluation process have been properly completed. ICANN will agree upon the contents of the AEP Log with Panel Firm prior to commencement of evaluations.
- 2. For each application selected for procedural completeness review, the Panel Firm will provide evidence that all steps described above in "Panel Evaluation Approach and Activities" have been completed.
- 3. Access to working papers as required verifying Panel Firm's compliance.

Panellists and managers shall be available to participate in a resolution process in the event a discrepancy is found during QC. The above tasks are subject to change. Notification of any change will be communicated by ICANN and agreed to with Panel Firm.

# 9. Advisories and ICANN policies

### (A) Security

Panel Firm will access ICANN's TLD Application System ("**TAS**") from a secure device (to an agreed level of security), and take reasonable security precautions within Panel Firm's networks and devices that are used to connect to TAS.

Panel Firm will either comply with reasonable written data security requirements that ICANN may provide from time to time in connection with performing the evaluation services or provide an explanation of why it is unable or unwilling to do so.

To the extent compliance with data security requirements results in a material change to the scope of services, schedule and/or fees/expenses for such services, ICANN will work with the Panel Firm to discuss the impact and agree a revision of costs and time schedules to reflect such circumstances, and formalise such changes via a Change Request

### (B) Retention Requirements

All source documents created by Panel Firm or a Panellist in connection with any evaluation services (including Panel Firm and Panellist working papers and notes) must be retained for a minimum of 5 years from the completion of application reviews for the opening round. Panel Firm will provide copies of application evaluation working paper documentation to ICANN if requested.

### (C) Advisories and Compliance

To the extent ICANN publishes or updates reasonable advisories and/or policies and notifies such advisories/policies/updates from time to time to evaluation panellists and the Panel Firm in relation to the performance of Evaluation Services, the Panel Firm will either comply with such advisories and/or policies or provide an explanation of why it is unable or unwilling so to do. Panel firm acknowledges that non-compliance with updates to reasonable advisories and/or policies may impact the allocation of applications for evaluation.

To the extent compliance with any new advisory or ICANN policy results in a material change to the scope of services, schedule and/or fees/expenses for such services, ICANN will work with the Panel Firm to discuss the impact and agree a revision of costs and time schedules to reflect such circumstances, and formalise such changes via a Change Request.

# 10. Terms and Conditions

This SOW is governed by the terms and conditions of the Master Agreement which are incorporated by reference.

The following provisions are agreed to be supplemental to the terms and conditions of the Master Agreement (**"Supplemental SOW Terms**"). To the extent of any inconsistency between the Supplemental SOW Terms and the Master Agreement, the Supplemental SOW Terms will prevail.

(a) Fees

In the event that Panel Firm evaluation services under this SOW are suspended or terminated by ICANN for any reason other than for breach by Panel Firm of the SOW or Master Agreement terms, Panel Firm will be entitled to full payment for services performed under this SOW up to the time of notification of suspension or termination of services.

(b) Panel Firm's role and use of the Panel Firm's name

The parties acknowledge and agree the following in relation to Panel Firm's role under this SOW:-

(i) the Panel Firm acts as a service provider to ICANN, assessing applications and recommending an outcome, as well as to provide (as applicable) a written explanation setting out its rationale;

(ii) ICANN will be free in its complete discretion to decide whether to follow Panel Firm's determination and to issue a decision on that basis or not;

(iii) ICANN will be solely responsible to applicants and other interested parties for the decisions it decides to issue and the Panel Firm shall have no responsibility nor liability to ICANN for any decision issued by ICANN except to the extent the Panel Firm's evaluation and recommendation of a relevant application constitutes wilful misconduct or is fraudulent, negligent or in breach of any of the Panel Firm obligations under this SOW;

(iv) each decision and all associated materials must be issued by ICANN in its own name only, without any reference to the Panel Firm unless agreed in writing in advance;

(v) ICANN will make no use of the Panel Firm's name, brand or logo without its prior approval in writing, and where so approved, ICANN shall refer to EIU as an "Appointed Evaluation Panel Firm"; and

(vi) ICANN will not identify Panel Firm evaluation services with any individual or specific applicants, applications or results of the evaluation except in accordance with this SOW and the Master Agreement.

(vii) ICANN shall procure that each applicant agrees in advance that it will accept ICANN's final decision and waives any rights it may have to take any action against ICANN and its service providers (including, for the avoidance of any doubt, the Panel Firm).

# 12. Change Control

(a) A "Change Request" is a request to amend this SOW or any document attached to it or referred to in this SOW. Either party may initiate a Change Request in writing. A Change Request will document details of the impact that the proposed change will have on any of the terms of this SOW and include, if relevant, any additional costs or timing changes.

(b) On receipt of a Change Request either party will use reasonable commercial efforts to respond within 5 business days (or other agreed extended period) of receipt as to their acceptance or otherwise of the Change Request.

(c) A Change Request shall become a "SOW Amendment" when the Change Request is agreed and signed by authorized representatives of both parties. An agreed SOW Amendment will be incorporated into this SOW and will amend this SOW as documented and agreed. The reasonable costs of implementing a SOW Amendment and any

amendments to the Professional Fees (if any) will be borne as set out in the SOW Amendment.

(d) If either party is unwilling to accept a Change Request suggested by the other (or any term of any Change Request) then this SOW will continue unchanged.

# Annex 19

### New gTLD Program Consulting Agreement

This Consulting Master Services Agreement (together with the Exhibits and Attachments hereto, this "Agreement") is effective as of July 26, 2011 (the "Effective Date"), by and between the Internet Corporation for Assigned Names and Numbers ("ICANN"), a California nonprofit public benefit corporation, with its principal offices located at 4676 Admiralty Way, Suite 330, Marina del Rey, CA, USA 90292 and The Economist Intelligence Unit, NA, Incorporated, with its principal offices located at Contact Information Redacted ', hereinafter referred to as "Contractor".

WHEREAS, Contractor and ICANN desire to enter into an agreement for the performance by Contractor of certain professional consulting services in connection with activities being conducted by ICANN.

NOW THEREFORE, in consideration of the foregoing, the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. <u>SERVICES</u>: Contractor shall provide to ICANN such professional consulting services as are set forth in statements of work (each a "Statement of Work") signed by and in a form acceptable to both parties, which shall set forth the manner of the work which will be provided to ICANN pursuant to this Agreement (the "Services") and the products and materials to be produced by Contractor pursuant to the Services (the "Products"). Any Services provided hereunder shall be rendered by Contractor in a manner consistent with industry standards, and shall be provided in accordance with all applicable laws. Contractor's Services shall not be exclusive to ICANN, provided that during the term of Contractor's engagement hereunder, Contractor will not render services that prevent, interfere or conflict with, or delay the prompt performance of the Services.

2. <u>TERM</u>: Contractor shall render the Services on the date or dates set forth on any Statements of Work entered into hereunder.

3. <u>COMPENSATION</u>: Subject to all the provisions of this Agreement, including, but not limited to, the "Supplemental Terms" (attached hereto as Exhibit A) and any and all Statements of Work, ICANN agrees to pay Contractor as full and complete consideration for Contractor's services hereunder, and Contractor agrees to accept, the sum as set out in the applicable Statement of Work, payable in US Dollars for the Services, which shall be paid in accordance with the payment schedule set forth in such Statement of Work.

4. <u>RIGHTS</u>:

(a) In consideration of the amounts payable by ICANN pursuant to Section 3, and subject to Section 4(b), Contractor assigns to ICANN exclusive ownership rights, in perpetuity of all copyright in and to the Products.

(b) Notwithstanding any provision of this Agreement, any and all rights (including without limitation copyright, trademarks and rights in data) in and to any content, data, brands and materials included in the Products that are in existence prior to the commencement of the Services to be provided under any and all Statements of Work (the "Pre-Existing Materials") shall not be transferred to ICANN and shall remain the exclusive property of Contractor or its licensors. Contractor grants to ICANN a non-exclusive, perpetual, royalty free license (including the right to sublicense to other parties) to use, reproduce, modify and distribute any Pre-Existing Materials on condition that: (i) such Pre-Existing Materials are used as part of the Products they are provided within and only as required in order to use the Products; and (ii) no modification shall be made that misrepresents or distorts the content or meaning of such Pre-Existing Materials.

(c) The transfer in Section 4(a) shall, subject to Section 4(b), include the right to apply for any and all patents arising from the Products and to register any copyright subsisting therein (collectively, the "Legal Rights")

(d) Save as set out in any applicable Statement of Work, Contractor will not be entitled to any royalty, commission or other payment with respect to the Products or Legal Rights in addition to the fees payable for the services to be provided under such Statement of Work.

(e) Contractor warrants that all Products will be Contractor's original work and do not infringe any copyrights, trade secrets, trademarks, patents or other proprietary rights of any third party.

5. INDEPENDENT CONTRACTOR STATUS: Contractor acknowledges and agrees that Contractor is an Independent Contractor and that Contractor's employees or agents, if any, are not employees or agents of ICANN for any purpose, including but not limited to national or local withholding or employer taxation obligations. Contractor agrees to indemnify and hold ICANN harmless (including attorney's fees and costs incurred by ICANN) should Contractor fail to meet Contractor's obligations with respect to its employees with regard to the payment or withholding of social security and other taxes, federal and state (or other such political or governmental subdivision) income taxes, unemployment insurance, and similar items should ICANN be held liable or responsible therefore. Contractor retains the sole right to control or direct the manner in which the Services are to be performed. Without limiting the foregoing, ICANN retains the right to inspect, to stop work, to prescribe alterations, and generally supervise Contractor's work to insure its conformity with the applicable Statement of Work. Contractor acknowledges that Contractor has no authority for or on behalf of ICANN to make, enter into or amend any contracts or agreements or to take any action which would impose liability on ICANN, without the express written consent of an authorized officer of ICANN. Contractor represents to ICANN that Contractor is engaged in an independent calling and will comply with all laws regarding business permits and licenses that may be required to carry out Contractor's obligations under this Agreement.

7. <u>INTERPRETATION</u>: In the event of a conflict between: (i) this Agreement; and (ii) any Statement(s) of Work, the terms of the applicable Statement of Work shall prevail.

# EXHIBIT A SUPPLEMENTAL TERMS

1. <u>RIGHTS OBLIGATIONS</u>: Except as set forth in the applicable Statement of Work, Contractor agrees that ICANN shall have the exclusive right, but not the obligation, to register copyright and file applications for patents throughout the world to protect ICANN's Legal Rights in and to the Products and that Contractor shall, upon the request of ICANN, perform (at no cost to Contractor) such legal acts and execute and deliver to ICANN, any such documents, applications and assignments reasonably requested by ICANN to register ICANN's Legal Rights in and to the Products.

If an event of force majeure continues for eight (8) consecutive weeks, ICANN shall have the right to terminate this Agreement.

3. <u>WARRANTIES</u>: Contractor represents and warrants to ICANN as follows:

(a) Contractor is fully authorized to enter into, and perform its obligations under this Agreement. This Agreement creates lawful, valid, and binding obligations, enforceable against Contractor in accordance with its terms.

(b) Contractor has the right to grant all rights granted herein, including but not limited to all necessary literary, artistic, musical and/or intellectual property rights, and is free to enter into and fully perform this Agreement.

(c) The exercise of rights granted herein, the performance of the Services and the delivery of the Products will not infringe on any of the following rights of any third party: copyright, trademark, or other intellectual property rights.

(d) Contractor has not entered and shall not enter into any arrangement or agreement that will interfere or conflict with the rights granted to ICANN hereunder.

"Personal Information" means personally identifiable information relating to such party's employees, consumers and potential consumers. Each party will notify

the other party immediately upon discovery of any lost or altered Confidential Information.

(b) Information will not be considered Confidential Information to the extent, but only to the extent, that such information: (i) is already known to the receiving party free of any restriction at the time it is obtained from the other party; (ii) is subsequently learned from an independent third party free of any restriction and without breach of this Agreement; (iii) becomes publicly available through no wrongful act of either party; (iv) is independently developed by one party without reference to any Confidential Information of the other; or (v) is required to be disclosed by law, regulation, court order or subpoena, provided that the disclosing party will exercise reasonable efforts to notify the other party prior to disclosure. The parties agree also that the existence and terms of this Agreement are confidential and shall not be disclosed by either party without prior consent in writing by the other party.

6. <u>SURVIVING OBLIGATIONS</u>: The parties' representations, warranties, and indemnity obligations shall remain in effect following the termination or expiration of this Agreement.

7. <u>ASSIGNMENT</u>: Neither party may without prior consent in writing assign this Agreement or any of its rights or obligations hereunder.

8. <u>REMEDIES</u>: In recognition of the relative risks and benefits of this Agreement to both ICANN and Contractor, ICANN agrees that, to the fullest extent permitted by law, except for claims for indemnification under Section 4, any liability of Contractor (including its consultants, employees, and agents) for damages to ICANN shall be limited to an amount equal to the total amount paid to Contractor pursuant to this Agreement. EXCEPT FOR CLAIMS FOR INDEMNIFICATION UNDER SECTION 4, IN NO EVENT SHALL ANY PARTY TO THIS AGREEMENT OR ANY OF ITS DIRECTORS, OFFICERS, EMPLOYEES, AGENTS OR SUBCONTRACTORS BE LIABLE TO THE OTHER PARTY UNDER ANY THEORY OF TORT, CONTRACT, STRICT LIABILITY OR OTHER LEGAL OR EQUITABLE THEORY FOR LOST PROFITS, EXEMPLARY, PUNITIVE, SPECIAL, INCIDENTAL, INDIRECT, CONSEQUENTIAL DAMAGES OR THE LIKE, EACH OF WHICH IS HEREBY EXCLUDED BY AGREEMENT OF THE PARTIES REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE OR WHETHER EITHER PARTY OR ANY ENTITY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

### 9. <u>TERMINATION</u>:

(a) Each Party shall have the right to terminate this Agreement or any Statement of Work for convenience. Termination under this provision will be effective thirty (30) days after written notice by one party to the other; provided, that ICANN will be required to make payment for all work in progress and Products actually delivered under any active Statement of Work in the event of a termination of this Agreement or the applicable Statement of Work pursuant to this Section 9(a); and, provided, further, that, without prejudice to the generality of Section 7 of the Agreement to which these Supplemental Terms are attached, the termination provisions of each Statement of Work, if any, will supersede this Section 9(a).

(b) Each party shall have the right to terminate this Agreement if such party has a good faith belief, based on the facts then available, that the other party has engaged in any of the following conduct: fraud, misappropriation or embezzlement of funds, or gross misconduct. Termination under this provision shall be effective immediately upon receipt of notice by the relevant party.

(c) <u>Other Provisions</u>: Either party shall have the right to terminate this Agreement pursuant to other provisions contained throughout this Agreement, including but not limited to Section 2 (if ICANN) of these Supplemental Terms. Nothing contained within this provision shall negate or override its rights to terminate contained within other provisions herein, and it may elect at its option the most favorable applicable termination provision or provisions contained within this Agreement.

#### 10. <u>DEFAULT</u>:

(a) If either party fails, refuses or neglects to perform any of its material obligations hereunder, for any reason other than incapacity, such party shall be in "default" of this Agreement. If either party refuses or states that it will refuse to comply with any of its material obligations hereunder, such refusal or statement may be treated by the other party as an immediate default, regardless of whether the time for performance of such obligation or obligations has arrived. Further, a party may, at any time, make a written request for the other party to confirm in writing its intentions and willingness to comply with its obligations hereunder, either generally or with respect to any particular matter. If, within five (5) days from delivery of such request at the address for notices set forth herein (exclusive of Saturdays, Sundays and federal holidays), the recipient of the request fails to deliver the requested information to the other party, such failure may be treated by such other party as an immediate default.

(b) Either party may suspend this Agreement with respect to performance of its obligations while any default of the other party continues.

11. <u>CURING PROVISION</u>: Neither party shall bring or make any claim that the other party has breached any of the provisions hereunder unless such party has first made a written demand to cure such failure, and the other party has not satisfied the obligations within ten (10) business days of receipt of such demand. The written demand shall specify the provision claimed to be breached, the date such obligation or performance was to have been satisfied and any other identifying specifics.

#### 12. MISCELLANEOUS:

(a) <u>No Implied Waiver</u>: No failure on the part of ICANN or Contractor to exercise and no delay in exercising, and no course of dealing with respect to any right, power or privilege under this Agreement shall operate as a wavier thereof, nor shall any single or partial exercise of any right, power or privilege under this Agreement preclude the exercise of any other right, power or privilege.

(b) <u>Counterparts</u>: This Agreement may be executed in two or more counterparts (and by different parties on separate counterparts) each of which shall be an original, but all of which together shall constitute one and the same instrument.

(c) <u>No Violation of Law</u>: If any provision of this Agreement shall be deemed invalid or unenforceable as written, it shall be construed, to the greatest extent possible, in a manner which shall render it valid and enforceable, and any limitations on the scope or duration of any such provision necessary to make it valid and enforceable shall be deemed to a part hereof; no invalidity or unenforceability shall affect any other portion of this Agreement.

(d) <u>Choice of Law and Submission to Jurisdiction</u>: This Agreement shall be governed by applicable U.S. federal law and by the laws of the State of California applicable to contracts entered into and to be wholly performed within the State of California. Contractor and ICANN hereby submit and consent to the jurisdiction of the State and Federal Courts located in Los Angeles County, California, USA.

(e) <u>Paragraph Headings</u>: Paragraph headings contained in this Agreement are for convenience and shall not be considered for any purpose in construing this Agreement.

13. <u>NOTICES</u>: Any notice given under this Agreement will be in writing and will be effective (a) upon receipt if (i) delivered by hand or (ii) sent via overnight mail by a nationally recognized express delivery service; or (b) three (3) days after deposit in the U.S. mail, postage prepaid, certified mail return receipt requested, when addressed as follows:

# **Overview of Findings in relation to the .RADIO Application by the EBU**

#### 1. Introduction

In addition to the other arguments we have formulated in the context of the Cooperative Engagement Process, please find below a number of factual elements which, in our view, prove that the EIU failed to conduct due diligence in the context of the Community Priority Evaluation for the application for the .RADIO gTLD, submitted by the European Broadcasting Union (EBU).

#### a. About the EBU

The European Broadcasting Union is a not-for-profit organization that has been established by an alliance of mostly public service media entities / broadcasters. According to the EBU's website, the EBU has 73 active members in 56 countries, and 34 associate members in 20 countries.<sup>1 2</sup>

As is made clear in the EBU's full name, that they are (i) a European-centric entity, and (ii) an association that is focused on *broadcasting*. Broadcasting is defined as *"the distribution of audio and/or video content to a dispersed audience via any electronic mass communications medium, but typically one using the electromagnetic spectrum (radio waves), in a one-to-many model"*. <sup>3</sup>

#### b. The EIU made process errors

The fact that the community priority evaluation panel was required to conduct independent verification of the information provided by applicant of community-based gTLDs has been confirmed as such by ICANN.

On the basis of the elements set out below – which are just a limited number of examples – it is clear that the EIU has not performed the required due diligence by conducting independent verification of information, rather it merely accepted the information provided by the EBU in the context of its application. In the context of the Documentary Information Disclosure Request submitted by the parties having initiated this Cooperative Engagement Process, ICANN denied access to such information on which the EIU has relied, citing non-disclosure obligations. The lack of information provided by ICANN can and does create an

environment where the community can only make adverse inferences as to the absence of EUI diligence.

#### c. Inconsistencies across various determinations

We have pointed out in our earlier submissions that the EIU clearly treated similar applications in a dissimilar manner, which clearly confirms our previous statements that the EIU was not consistent in its approach.

For instance, the EIU has used the Oxford English Dictionary as a yardstick in various determinations.<sup>4</sup> The EIU did, however, not refer to the Oxford English Dictionary in the .RADIO determination.

If it would have done so, it would have been clear – as will be stated below – that the term "radio" has no unique meaning, and that the "community" as concocted by the EBU implies at maximum a "commonality of interests", rather than "of cohesion".

According to the Oxford English Dictionary, the term "radio" is defined as:

- 1. The transmission and reception of electromagnetic waves of radio frequency, especially those carrying sound messages;
- 2. The activity or industry of broadcasting sound programmes to the public;
- 3. An apparatus for receiving radio programmes.<sup>5</sup>

Thus, if the EIU would have used the same yardstick – the Oxford English Dictionary – in connection with the .RADIO application, it is clear that the outcome would have been entirely different.

### d. Conflict of Interest

The EBU preexists the of the GAC in 1999 and, over the past 10+ years, the EBU has shown very little interest in Internet Governance with regards to the GAC, until submitting their application for the .RADIO gTLD in 2012.

We furthermore point out the fact that the EBU has been accepted to the ICANN Governmental Advisory Committee. It has requested Observer status with the GAC after having submitted its application for the .RADIO gTLD.<sup>6</sup>

While the EBU may not have any voting rights, it appears they have been

provided full access to influence GAC committees and its working groups, as has been stressed in various public comments in relation to the EBU's application for the .RADIO gTLD.

No other GAC Members or Observers are a direct applicant for a generic Industry specific string like .RADIO that is contested. This will give the EBU an undue advantage, "where it carries commercial activities" as noted in their other application, as well as against all other contenders for the .RADIO string.

All three parties that have initiated this Cooperative Engagement Process have expressed this concern before the publication of the EIU's determination in relation to the EBU's application for the .RADIO gTLD. The EIU, however, failed to make a single reference to this justified community remark in its determination.

#### 2. Failure to Verify Application Information

#### a. Community Establishment – Delineation

We have previously reported various flaws and contradictions in the EBU's "community definition" and the evaluation thereof by the EIU. Generally speaking, the EBU's community definition is unclear on whether they are focusing on the "radio community" as described by them, or to the "radio industry":

- According to the EBU's application, "the radio industry is composed of a huge number of very diverse radio broadcasters". The applicant distinguishes the "licensed radio broadcasters" as a separate category and make them part of the "radio community". This implies that "unlicensed radio broadcasters" are not part of their community.
- 2) The application refers to "radio professionals", notwithstanding the fact that they are not "radio broadcasters" as set out earlier. Furthermore, considering the fact that there are no license requirements for radio broadcasters, they cannot form part of the community as set out above;
- 3) The application refers to "webcasting" and "streaming" and "internet radios" as not being broadcasters in the "traditional sense", which excludes these from the "radio industry" as referred to in 1) above;
- 4) The concept introduced by the EBU in its application, which contains "companies providing specific services or products to the radio industry" is very vague, and - since they are not "diverse radio broadcasters", they are not part of the radio industry concocted by the applicant;
- 5) Considering the fact that the applicant uses the "radio industry" as a benchmark, with the express reference to "radio broadcasters", it is contradictory to continue to expressly assert that parties who are not part of this industry are also part of the "radio community".

6) the European <u>Broadcasting</u> Union (emphasis added) is a not-for-profit organization that has been established by an alliance of public service media entities. To a certain extent, these entities are indeed radiating electromagnetic energy through space when they are broadcasting their radio or television programs, but this does not entitle the organization to represent the global "radio community" or "radio industry" as a whole.

Indeed, in addition to the active members and associate members of the EBU, there are hundreds of thousands of other organizations that have no affinity at all with the EBU, but are also active in the field of "radio", such as, but not limited to:

- unlicensed radio broadcasters;
- amateur radio;
- non-public media organizations, such as private broadcasters (who are not a member of the EBU);
- manufacturers of equipment and devices for transmitting and receiving radio signals;
- etc.

The parties having initiated this Cooperative Engagement Process are therefore of the opinion that the EBU does not have standing in relation to and is not entitled to represent the vast majority of private individuals, organizations and companies who are active in the field of radio.

#### b. Nexus and Uniqueness

As stated in our Reconsideration Request, the concept "radio" is much broader than the concept put forward by the EBU, which has been accepted by the EIU in the Determination.

A simple reference to external sources, such as Wikipedia, proves that "radio" has a much broader reach than the narrow definition provided by the EBU:

#### i. https://en.wikipedia.org/wiki/Radio

"Radio is the radiation (wireless transmission) of electromagnetic energy through space. The biggest use of radio waves is to carry information, such as sound, by systematically changing (modulating) some property of the radiated waves, such as their amplitude, frequency, phase, or pulse width. When radio waves strike an electrical conductor, the oscillating fields induce an alternating current in the conductor. The information in the waves can be extracted and transformed back into its original form."

Considering the fact that the EBU is only limiting its focus to a limited number of actors within the field of radio broadcasting, there is insufficient nexus with the

"radio" concept as a whole, which could have been easily independently verified by the EIU.

ii. https://en.wikipedia.org/wiki/Radio\_(disambiguation)

This page provides for an overview of all the meanings of the word "radio", which is obviously much broader than the targeted "community" purported by the EBU in relation to its application for the .RADIO gTLD.

Considering the fact that Wikipedia is widely consulted and available, the EIU failed to independently verify the information provided by the EBU.

iii. https://en.wikipedia.org/wiki/Special:PrefixIndex/Radio

On this page, various terms have been included that contain the word "radio" as a prefix. It is obvious that the EBU has no affinity, let alone is entitled to represent actors in relation to the following industries:

- Radio-activity;
- Radio-controlled (model) cars, aircrafts, hovercrafts, boats, ...;
- Radio-Scientific Union;
- Radio-frequency induction;
- Radio-frequency identification;
- Radio-frequency heating;
- Etc.

First and foremost, Wikipedia defines the word "radio" as "a medium of wireless communication".

The EBU has no direct affinity with the medium in the general sense of the word. The EBU is an alliance of public service media entities ("active" members and "associate" members). According to the EBU's website: "The European Broadcasting Union is devoted to making public service media indispensable. We support and strengthen public service media, provide first-class media services and offer our Members a centre for learning and sharing."

The noun "radio" refers to two things:

- 1) the service provided by radio stations: broadcasting sound that can be picked up by a receiver; and
- 2) the device that is capable of receiving radio signals.

It is clear that the application only focuses on a specific part of the service providers referred to under 1), and extends beyond that point to include persons or entities that are not involved in broadcasting, such as "streaming" and "companies providing specific services or products to the radio industry". Furthermore, the application does not refer to manufacturers of radios that are purchased and used by consumers (which is one of the two common manifestations of the word "radio").

In other words, the EIU erred in deciding that the word "RADIO" is unique; this information could have been easily verified by the EIU by using the above sources or, moreover, the information of the organization of which it forms part, the Economist (<u>http://www.economist.com/topics/radio</u>).

#### c. Community Support

The European Broadcasting Union represents a limited number of broadcasting organizations. The EBU does not represent companies, organizations and individuals who are active in the field of webcasting, Internet radio, the streaming media community or, as the EBU indicated itself in its own description of the "community" they purport to represent: the vast majority of the "radio industry".

This information relied on by the EIU is incorrect and could have been easily and independently verified by the EIU, using public sources such as the ones cited above, had they conducted the requisite due diligence.

#### d. Community Objection

The EBU's application for the .RADIO gTLD has received substantial opposition from various sources, including but not limited to:

- the Webcaster Alliance, Inc.;
- the International Radio Emergency Support Coalition (IRESC);<sup>7</sup>
- the parties having initiated this Cooperative Engagement Process.

This information has been made available through the channels provided by ICANN to this end.

#### 3. Next Steps

We understand that the Cooperative Engagement Process intends to provide the opportunity to the parties to come to an amicable solution, in view of avoiding a possible Independent Review.

Initially, we have requested ICANN to review and overturn its decision in relation to awarding community-based status to the EBU's application for the .RADIO gTLD.

By way of this additional submission, we would like to propose to ICANN to: organize a conference call with ICANN in order to see which other remedies would be available. If and where relevant, the parties having initiated this process, would be open to organize a conference call with the EIU and/or the EBU in order to discuss a possible way forward.

The contents of this submission is to be considered confidential and are in any case without prejudice to any additional or revised arguments or elements to be added if an Independent Review would be initiated.

#### Initiation of Cooperative Engagement Process .RADIO Community Priority Evaluation

I am contacting you in my capacity of designated representative of Afilias Limited, BRS Media, Inc. and Tin Dale, LLC (collectively: "Requesters").

Requesters hereby initiate the Cooperative Engagement Process in relation to:

- 1) the Determination of the Board Governance Committee ("BGC") regarding Reconsideration Request 14-41 of 20 January 2015, which has been published at (https://www.icann.org/resources/pages/14-41-2014-09-29-en);
- 2) ICANN's Response to Requesters' Request for Information under ICANN's Documentary Information Disclosure Policy, which has been published at (<u>https://www.icann.org/resources/pages/20140926-01-2014-10-27-en</u>) and which has been incorporated by reference in Requesters' Reconsideration Request referred to below;
- 3) the determination by the Community Priority Evaluation Panel that the application for the .RADIO gTLD submitted by the European Broadcasting Union has prevailed in Community Priority Evaluation, and this according to the Community Priority Evaluation Report that has been published at (<u>https://www.icann.org/sites/default/files/tlds/radio/radio-cpe-1-1083-39123-en.pdf</u>), which has been accepted by ICANN (the "CPE Report").

Requesters are of the opinion that:

1) ICANN has violated its Bylaws, and more in particular its obligations regarding accountability and transparency set out therein, by not disclosing the information requested in Requesters' Request for Information referred to above. By way of the Request for Information, Requesters attempted to obtain further insights into the processes and procedures utilized by the CPE Panel, in order to verify whether these have been applied in line with the criteria set out in the Applicant Guidebook. ICANN refused to provide such information, referring to the fact that the information requested was either not in ICANN's possession, or

that such documents were not appropriate for public disclosure, because they were subject to certain DIDP Nondisclosure Conditions;

By not providing more precise information, ICANN deliberately and intentionally blocked Requesters' options for appropriately invoking ICANN's transparency and accountability obligations set out in ICANN's Bylaws, and has therefore not ensured the necessary integrity and fairness towards other applicants who are in contention for the same .RADIO gTLD, including in particular Requesters;

- 2) In Requesters' view, the CPE Report was unclear and imprecise in various ways (use of vague language, providing a limited number of examples, brief arguments and assumptions, ...) on how the scoring mechanisms provided for in the Applicant Guidebook had been applied by the CPE Panel.
- 3) As Requesters have pointed out in their initial Reconsideration Request, the CPE Panel has, in drawing up the CPE Report and the decisions taken by ICANN as a result thereof (including the Determination by the BGC), not applied documented policies neutrally and objectively, as required by ICANN's Bylaws.

Indeed, when comparing the CPE Report for the .RADIO gTLD with other reports drawn up by the Economist Intelligence Unit, it is obvious that different standards have been used by the different CPE Panels. These proven inconsistencies underline the fact that the CPE Panel in this case has not applied ICANN policies neutrally, objectively, and in a transparent manner.

4) ICANN has violated its By-Laws by determining that Requesters are not entitled to reconsideration, considering that – according to ICANN – they mainly *"disagree with the CPE Panel's determination and scoring of the Application, and challenge the substantive merits of the CPE Panel's Report"*, notwithstanding the fact that ICANN's own Top-Level Domain Application Terms and Conditions expressly authorize applicants to utilize ICANN's Bylaws processes for purposes of *"challenging any final decision made by ICANN"* with respect to an application.

Furthermore, since ICANN deliberately refused to disclose the information and processes utilized and considered by the CPE Panel, ICANN has made it impossible for Requesters to adequately challenge the CPE Report, including the processes, procedures, standards and criteria used by the EIU in drawing up such CPE Report. Indeed, the BGC's Determination regarding Requesters' Reconsideration Request undisputedly proves that such Request was dismissed on the basis of a lack of insight into information processes, procedures and criteria used by the CPE Panel, which ICANN refused to disclose to Requesters in the first place ...

5) In its Determination, the BGC refers to the fact that the CPE Panel has published "supplementary guidelines ("CPE Guidelines") that provide more detailed scoring guidance, including scoring rubrics, definitions of key terms, and specific questions to be scored". (BGC Determination, page 6). In the Determination, the BGC refers on various occasions that the CPE Panel has "applied the Guidebook scoring <u>guidelines</u>" apparently as opposed to the "<u>standards governing CPE</u>" that are "set forth in Section 4.2 of the Guidebook" (BGC Determination, pages 6, 10, 12, 14, 15 and 18) (emphasis added).

Requesters are of the opinion that the CPE Panel did not have the authority under ICANN Policy and in particular under the Applicant Guidebook to publish such additional "CPE Guidelines". Furthermore, the rules and processes for developing "ICANN Policy" have not been followed in defining these "CPE Guidelines".

For these two reasons alone, the CPE Guidelines cannot be considered "ICANN Policy", and should therefore have been disregarded by the EIU in developing the CPE Report and by ICANN in making the Determinations.

In Requesters' view, the only reference point to be used by the CPE Panel is the Applicant Guidebook.

In this respect, Requesters point out to the fact that these CPE Guidelines have been published about one year and a half after the closing of the application window in April / May of 2012. Reference is made to <a href="http://newgtlds.icann.org/en/applicants/cpe">http://newgtlds.icann.org/en/applicants/cpe</a> - CPE Resources.

In conclusion: by expressly referring to the fact that the CPE Panel has utilized its own CPE Guidelines, which do not form part of the Applicant Guidebook, nor are to be considered ICANN Policy, the CPE Panel has not applied ICANN's policies and procedures. Since the BGC has expressly confirmed in the Determination that the CPE Panel has applied "the (Applicant) Guidebook scoring guidelines and the CPE Guidelines", the BGC has in fact acknowledged that guidelines other than what has to be considered ICANN Policy have been followed ...

6) Furthermore, as stated above, ICANN refused to provide information on how these CPE Guidelines have been utilized by the EIU in developing the CPE Report which formed the basis of ICANN's Determination to acknowledge the community-based status of the European Broadcasting Union's application for the .RADIO gTLD.

Since ICANN allowed the CPE Panel to publish additional CPE Guidelines outside of the context of the Applicant Guidebook, without following ICANN's policy development processes, which in itself is a violation of ICANN's policies and processes, the result of decisions and determinations that are based on such "CPE Guidelines" cannot but considered contrary to ICANN policy and processes.

7) The contents of the Determination of the BGC, combined with ICANN's reluctance to provide an appropriate Response to the Request for Information clearly show that ICANN is refusing to be held accountable for Board or Staff actions or inactions, and are clear examples of obscure decision making.

Therefore, Requesters are of the opinion that ICANN has not applied documented policies neutrally and objectively, with integrity and fairness when making decisions:

- based on the CPE Report;
- in developing its Response to Requesters' Request for Information under the DIDP; nor
- in the context of the Determination of the BGC



as required by Article 4 of ICANN's Articles of Incorporation, as well as Article I, Section 2 and Article III of ICANN's Bylaws.

For these reasons, and other reasons to be added in the context hereof, Requesters hereby initiate the Cooperative Engagement Process in relation to the Determination referred to above.

Composition of the review team will be agreed jointly by the Chair of the GAC (Governmental Advisory Committee) (Governmental Advisory Committee) (in consultation with GAC (Governmental Advisory Committee) (Governmental Advisory Committee) members) and the CEO of ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers). Resulting recommendations of

the reviews will be provided to the Board and posted for public comment. The Board will take action within six months of receipt of the recommendations.

<u>9.3 Promoting competition, consumer trust, and consumer choice</u>: ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers) will ensure that as it contemplates expanding the top-level domain space, the various issues that are involved (including competition, consumer protection, security, stability and resiliency, malicious abuse issues, sovereignty concerns, and rights protection) will be adequately addressed prior to implementation. If and when new gTLDs (whether in ASCII or other language character sets) have been in operation for one year, ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers) will organize a review that will examine the extent to which the introduction or expansion of gTLDs has

promoted competition, consumer trust and consumer choice, as well as effectiveness of (a) the application and evaluation process, and (b) safeguards put in place to mitigate issues involved in the introduction or expansion. ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers) will organize a further review of its execution of the above commitments two years after the first review, and then no less frequently than every four years. The reviews will be performed by volunteer community members and the review team will be constituted and published for public comment, and will include the following (or their designated nominees): the Chair of the GAC (Governmental Advisory Committee) (Governmental Advisory Committee), the CEO of ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers), representatives of the relevant Advisory Committees (Advisory Committees) (Advisory Committees) and Supporting Organizations (Supporting Organizations) (Supporting Organizations), and independent experts. Composition of the review team will be agreed jointly by the Chair of the GAC (Governmental Advisory Committee) (Governmental Advisory Committee) (in consultation with GAC (Governmental Advisory Committee) (Governmental Advisory Committee) members) and the CEO of ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers). Resulting recommendations of the reviews will be provided to the Board and posted for public comment. The Board will take action within six months of receipt of the recommendations.

9.3.1 ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers) additionally commits to enforcing its existing policy relating to WHOIS (WHOIS (pronounced "who is"; not an acronym)) (WHOIS (pronounced "who is"; not an acronym)), subject to applicable laws. Such existing policy requires that ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers) implement measures to maintain timely, unrestricted and public access to accurate and complete WHOIS (WHOIS (pronounced "who is"; not an acronym)) (WHOIS (pronounced "who is"; not an acronym)) information, including registrant, technical, billing, and administrative contact information. One year from the effective date of this document and then no less frequently than every three years thereafter, ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers) will organize a review of WHOIS (WHOIS (pronounced "who is"; not an acronym)) (WHOIS (pronounced "who is"; not an acronym)) policy and its implementation to assess the extent to which WHOIS (WHOIS (pronounced "who is"; not an acronym)) (WHOIS (pronounced "who is"; not an acronym)) policy is effective and its implementation meets the legitimate needs of law enforcement and promotes consumer trust. The review will be performed by volunteer community members and the review team will be constituted and published for public comment, and will include the following (or their designated nominees): the Chair of the GAC (Governmental Advisory Committee) (Governmental Advisory Committee), the CEO of ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers), representatives of the relevant Advisory Committees (Advisory Committees) (Advisory Committees) and Supporting Organizations (Supporting Organizations) (Supporting Organizations), as well as experts, and representatives of the global law enforcement community, and global privacy experts. Composition of the review team will be agreed jointly by the Chair of the GAC (Governmental Advisory Committee) (Governmental Advisory Committee) (in consultation with GAC (Governmental Advisory

Committee) (Governmental Advisory Committee) members) and the CEO of ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers). Resulting recommendations of the reviews will be provided to the Board and posted for public comment. The Board will take action within six months of receipt of the recommendations.

10. To facilitate transparency and openness in ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers)'s deliberations and operations, the terms and output of each of the reviews will be published for public comment. Each review team will consider such public comment and amend the review as it deems appropriate before it issues its final report to the Board.

11. The DOC (Department of Commerce (USA)) (Department of Commerce (USA)) enters into this Affirmation of Commitments pursuant to its authority under 15 U.S.C. 1512 and 47 U.S.C. 902. ICANN (Internet Corporation for Assigned Names and Numbers) (Internet Corporation for Assigned Names and Numbers) commits to this Affirmation according to its Articles of Incorporation and its Bylaws. This agreement will become effective October 1, 2009. The agreement is intended to be longstanding, but may be amended at any time by mutual consent of the parties. Any party may terminate this Affirmation of Commitments by providing 120 days written notice to the other party. This Affirmation contemplates no transfer of funds between the parties. In the event this Affirmation of Commitments is terminated, each party shall be solely responsible for the payment of any expenses it has incurred. All obligations of the DOC (Department of Commerce (USA)) (Department of Commerce (USA)) under this Affirmation of Commitments are subject to the availability of funds.


