- 5. On October 3, 2019, the trial court issued a "Statement of Decision on Bifurcated Trial (Phase One) on Affirmative Defense of Judicial Estoppel" ("Statement of Decision"). In the Statement of Decision, the court found in favor of ICANN and against DCA on ICANN's affirmative defense of judicial estoppel and barred DCA from bringing or maintaining its claims against ICANN alleged in the First Amended Complaint ("FAC") in this lawsuit. Because the Statement of Decision resolved all remaining causes of action in the litigation, on October 3, the trial court entered a final judgment in favor of ICANN and against DCA on all claims, permitting ICANN to recover its costs of suit, and dismissing the FAC with prejudice ("Final Judgment").
- On October 3, 2019, the Executive Officer/Clerk of the
 Los Angeles Superior Court served filed-endorsed copies of the
 Statement of Decision and the Final Judgment on all parties' counsel,

including DCA's counsel Brown, Neri, Smith & Khan, LLP, along with a Certificate of Mailing that was also filed on the trial court docket. A true and correct filed-endorsed copy of the trial court's October 3, 2019 "Final Judgment" is attached hereto as Exhibit A, and a true and correct copy of the Certificate of Mailing issued by Executive Officer/Clerk of the Los Angeles Superior Court reflecting service of the filed-endorsed copies of the Statement of Decision and the Final Judgment on all parties' counsel, including DCA's counsel Brown, Neri, Smith & Khan, LLP, is attached hereto as Exhibit B.

- 7. On October 10, 2019, ICANN served a notice of entry of judgment, per the trial court's directive in its October 3, 2019 minute order. A true and correct copy of the October 3, 2019 minute order is attached hereto as **Exhibit C**, and a true and correct copy of ICANN's notice of entry of judgment, served on October 10, 2019, is attached hereto as **Exhibit D**.
- 8. Both ICANN and Intervenor ZACR filed their memoranda of costs on October 18, 2019, which was 15 days after the date the Executive Officer/Clerk of the Los Angeles Superior Court served the filed-endorsed copy of the Final Judgment, as required by Rule of Court, rule 3.1700(a)(1).
- 9. No relevant motions were filed to support an extension of the time to appeal under California Rules of Court, rule 8.108.
- 10. On December 3, 2019, DCA filed a notice of appeal in the County of Los Angeles Superior Court.

11. On December 13, 2019, DCA filed its notice designating the record on appeal. ICANN will file its counter-designation by December 23, 2019.
