## Re: Pre-Audit Notification for 2014 Registrar Audit

Dear Registrar:

ICANN will be conducting a contractual compliance audit to assess whether registries and registrars are in compliance with their key obligations under their contracts with ICANN.

The plan is to audit all registrars and registries over a three-year period. One third (1/3) of registrars and registries will be randomly selected for the second year's audit.

If you **do not** receive a Request for Information (RFI) by Monday 14 October 2013, it will mean that your registrar has not been selected for the second year's audit and will be audited next year.

We also plan to organize two optional information outreach sessions on Thursday 17 October 2013 to those registrars and registries selected this year that may have any questions related to the Audit Program. Further information and details will be provided with the RFI on 14 October 2013 if your registrar is selected.
