Re: Pre-Audit Notification for 2015 Registrar Audit

Dear Registrar:

ICANN will be conducting a contractual compliance audit to assess whether registries and registrars are in compliance with their key obligations under their contracts with ICANN.

The plan is to audit all registrars and registries over a three-year period. One third (1/3) of registrars and registries will be randomly selected for the third year's audit.

If you do not receive a Request for Information (RFI) by Monday 20 October 2014, it will mean that your registrar has not been selected for the third year's audit.

We also plan to organize an optional information outreach session on Tuesday 21 October 2014 to those registrars and registries selected this year that may have any questions related to the Audit Program. Further information and details will be provided with the RFI on 20 October 2014 if your registrar is selected.
