  - 3. Defendants are not infants or incompetent persons.
- 4. Defendants are corporations, and are not in military service or otherwise exempted under the Soldiers' and Sailors' Civil Relief Act of 1940; and
- 5. Notice of this application for default judgment by court, as required by Federal Rule of Civil Procedure 55(b)(2), was caused to be served on Defendants, through counsel of record, on September 12, 2007 via personal service, in accordance with Local Rule 14.12.1.
- 6. Plaintiff ICANN is entitled to the following judgment against Defendants on account of the claims pleaded in the complaint:
  - Establishment of the facts pleaded against Defendants as true;
  - A determination that Defendants are in breach of the RAA;
  - A determination that ICANN rightfully terminated the RAA on account of Defendants' breaches; and
  - A determination that Defendants are restrained from engaging in any further breaches of the obligations imposed by the RAA that survive termination, such as data retention obligations and the payment of registrar fees incurred during the term of the RAA.
- 7. The amount of the judgment sought is the sum of \$122,152.35 as set forth in the attached declaration of Samantha Eisner.
