demands for registrant data since early March 2007, before either the arbitration proceeding or this litigation were instituted.

RegisterFly has now provided all of the data which ICANN has demanded and this Court has ordered be provided, although it acknowledges that there remain formatting issues with the data it has transferred, so RegisterFly is not in compliance with those terms of the preliminary injunction. However, RegisterFly continues to work with ICANN to correct these formatting issues so that the data provided is usable.

RegisterFly will provide evidence at the hearing on this Court's OSC Re: Further Contempt Sanctions of RegisterFly's efforts to comply with the orders of this Court. Given these efforts to comply, further sanctions are not appropriate or necessary.
