THAT:

The Demurrer to Plaintiff's Complaint brought by defendant Internet Corporation for Assigned Names and Numbers ("ICANN") and erroneously-named defendant Internet Assigned Numbers Authority ("IANA") came on regularly for hearing before the Court on September 20, 2006, the Honorable John L. Segal presiding. The Court, having considered the papers in support of and in opposition to the Demurrer, the pleadings on file in this matter by the parties, and the arguments of counsel at the hearing, and good cause appearing therefore, HEREBY ORDERS

The Court has no jurisdiction over the subject of the First Cause of Action because Plaintiff's Complaint fails to meet the mandatory requirements of the Foreign Sovereign Immunities Act. Specifically, the country-code Top-Level Domain for the Republic of Congo, which Plaintiff seeks to apply in satisfaction of Plaintiff's money judgment against the Congo is: (1) not property; (2) not located in the United States; and (3) not used for commercial activity therein. 28 U.S.C. § 1610(a).

Alternatively, Plaintiff's Complaint fails to state facts sufficient to maintain a creditor's suit against defendant ICANN and erroneously-named defendant IANA. Cal. Civ. Proc. Code § 708.210.

Therefore, the Demurrer to the Complaint is SUSTAINED WITHOUT LEAVE TO AMEND and the Court's earlier issuance of the Writs of Execution against ICANN and IANA are dissolved.
