Dear Zhang Jun,

Please be advised that as of 12 October 2018, Shenzhen Domainstar Technology Co., Limited's ("Shenzhen Domainstar Technology") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 12 April 2017 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 28 October 2018, 16 days from the date of this notice.

The termination is due to Shenzhen Domainstar Technology's failure to timely cure the breach by 11 October 2018 as set forth in ICANN's notice of breach of RAA dated 20 September 2018. As of 12 October 2018, the following breach remains:

1. Shenzhen Domainstar Technology's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Additionally, Shenzhen Domainstar Technology has failed to provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure (a) timely response to ICANN Contractual Compliance matters; (b) Shenzhen Domainstar Technology's contact information is up to date; and (c) timely payment of its ICANN fees.

Please see the chronology below for additional details.

Shenzhen Domainstar Technology is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 28 October 2018. Please remove all ICANN trademarks, name and logo from Shenzhen Domainstar Technology's website and business materials that have been licensed to Shenzhen Domainstar Technology under the terms of that Specification by 28 October 2018.

### Domain Name Transition Process

No domain names are currently managed by Shenzhen Domainstar Technology. Therefore, ICANN does not need to follow the [De-Accredited Registrar Transition Procedure](#) ("Procedure").

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Shenzhen Domainstar Technology has past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
